A BILL

To modify the age-60 retirement standard for certain pilots and, for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Freedom to Fly Act
- 5 of 2007".
- 6 SEC. 2. MODIFICATION OF FAA'S AGE-60 RETIREMENT
- 7 STANDARD.
- 8 (a) In General.—A pilot who has attained 60 years
- 9 of age may serve as a pilot of an aircraft operated by an

- 1 air carrier engaged in operations under part 121 of title
- 2 14, Code of Federal Regulations, until attaining 65 years
- 3 of age only if the pilot serves—
- 4 (1) as a required pilot in multi-crew aircraft op-
- 5 erations; and
- 6 (2) with another pilot serving as a required 7 pilot in such multi-crew aircraft operations who has 8 not yet attained 60 years of age.
- 9 (b) Sunset of Age-60 Retirement Rule.—
- 10 (1) IN GENERAL.—On and after the effective 11 date described in subsection (e), section 121.383(c) 12 of title 14, Code of Federal Regulations shall have 13 no further force or effect.
- 14 (2) REGULATIONS.—Not later than 30 days 15 after the effective date described in subsection (e), 16 the Secretary of Transportation shall take such ac-17 tion as may be necessary to implement paragraph
- 18 (1) and to modify the regulations relating to pilot 19 privileges by reason of age.
- 20 (c) Applicability.—The provisions of subsection (a)
- 21 shall not provide a basis for a claim of seniority under
- 22 any labor agreement in effect between a recognized bar-
- 23 gaining unit for pilots and an air carrier engaged in oper-
- 24 ations under part 121 of title 14, Code of Federal Regula-
- 25 tions, that is made by a person who was a pilot and who

- 1 attained 60 years of age before the effective date described
- 2 in subsection (e) and is seeking a position as a pilot with
- 3 such air carrier following that person's termination or ces-
- 4 sation of employment or promotion or transfer to another
- 5 position with such air carrier pursuant to section
- 6 121.383(c) of title 14, Code of Federal Regulations, as
- 7 in effect on the day before the effective date described in
- 8 subsection (e).
- 9 (d) GAO REPORT AFTER MODIFICATION OF AGE-60
- 10 RETIRMENT STANDARD.—Not later than 24 months after
- 11 the effective date described in subsection (e), the Comp-
- 12 troller General of the United States shall report to the
- 13 Committee on Commerce, Science, and Transportation of
- 14 the Senate and the Committee on Transportation and In-
- 15 frastructure of the House of Representatives concerning
- 16 the effect on aviation safety, if any, of the modification
- 17 of the age standard contained in subsection (a).
- 18 (e) Effective Date.—This Act shall take effect on
- 19 the date that is 30 days after the date of the enactment
- 20 of this Act.
