1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Student Privacy Pro-

4	SEC. 2. ACCESS BY MILITARY RECRUITERS TO SECONDARY
5	SCHOOL STUDENT INFORMATION.
6	(a) Amendments.—Section 9528 of the Elementary

9	(1) by redesignating subsections (a) through (d)

18	(b) APPLICATION.—The amendments made by this
