## A BILL

To restore habeas corpus for those detained by the United States and to repeal the prohibition on treaty obligations establishing grounds for certain claims.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Habeas Corpus Res-  
5       toration Act of 2007”.

1 **SEC. 2. RESTORATION OF HABEAS CORPUS FOR THOSE DE-**  
2 **TAINED BY THE UNITED STATES.**

3 (a) IN GENERAL.—Section 2241 of title 28, United  
4 States Code, is amended by striking subsection (e).

5 (b) TITLE 10.—Section 950j of title 10, United  
6 States Code, is amended by striking subsection (b) and  
7 inserting the following:

8 “(b) LIMITED REVIEW OF MILITARY COMMISSION  
9 PROCEDURES AND ACTIONS.—Except as otherwise pro-  
10 vided in this chapter or in section 2241 of title 28 or any  
11 other habeas corpus provision, and notwithstanding any  
12 other provision of law, no court, justice, or judge shall  
13 have jurisdiction to hear or consider any claim or cause  
14 of action whatsoever, including any action pending on or  
15 filed after the date of the enactment of the Military Com-  
16 missions Act of 2006, relating to the prosecution, trial,  
17 or judgment of a military commission under this chapter,  
18 including challenges to the lawfulness of procedures of  
19 military commissions under this chapter.”.

20 **SEC. 3. REPEAL OF PROHIBITION ON TREATY OBLIGATIONS**  
21 **ESTABLISHING GROUNDS FOR CERTAIN**  
22 **CLAIMS.**

23 The Military Commissions Act of 2006 (Public Law  
24 109–366) is amended by striking section 5.

25 **SEC. 4. EFFECTIVE DATE AND APPLICABILITY.**

26 The amendments made by this Act shall—

1           (1) take effect on the date of the enactment of  
2       this Act; and

3           (2) apply to any case that is pending on or  
4       after the date of enactment of this Act.
