## A BILL

To amend the Morris K. Udall Scholarship and Excellence in National Environmental and Native American Public Policy Act of 1992 to provide funds for training in tribal leadership, management, and policy, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. NATIVE NATIONS LEADERSHIP, MANAGEMENT,**  
4               **AND POLICY.**

5       (a) FINDINGS.—Congress finds that—

1           (1) the policy of the United States favors self-  
2           determination for Indian tribes;

3           (2) consistent with the policy described in para-  
4           graph (1), Indian tribes are increasingly taking con-  
5           trol of the affairs of the tribes in order to realize in  
6           practice most of the status afforded the tribes in  
7           treaties, court decisions, and legislation;

8           (3) as a result of the increasing control of the  
9           tribes, tribes require enhanced leadership prepara-  
10          tion and greater access to information relating to re-  
11          search and analysis of successful models for tribal  
12          government and business operations, similar to the  
13          information regularly available to Federal, State,  
14          and local government agencies;

15          (4) enabling Indian tribes to develop strong  
16          leadership and governing policy is consistent with  
17          Federal policy supporting tribal self-determination  
18          and increases the likelihood that tribal governments  
19          will achieve political and economic self-determina-  
20          tion; and

21          (5) during the last 5 years, the Morris K. Udall  
22          Scholarship and Excellence in National Environ-  
23          mental Policy Foundation, in cooperation with the  
24          Native Nations Institute at the University of Ari-  
25          zona, pursuant to section 6(7) of the Morris K.

1        Udall Scholarship and Excellence in National Envi-  
2        ronmental and Native American Public Policy Act of  
3        1992 (20 U.S.C. 5604(7)), has provided to Indian  
4        tribes the leadership and management training, pol-  
5        icy analysis, and research of the quality and type re-  
6        quired to assist Indian tribes to achieve self-deter-  
7        mination.

8        (b) DEFINITIONS.—Section 4 of the Morris K. Udall  
9        Scholarship and Excellence in National Environmental  
10       and Native American Public Policy Act of 1992 (20  
11       U.S.C. 5602) is amended—

12                (1) by redesignating paragraphs (6) through  
13                (9) as paragraphs (7) through (10), respectively;  
14                and

15                (2) by inserting after paragraph (5) the fol-  
16        lowing:

17                “(6) the terms ‘Indian tribe’ and ‘tribe’ have  
18        the meaning given the term ‘Indian tribe’ in section  
19        4 of the Indian Self-Determination and Education  
20        Assistance Act (25 U.S.C. 450b);”.

21        (c) AUTHORIZATION OF APPROPRIATIONS.—Section  
22        13 of the Morris K. Udall Scholarship and Excellence in  
23        National Environmental and Native American Public Pol-  
24        icy Act of 1992 (20 U.S.C. 5609) is amended by striking  
25        subsection (c) and inserting the following:

1       “(c) TRAINING IN TRIBAL LEADERSHIP, MANAGE-  
2   MENT, AND POLICY.—

3               “(1) IN GENERAL.—There is authorized to be  
4   appropriated to carry out section 6(7)—

5                       “(A) \$500,000 for each of fiscal years  
6               2008 and 2009;

7                       “(B) \$750,000 for fiscal year 2010; and

8                       “(C) \$1,000,000 for each of fiscal years  
9               2011 and 2012.

10               “(2) LIMITATIONS.—An appropriation made  
11   pursuant to this subsection shall not be subject to  
12   section 7(c).”.
