## A BILL

To establish the Northern Border Economic Development Commission, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) Short Title.—This Act may be cited as the

#### 1 SEC. 2. DEFINITIONS.

- 2 In this Act, the following definitions apply:
- 3 (1) Commission.—The term "Commission"
- 4 means the Northern Border Economic Development
- 5 Commission established by section 3.
- 6 (2) Federal Grant Program.—The term
- 7 "Federal grant program" means a Federal grant
- 8 program to provide assistance in carrying out eco-
- 9 nomic and community development activities and
- 10 conservation activities that are consistent with eco-
- 11 nomic development.
- 12 (3) Non-profit entity.—The term "non-prof-
- it entity" means any entity with tax-exempt or non-
- profit status, as defined by the Internal Revenue
- 15 Service.
- 16 (4) REGION.—The term "region" means the
- area covered by the Commission (as described in sec-
- 18 tion 15).

1	SEC. 3. NORTHERN BORDER ECONOMIC DEVELOPMENT
2	COMMISSION.
3	(a) Establishment.—
4	(1) IN GENERAL.—There is established the
5	Northern Border Economic Development Commis-
6	sion.
7	(2) Composition.—The Commission shall be
8	composed of—
9	(A) a Federal member, to be appointed by
10	the President, with the advice and consent of
11	the Senate; and
12	(B) the Governor of each State in the re-
13	gion that elects to participate in the Commis-
14	sion.
15	(3) Cochairpersons.—The Commission shall
16	be headed by—
17	(A) the Federal member, who shall serve—
18	(i) as the Federal cochairperson; and
19	(ii) as a liaison between the Federal
20	Government and the Commission; and
21	(B) a State cochairperson, who—
22	(i) shall be a Governor of a partici-
23	pating State in the region; and
24	(ii) shall be elected by the State mem-
25	bers for a term of not less than 1 year.
26	(b) Alternate Members.—

1	(1) State alternates.—
2	(A) APPOINTMENT.—The State member of
3	a participating State may have a single alter-
4	nate, who shall be appointed by the Governor of
5	the State from among the Governor's cabinet or
6	personal staff.
7	(B) Voting.—An alternate shall vote in
8	the event of the absence, death, disability, re-
9	moval, or resignation of the member for whom
10	the individual is an alternate.
11	(2) Alternate federal cochairperson.—
12	The President shall appoint an alternate Federal co-
13	chairperson.
14	(3) Quorum.—
15	(A) In general.—Subject to the require-
16	ments of this paragraph, the Commission shall
17	determine what constitutes a quorum of the
18	Commission.
19	(B) FEDERAL COCHAIRPERSON.—The
20	Federal cochairperson or the Federal cochair-
21	person's designee must be present for the estab-
22	lishment of a quorum of the Commission.
23	(C) State alternates.—A State alter-
24	nate shall not be counted toward the establish-
25	ment of a quorum of the Commission.

1	(4) Delegation of Power.—No power or re-
2	sponsibility of the Commission specified in para-
3	graphs (3) and (4) of subsection (c), and no voting
4	right of any Commission member, shall be delegated
5	to any person—
6	(A) who is not a Commission member; or
7	(B) who is not entitled to vote in Commis-
8	sion meetings.
9	(c) Decisions.—
10	(1) REQUIREMENTS FOR APPROVAL.—Except
11	as provided in subsection (g), decisions by the Com-
12	mission shall require the affirmative vote of the Fed-
13	eral cochairperson and of a majority of the State
14	members, exclusive of members representing States
15	delinquent under subsection (g)(2)(C).
16	(2) Consultation.—In matters coming before
17	the Commission, the Federal cochairperson, to the
18	extent practicable, shall consult with the Federal de-
19	partments and agencies having an interest in the
20	subject matter.
21	(3) Decisions requiring quorum of state
22	MEMBERS.—The following decisions may not be
23	made without a quorum of State members:
24	(A) A decision involving Commission pol-
25	iey.

1	(B) Approval of State, regional, or sub-
2	regional development plans or strategy state-
3	ments.
4	(C) Modification or revision of the Com-
5	mission's code.
6	(D) Allocation of amounts among the
7	States.
8	(4) Project and grant proposals.—The ap-
9	proval of project and grant proposals is a responsi-
10	bility of the Commission and shall be carried out in
11	accordance with section 9.
12	(d) Duties.—The Commission shall—
13	(1) develop, on a continuing basis, comprehen-
14	sive and coordinated plans and programs to establish
15	priorities and approve grants for the economic devel-
16	opment of the region, giving due consideration to
17	other Federal, State, and local planning and devel-
18	opment activities in the region;
19	(2) not later than 365 days after the date of
20	enactment of this Act, establish priorities in a devel-
21	opment plan for the region (including 5-year re-
22	gional outcome targets);
23	(3) assess the needs and capital assets of the
24	region based on available research, demonstration
25	projects, assessments, and evaluations of the region

1	prepared by Federal, State, or local agencies, local
2	development districts, and any other relevant source
3	(4)(A) enhance the capacity of, and provide
4	support for, local development districts in the region
5	or
6	(B) if no local development district exists in an
7	area in a participating State in the region, foster the
8	creation of a local development district;
9	(5) actively solicit the participation of rep-
10	resentatives of local development districts, industry
11	groups, and other appropriate organizations as ap-
12	proved by the Commission, in all public proceedings
13	of the Commission conducted under subsection
14	(e)(1), either in-person or through interactive tele-
15	communications;
16	(6) encourage private investment in industrial
17	commercial, and other economic development
18	projects in the region; and
19	(7) not later than 365 days after the date of
20	enactment of this Act, initiate a special resource
21	study for the north woods of Maine, which study—
22	(A) shall be carried out in cooperation with
23	appropriate local, State, and Federal officials
24	and

- 1 (B) shall examine land use, ownership, and 2 development trends and propose options for fu-3 ture management, ownership, conservation, and 4 development of land to maximize job creation 5 and ecological value.
- 6 (e) Administration.—In carrying out subsection 7 (d), the Commission may—
  - (1) hold such hearings, sit and act at such times and places, take such testimony, receive such evidence, and print or otherwise reproduce and distribute a description of the proceedings and reports on actions by the Commission as the Commission considers appropriate;
  - (2) authorize, through the Federal or State cochairperson or any other member of the Commission designated by the Commission, the administration of oaths if the Commission determines that testimony should be taken or evidence received under oath;
  - (3) request from any Federal, State, or local department or agency such information as may be available to or procurable by the department or agency that may be of use to the Commission in carrying out duties of the Commission;

1	(4) adopt, amend, and repeal bylaws and rules
2	governing the conduct of Commission business and
3	the performance of Commission duties;
4	(5) request the head of any Federal department
5	or agency to detail to the Commission such per-
6	sonnel as the Commission requires to carry out du-
7	ties of the Commission, each such detail to be with-
8	out loss of seniority, pay, or other employee status
9	(6) request the head of any State department
10	or agency or local government to detail to the Com-
11	mission such personnel as the Commission requires
12	to carry out duties of the Commission, each such de-
13	tail to be without loss of seniority, pay, or other em-
14	ployee status;
15	(7) provide for coverage of Commission employ-
16	ees in a suitable retirement and employee benefit
17	system by—
18	(A) making arrangements or entering into
19	contracts with any participating State govern-
20	ment; or
21	(B) otherwise providing retirement and
22	other employee benefit coverage;
23	(8) accept, use, and dispose of gifts or dona-
24	tions of services or real, personal, tangible, or intan-

gible property;

1	(9) enter into and perform such contracts or
2	other transactions as are necessary to carry out
3	Commission duties;
4	(10) establish and maintain a central office lo-
5	cated within the Northern Border Economic Devel-
6	opment Commission region and field offices at such
7	locations as the Commission may select; and
8	(11) provide for an appropriate level of rep-
9	resentation in Washington, DC.
10	(f) Federal Agency Cooperation.—A Federal
11	agency shall—
12	(1) cooperate with the Commission; and
13	(2) provide, on request of the Federal cochair-
14	person, appropriate assistance in carrying out this
15	Act, in accordance with applicable Federal laws (in-
16	cluding regulations).
17	(g) Administrative Expenses.—
18	(1) In general.—Administrative expenses of
19	the Commission (except for the expenses of the Fed-
20	eral cochairperson, including expenses of the alter-
21	nate and staff of the Federal cochairperson, which
22	shall be paid solely by the Federal Government)
23	shall be paid—

1	(A) by the Federal Government, in an
2	amount equal to 50 percent of the administra-
3	tive expenses; and
4	(B) by the States in the region partici-
5	pating in the Commission, in an amount equal
6	to 50 percent of the administrative expenses.
7	(2) State share.—
8	(A) In General.—The share of adminis-
9	trative expenses of the Commission to be paid
10	by each State shall be determined by the Com-
11	mission.
12	(B) NO FEDERAL PARTICIPATION.—The
13	Federal cochairperson shall not participate or
14	vote in any decision under subparagraph (A).
15	(C) Delinquent states.—If a State is
16	delinquent in payment of the State's share of
17	administrative expenses of the Commission
18	under this subsection—
19	(i) no assistance under this Act shall
20	be furnished to the State (including assist-
21	ance to a political subdivision or a resident
22	of the State); and
23	(ii) no member of the Commission
24	from the State shall participate or vote in
25	any action by the Commission.

1	(h) Compensation.—
2	(1) Federal Cochairperson.—The Federal
3	cochairperson shall be compensated by the Federal
4	Government at level III of the Executive Schedule in
5	subchapter II of chapter 53 of title V, United States
6	Code.
7	(2) Alternate federal cochairperson.—
8	The alternate Federal cochairperson—
9	(A) shall be compensated by the Federal
10	Government at level V of the Executive Sched-
11	ule described in paragraph (1); and
12	(B) when not actively serving as an alter-
13	nate for the Federal cochairperson, shall per-
14	form such functions and duties as are delegated
15	by the Federal cochairperson.
16	(3) State members and alternates.—
17	(A) IN GENERAL.—A State shall com-
18	pensate each member and alternate rep-
19	resenting the State on the Commission at the
20	rate established by law of the State.
21	(B) No additional compensation.—No
22	State member or alternate member shall receive
23	any salary, or any contribution to or sup-
24	plementation of salary from any source other

1 than the State for services provided by the 2 member or alternate to the Commission. 3 (4) Detailed employees.— 4 (A) IN GENERAL.—No person detailed to serve the Commission under subsection (e)(6) 6 shall receive any salary or any contribution to 7 or supplementation of salary for services pro-8 vided to the Commission from— 9 (i) any source other than the State, 10 local, or intergovernmental department or 11 agency from which the person was detailed; 12 or 13 (ii) the Commission. 14 (B) VIOLATION.—Any person that violates 15 this paragraph shall be fined not more than 16 \$5,000, imprisoned not more than 1 year, or 17 both. 18 (C) APPLICABLE LAW.—The Federal co-19 chairperson, the alternate Federal cochair-20 person, and any Federal officer or employee de-21 tailed to duty on the Commission under sub-22 section (e)(5) shall not be subject to subpara-23 graph (A), but shall remain subject to sections 24 202 through 209 of title 18, United States

Code.

1	(5) Additional Personnel.—
2	(A) Compensation.—
3	(i) In General.—The Commission
4	may appoint and fix the compensation of
5	an executive director and such other per-
6	sonnel as are necessary to enable the Com-
7	mission to carry out the duties of the Com-
8	mission.
9	(ii) Exception.—Compensation
10	under clause (i) shall not exceed the max-
11	imum rate for the Senior Executive Service
12	under section 5382 of title 5, United
13	States Code, including any applicable local-
14	ity-based comparability payment that may
15	be authorized under section 5304(h)(2)(C)
16	of that title.
17	(B) EXECUTIVE DIRECTOR.—The executive
18	director shall be responsible for—
19	(i) the carrying out of the administra-
20	tive duties of the Commission;
21	(ii) direction of the Commission staff;
22	and
23	(iii) such other duties as the Commis-
24	sion may assign.

(C) NO FEDERAL EMPLOYEE STATUS.—No member, alternate, officer, or employee of the Commission (except the Federal cochairperson of the Commission, the alternate and staff for the Federal cochairperson, and any Federal em-ployee detailed to the Commission under sub-section (e)(5)) shall be considered to be a Fed-eral employee for any purpose.

## (i) Conflicts of Interest.—

- (1) In General.—Except as provided under paragraph (2), no State member, alternate, officer, or employee of the Commission shall participate personally and substantially as a member, alternate, officer, or employee of the Commission, through decision, approval, disapproval, recommendation, the rendering of advice, investigation, or otherwise, in any proceeding, application, request for a ruling or other determination, contract, claim, controversy, or other matter in which, to knowledge of the member, alternate, officer, or employee any of the following persons has a financial interest:
- 22 (A) The member, alternate, officer, or employee.
- 24 (B) The spouse, minor child, partner, or 25 organization (other than a State or political

1	subdivision of the State) of the member, alter-
2	nate, officer, or employee, in which the member,
3	alternate, officer, or employee is serving as offi-
4	cer, director, trustee, partner, or employee.
5	(C) Any person or organization with whom
6	the member, alternate, officer, or employee is
7	negotiating or has any arrangement concerning
8	prospective employment.
9	(2) Disclosure.—Paragraph (1) shall not
10	apply if the State member, alternate, officer, or em-
11	ployee—
12	(A) immediately advises the Commission of
13	the nature and circumstances of the proceeding,
14	application, request for a ruling or other deter-
15	mination, contract, claim, controversy, or other
16	particular matter presenting a potential conflict
17	of interest;
18	(B) makes full disclosure of the financial
19	interest; and
20	(C) before the proceeding concerning the
21	matter presenting the conflict of interest, re-
22	ceives a written determination by the Commis-
23	sion that the interest is not so substantial as to

be likely to affect the integrity of the services

1	that the Commission may expect from the State
2	member, alternate, officer, or employee.
3	(3) Violation.—Any person that violates this
4	subsection shall be fined not more than \$10,000, im-
5	prisoned not more than 2 years, or both.
6	(j) Validity of Contracts, Loans, and
7	Grants.—The Commission may declare void any con-
8	tract, loan, or grant of or by the Commission in relation
9	to which the Commission determines that there has been
10	a violation of any provision under subsection (h)(4), sub-
11	section (i), or sections 202 through 209 of title 18, United
12	States Code.

13	(b) Funding.—
14	(1) In general.—Funds for grants under sub-
15	section (a) may be provided—
16	(A) entirely from appropriations to carry
17	out this section;
18	(B) in combination with funds available
19	under another State or Federal grant program;
20	or
21	(C) from any other source.
22	(2) Eligible projects.—The Commission
23	may provide assistance, make grants, enter into con-
24	tracts, and otherwise provide funds to eligible enti-
25	ties in the region for projects that promote—

1	(A) business development;
2	(B) job training or employment-related
3	education;
4	(C) small business and entrepreneurship;
5	(D) local planning and leadership develop-
6	ment;
7	(E) basic public infrastructure, including
8	high-tech infrastructure and productive natural
9	resource conservation;
10	(F) information and technical assistance
11	for the modernization and diversification of the
12	forest products industry to support value-added
13	forest products enterprises;
14	(G) forest-related cultural, nature-based,
15	and heritage tourism;
16	(H) energy conservation and efficiency in
17	the region to enhance its economic competitive-
18	ness;
19	(I) the use of renewable energy sources in
20	the region to produce alternative transportation
21	fuels, electricity and heat; and
22	(J) any other activity facilitating economic
23	development in the region.
24	(3) Federal Share.—Notwithstanding any
25	provision of law limiting the Federal share in any

- 1 grant program, funds appropriated or otherwise
- 2 made available to carry out this section may be used
- 3 to increase a Federal share in a grant program, as
- 4 the Commission determines appropriate.

#### 5 SEC. 5. SUPPLEMENTS TO FEDERAL GRANT PROGRAMS.

- 6 (a) Federal Grant Program Funding.—In ac-
- 7 cordance with subsection (b), the Federal cochairperson
- 8 may use amounts made available to carry out this Act,
- 9 without regard to any limitations on areas eligible for as-
- 10 sistance or authorizations for appropriation under any
- 11 other Act, to fund all or any portion of the basic Federal
- 12 contribution to a project or activity under a Federal grant
- 13 program in the region in an amount that is above the fixed
- 14 maximum portion of the cost of the project otherwise au-
- 15 thorized by applicable law, but not to exceed 80 percent
- 16 of the costs of the project.

## 17 (b) Certification.—

- 18 (1) In General.—In the case of any program
- or project for which all or any portion of the basic
- Federal contribution to the project under a Federal
- 21 grant program is proposed to be made under this
- section, no Federal contribution shall be made until
- 23 the Federal official administering the Federal law
- authorizing the contribution certifies that the pro-
- 25 gram or project—

1	(A) meets the applicable requirements of
2	the applicable Federal grant law; and
3	(B) could be approved for Federal con-
4	tribution under the law if funds were available
5	under the law for the program or project.
6	(2) Certification by commission.—
7	(A) In general.—The certifications and
8	determinations required to be made by the
9	Commission for approval of projects under this
10	Act in accordance with section 9—
11	(i) shall be controlling; and
12	(ii) shall be accepted by the Federal
13	agencies.
14	(B) ACCEPTANCE BY FEDERAL COCHAIR-
15	PERSON.—Any finding, report, certification, or
16	documentation required to be submitted to the
17	head of the department, agency, or instrumen-
18	tality of the Federal Government responsible for
19	the administration of any Federal grant pro-
20	gram shall be accepted by the Federal cochair-
21	person with respect to a supplemental grant for
22	any project under the program.

1	SEC. 6. LOCAL DEVELOPMENT DISTRICTS; CERTIFICATION
2	AND ADMINISTRATIVE EXPENSES.
3	(a) Definition of Local Development Dis-
4	TRICT.—In this section, the term "local development dis-
5	trict" means an entity designated by the State that—
6	(1) is—
7	(A)(i) a planning district in existence on
8	the date of enactment of this Act that is recog-
9	nized by the Economic Development Adminis-
10	tration of the Department of Commerce; or
11	(ii) a development district recognized by
12	the State; or
13	(B) if an entity described in subparagraph
14	(A)(i) or (A)(ii) does not exist, an entity des-
15	ignated by the Commission that satisfies the
16	criteria developed by the Economic Develop-
17	ment Administration for a local development
18	district; and
19	(2) has not, as certified by the Federal cochair-
20	person—
21	(A) inappropriately used Federal grant
22	funds from any Federal source; or
23	(B) appointed an officer who, during the
24	period in which another entity inappropriately
25	used Federal grant funds from any Federal
26	source, was an officer of the other entity.

1	(b) Grants to Local Development Districts.—
2	(1) In General.—The Commission may make
3	grants for administrative expenses under this sec-
4	tion.
5	(2) Conditions for grants.—
6	(A) MAXIMUM AMOUNT.—The amount of
7	any grant awarded under paragraph (1) shall
8	not exceed 80 percent of the administrative ex-
9	penses of the local development district receiv-
10	ing the grant.
11	(B) LOCAL SHARE.—The contributions of
12	a local development district for administrative
13	expenses may be in cash or in kind, fairly evalu-
14	ated, including space, equipment, and services.
15	(c) Duties of Local Development Districts.—
16	A local development district shall—
17	(1) operate as a lead organization serving
18	multicounty areas in the region at the local level;
19	and
20	(2) serve as a liaison between State and local
21	governments, nonprofit organizations (including
22	community-based groups and educational institu-
23	tions), the business community, and citizens that—
24	(A) are involved in multijurisdictional plan-
25	ning;

1	(B) provide technical assistance to local ju-
2	risdictions and potential grantees; and
3	(C) provide leadership and civic develop-
4	ment assistance.
5	SEC. 7. DEVELOPMENT PLANNING PROCESS.
6	(a) State Development Plan.—In accordance
7	with policies established by the Commission, each State
8	member shall submit a development plan for the area of
9	the region represented by the State member.
10	(b) Content of Plan.—A State development plan
11	submitted under subsection (a) shall reflect the goals, ob-
12	jectives, and priorities identified in the regional develop-
13	ment plan developed under section $3(d)(2)$ .
14	(c) Consultation.—In carrying out the develop-
15	ment planning process, a State shall—
16	(1) consult with—
17	(A) local development districts;
18	(B) local units of government; and
19	(C) institutions of higher learning; and
20	(2) take into consideration the goals, objectives,
21	priorities, and recommendations of the entities de-
22	scribed in paragraph (1).
23	(d) Public Participation.—The Commission and
24	applicable State and local development districts shall en-
25	courage and assist, to the maximum extent practicable,

1	public participation in the development, revision, and im
2	plementation of all plans and programs under this Act
3	SEC. 8. PROGRAM DEVELOPMENT CRITERIA.
4	(a) In General.—In considering programs and
5	projects to be provided assistance under this Act, and in
6	establishing a priority ranking of the requests for assist
7	ance provided by the Commission, the Commission shall
8	follow procedures that ensure, to the maximum exten-
9	practicable, consideration of—
10	(1) the relationship of the project to overall re
11	gional development;
12	(2) the economic distress of an area, including
13	the per capita income, outmigration, poverty and un

project under this section, an affirmative vote of the Com-

mission under section 3(c) shall be required for approval

- 24 the United States east of, and including, Cayuga County,
- 25 New York, especially in rural areas.

1	(b) Counties Included in Northern Border
2	REGION.—Consistent with the goal described in sub-
3	section (a), the region of Commission shall include the fol-
4	lowing counties:
5	(1) In Maine, the counties of Aroostook, Frank-
6	lin, Oxford, Somerset, and Washington.
7	(2) In New Hampshire, the county of Coos.
8	(3) In New York, the counties of Cayuga, Clin-
9	ton, Franklin, Jefferson, Oswego, and St. Lawrence.
10	(4) In Vermont, the counties of Essex, Frank-
11	lin, Grand Isle, and Orleans.
12	(c) Contiguous Counties.—
13	(1) In general.—Subject to paragraph (2), in
14	addition to the counties listed in subsection (b), the
15	region of Commission shall include the following
16	counties:
17	(A) In Maine, the counties of
18	Androscoggin, Kennebec, Penobscot,
19	Piscataquis, and Waldo.
20	(B) In New York, the counties of Essex,
21	Hamilton, Herkimer, Lewis, Oneida, and Sen-
22	eca.
23	(C) In Vermont, the county of Caledonia.
24	(2) Recommendations to congress.—As
25	part of an annual report submitted under section 12,

1	the Commission may recommend to Congress re-
2	moval of a county listed in paragraph (1) from the
3	region on the basis that the county no longer exhib-
4	its 2 or more of the following economic distress fac-
5	tors: population loss, poverty, income levels, and un-
6	employment.
7	(d) Examination of Additional Counties and
8	Areas for Inclusion in the Region.—
9	(1) In general.—Not later than one year
10	after the date of enactment of this Act, the Commis-
11	sion—
12	(A) shall examine all counties that border
13	the region of the Commission specified in sub-
14	section (a), including the political subdivisions
15	and census tracts within such counties; and
16	(B) may add a county or any portion of a
17	county examined under subparagraph (A)to the
18	region, if the Commission determines that the

10	(C) In New York, the counties of Fulton
11	and Madison.
12	(D) In Vermont, the county of Lamoille.
13	(e) Addition of Counties and Other Areas.—
14	(1) RECOMMENDATIONS.—Following the one-
15	year period beginning on the date of enactment of
16	this Act, as part of an annual report submitted
17	under section 12, the Commission may recommend
18	to Congress additional counties or portions of coun-
19	ties for inclusion in the region.
20	(2) Areas of economic distress.—The Com-
21	mission may recommend that an entire county be in-
22	cluded in the region on the basis of one or more dis-
23	tressed areas within the county.
24	(3) Assessments of economic condi-
25	TIONS.—The Commission may provide technical and

- 1 financial assistance to a county that is not included
- 2 in the region for the purpose of conducting an eco-
- 3 nomic assessment of the county. The results of such
- 4 an assessment may be used by the Commission in
- 5 making recommendations under paragraph (1).
- 6 (f) Limitation.—A county eligible for assistance
- 7 from the Appalachian Regional Commission under subtitle
- 8 IV of title 40, United States Code, shall not be eligible
- 9 for assistance from the Northern Border Economic Devel-
- 10 opment Commission.
