A BILL

To amend title 5, United States Code, to establish a national health program administered by the Office of Personnel Management to offer Federal employee health benefits plans to certain individuals affected by an incident of national significance, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Emergency Coverage
- 5 During an Incident of National Significance Act of 2007".

1	SEC. 2. EXTENSION OF FEDERAL EMPLOYEE HEALTH IN-
2	SURANCE TO CERTAIN INDIVIDUALS AF-
3	FECTED BY AN INCIDENT OF NATIONAL SIG-

5	(a) In General.—Subpart G of part III of title 5,
6	United States Code, is amended by redesignating chapters
7	89A and 89B as chapters 89B and 89C, respectively, and
8	by inserting after chapter 89 the following:
9	"CHAPTER 89A—EMERGENCY HEALTH IN-
10	SURANCE FOR CERTAIN INDIVIDUALS
11	AFFECTED BY AN INCIDENT OF NA-
12	TIONAL SIGNIFICANCE

14	"In this chapter—
15	"(1) the terms defined under section 8901 shall
16	have the meanings given such terms under that sec-
17	tion;
18	"(2) the term 'eligible individual' means any in-
19	dividual who, at the time of an incident of national
20	significance, resides or is employed in the area iden-
21	tified under section 8924 with respect to such inci-
22	dent;

- 1 "(3) the term 'incident of national significance'
- 2 means a domestic catastrophic incident which is des-
- 3 ignated as an incident of national significance by the
- 4 President pursuant to the national response plan re-
- 5 ferred to in section 502(6) of the Homeland Security

- 7 "(4) the term 'Office' means the Office of Per-
- 8 sonnel Management.

- 10 "(a) The Office of Personnel Management shall ad-
- 11 minister a health insurance program for eligible individ-
- 12 uals in accordance with this chapter.
- "(b) Except as provided under this chapter, the Of-
- 14 fice shall prescribe regulations to apply the provisions of
- 15 chapter 89 to the greatest extent practicable to eligible
- 16 individuals covered under this chapter.

17 "§ 8923. Contract requirement

- 18 "(a) In each calendar year, the Office shall enter into
- 19 a contract with 3 or more carriers to make available 5
- 20 or more health benefits plans (subject to the provisions
- 21 of this chapter) to eligible individuals under this chapter.
- 22 "(b) In carrying out this section, the Office may re-
- 23 quire 5 or more carriers to enter into a contract described
- 24 in subsection (a), as a condition of entering into a contract
- 25 under section 8902.

1 "§ 8924. Eligibility and identification of individuals

- 2 "(a) Except as provided in subsection (b), any eligible
- 3 individual may enroll in a health benefits plan under this
- 4 chapter.
- 5 "(b) An individual may not enroll in a health benefits
- 6 plan under this chapter, if the individual—
- 7 "(1) is 65 years of age or older;
- 8 "(2) is enrolled or eligible to enroll for coverage
- 9 under a public health insurance program, including
- 10 coverage under title XVIII of the Social Security
- 11 Act, coverage under a State plan under title XIX of
- such Act, coverage under a State plan under title
- 13 XX of such Act, or coverage under any other pro-
- 14 gram determined by the Office;
- 15 "(3) is enrolled or eligible to enroll in a plan
- under chapter 89; or
- 17 "(4) is a member of the uniformed services as
- defined under section 101(a)(5) of title 10.
- 19 "(c) With respect to each incident of national signifi-
- 20 cance, the Secretary of Homeland Security shall, con-
- 21 sistent with the President's designation of such incident,
- 22 identify the area affected by such incident and shall, in
- 23 consultation with the Office, carry out a program to iden-
- 24 tify eligible individuals with respect to such incident.
- 25 "(d) The period of an individual's enrollment in a
- 26 health benefits plan under this chapter shall not exceed

- 1 24 months with respect to any incident of national signifi-
- 2 cance. Such period may be extended by the Office if the
- 3 Secretary of Homeland Security determines that the area
- 4 identified under subsection (c) remains affected by the in-
- 5 cident.

- 8 "(a) Rates charged and premiums paid for a health
- 9 benefits plan under this chapter may differ between or
- 10 among geographic regions.
- 11 "(b) No Government contribution shall be made for
- 12 any individual under this chapter.
- 13 "(c) In the administration of this chapter, the Office
- 14 shall ensure that individuals covered under this chapter
- 15 shall be in a risk pool that is separate from the risk pool
- 16 maintained for individuals covered under chapter 89.".
- 17 (b) Technical and Conforming Amendments.—
- 18 (1) Contract requirement under chapter
- 19 89.—Section 8902 of title 5, United States Code, is
- amended by adding after subsection (o) the fol-

18	(a) In General.—Subpart C of part IV of sub-
19	chapter A of chapter 1 of the Internal Revenue Code of
20	1986 (relating to refundable credits) is amended by redes-
21	ignating section 36 as section 37 and inserting after sec-
22	tion 35 the following new section:

1	"SEC. 36. EMERGENCY HEALTH INSURANCE COSTS OF CER-
2	TAIN INDIVIDUALS AFFECTED BY AN INCI-
3	DENT OF NATIONAL SIGNIFICANCE.
4	"(a) In General.—In the case of an individual,
5	there shall be allowed as a credit against the tax imposed
6	by this subtitle for the taxable year an amount equal to
7	the applicable percentage of the amount paid during such
8	taxable year by the taxpayer for coverage of the taxpayer
9	and family members under the health insurance plan es-
10	tablished under chapter 89A of title 5, United States
11	Code.
12	"(b) Applicable Percentage.—
13	"(1) In general.—For purposes of subsection
14	(a), the applicable percentage shall be determined in
15	accordance with the following table:

16	"(2) Family income.—For purposes of this
17	subsection, the term 'family income' means the ag-
18	gregate adjusted gross income of the taxpayer and

1 "(3) POVERTY LINE.—For purposes of this 2 subsection, the term 'poverty line' means the poverty 3 line as defined in section 673(2) of the Community 4 Services Block Grant Act, for a family of the size in-5 volved.

- "(1) COORDINATION WITH ADVANCE PAYMENTS
 OF CREDIT.—With respect to any taxable year, the
 amount which would (but for this paragraph) be allowed as a credit to the taxpayer under subsection
 (a) shall be reduced (but not below zero) by the aggregate amount paid on behalf of such taxpayer
 under section 7529 for such taxable year.
- "(2) COORDINATION WITH OTHER DEDUC-TIONS.—Amounts taken into account under subsection (a) shall not be taken into account in determining any deduction allowed under section 162(l) or 213.
