A BILL

- To establish a Rural Policing Institute within the Federal Law Enforcement Training Center of the Department of Homeland Security to develop and provide for training programs for rural law enforcement agencies.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Rural Law Enforce-
 - 5 ment Training Act of 2007".
 - 6 SEC. 2. RURAL POLICING INSTITUTE.
 - 7 (a) Establishment.—There is established a Rural
 - 8 Policing Institute, which shall be administered by the Di-

1	rector of the Federal Law Enforcement Training Center
2	of the Department of Homeland Security, through the
3	chief executive officer of the Office of State and Local
4	Training of such Center, to perform the following func-
5	tions, with respect to law enforcement agencies of units
6	of local government and tribal governments located in
7	rural areas:
8	(1) Evaluation of needs of rural law en-
9	FORCEMENT AGENCIES.—To evaluate the needs of
10	such agencies.
11	(2) Development of training programs.—
12	To develop expert training programs designed to re-
13	spond to the needs of such agencies with respect
14	to—
15	(A) preparing for and responding to rural
16	homeland security threats and incidents;
17	(B) combating methamphetamine addiction
18	and distribution;
19	(C) combating domestic violence;
20	(D) responding to school shootings; and
21	(E) other topics identified in the evaluation
22	conducted under paragraph (1).
23	(3) Provision of training programs.—To
24	provide to such agencies the training programs de-
25	veloped under paragraph (2).

- 1 (4) Outreach efforts.—To conduct outreach
- 2 efforts to ensure that such agencies are aware of the
- 3 training programs developed under paragraph (2) so
- 4 that such programs are made available to law en-
- 5 forcement officers of such agencies.
- 6 (b) No Duplication or Displacement of Cur-
- 7 RENT PROGRAMS.—Any training program developed
- 8 under paragraph (2) of subsection (a) and any training
- 9 provided by the Rural Policing Institute pursuant to such
- 10 subsection shall be developed or provided, respectively, in
- 11 a manner so as to not duplicate or displace any law en-
- 12 forcement program of the Federal Law Enforcement
- 13 Training Center in existence on the date of the enactment
- 14 of this section.
- 15 (c) Prioritized Locations for Rural Law En-
- 16 FORCEMENT TRAINING.—In designating sites for the pro-
- 17 vision of training under this section and for purposes of
- 18 ensuring cost-effectiveness, the Director of the Federal
- 19 Law Enforcement Training Center shall, to the maximum
- 20 extent possible and as appropriate, give priority to facili-
- 21 ties of the Department of Homeland Security in existence
- 22 as of the date of the enactment of this Act and to closed
- 23 military installations.
- 24 (d) Rural Defined.—In this section, the term
- 25 "rural" means an area that is not located in a metropoli-

- 1 tan statistical area, as defined by the Office of Manage-
- 2 ment and Budget.
- 3 (e) Authorization of Appropriations.—There
- 4 are authorized to be appropriated to carry out this sec-
- 5 tion—
- 6 (1) \$10,000,000 for fiscal year 2008; and
- 7 (2) \$5,000,000 for each of fiscal years 2009
- 8 through 2013.
