Mrs. MCCARTHY of New York introduced the following bill; which was referred to the Committee on Homeland Security

A BILL

To authorize the Secretary of Homeland Security to make grants to address homeland security preparedness shortcomings of units of municipal and county government.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Domestic Preparedness
5 Act of 2007”.

6 **SEC. 2. GRANT AUTHORITY.**

7 (a) IN GENERAL.—The Secretary of Homeland Secu-
8 rity may make grants in accordance with this Act to ad-

1 dress homeland security preparedness shortcomings of
2 units of municipal and county government.

3 (b) CATEGORIES.—Each grant under this section
4 shall be made for one of the following categories of use:

5 (1) Equipment and training.

6 (2) Improving interoperability between members
7 of a consortium of municipal or county governments.

8 (c) COST SHARING.—The Federal share of the costs
9 of an activity carried out with a grant under this section—

10 (1) may not exceed 70 percent of the total costs
11 of such activity, in the case of a grant for equipment
12 and training; and

13 (2) may not exceed 90 percent of the total costs
14 of such activity, in the case of a grant for improving
15 interoperability between members of a consortium of
16 municipal or county governments.

17 **SEC. 3. GRANT ELIGIBILITY.**

18 (a) IN GENERAL.—To be eligible for a grant under
19 this Act, an applicant must be a unit of municipal or coun-
20 ty government or a consortium of such units.

21 (b) LIMITATION.—

22 (1) IN GENERAL.—A unit of municipal or coun-
23 ty government, or a consortium of such units, may
24 not receive more than one grant under this Act.

1 (2) RESTRICTION ON ADDITIONAL GRANT TO
2 MEMBER OF CONSORTIUM.—A unit of municipal or
3 county government that is a member of a consor-
4 tium that receives a grant under this Act is not eli-
5 gible to receive an additional grant under this Act
6 individually or as a member of another consortium.

7 **SEC. 4. APPLICATION.**

8 (a) IN GENERAL.—Any unit of municipal or county
9 government may submit an application for a grant under
10 this section to the Secretary, on behalf of such unit or
11 on behalf of a consortium of which the unit is a member.

12 (b) CONTENTS.—An application under this section—

13 (1) shall seek funding for one of the categories
14 of use required under section 2(b); and

15 (2) shall include the results of a vulnerability
16 assessment in accordance with section 5.

17 **SEC. 5. VULNERABILITY ASSESSMENT.**

18 (a) IN GENERAL.—The Secretary may not make a
19 grant under this Act unless the applicant for the grant
20 conducts a vulnerability assessment that assesses the risk
21 and vulnerability of the applicant (including each member
22 of the applicant, in the case of a consortium) to a variety
23 of possible acts of terrorism, including conventional, bio-
24 logical, nuclear, and chemical attacks.

1 (b) REQUIREMENTS FOR ASSESSMENTS.—The Sec-
2 retary of Homeland Security shall prescribe requirements
3 for vulnerability assessments under this section.

4 (c) LIMITATION ON GRANTS FOR EQUIPMENT OR
5 TRAINING.—The Secretary may not make a grant under
6 this Act for equipment and training unless the Secretary
7 determines that the grant will address a need determined
8 in the vulnerability assessment conducted under this sec-
9 tion for purposes of the grant.

10 **SEC. 6. USE OF GRANT.**

11 Amounts provided as a grant under this section—

12 (1) shall be used only for the category of use
13 under section 2(b) for which the grant is made;

14 (2) may be used only for new domestic pre-
15 paredness initiatives;

16 (3) shall not be used to sustain or supplement
17 existing program; and

18 (4) may be distributed by the grantee to fire
19 departments, police departments, emergency serv-
20 ices, and public health agencies of the grantee.

21 **SEC. 7. RELATIONSHIP TO OTHER GRANT PROGRAMS.**

22 The program of grants under this Act—

23 (1) is intended to complement, and not take the
24 place of, the Assistance to Firefighters Program

1 conducted by the Office of Domestic Preparedness;
2 and

3 (2) does not affect the eligibility of any person
4 for the Assistance to Firefighters Grants or any
5 other funding made available by the Department of
6 Homeland Security.
