## A BILL

To provide alternative retired pay rates under title 10, United States Code, and alternative disability compensation rates under title 38, United States Code, for members of the Armed Forces with a combat-related disability, with such rates based on the average monthly salary for high school graduates in the United States, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ALTERNATIVE RETIRED PAY RATES FOR MEM-**  
2 **BERS OF THE ARMED FORCES WITH A COM-**  
3 **BAT-RELATED DISABILITY.**

4 (a) ALTERNATIVE RETIRED PAY BASE FOR CHAP-  
5 TER 71 RETIRED PAY.—Section 1401 of title 10, United  
6 States Code, is amended by adding at the end the fol-  
7 lowing new subsection:

8 “(c) ALTERNATIVE RETIRED PAY BASE FOR MEM-  
9 BERS WITH A COMBAT-RELATED DISABILITY.—(1) In the  
10 case of a member of the armed forces with a combat-re-  
11 lated disability who is entitled to monthly retired pay com-  
12 puted using a formula specified in subsection (a), the Sec-  
13 retary concerned shall permit the member to elect to have  
14 used in that formula, in lieu of the retired pay base of  
15 the member computed under section 1406(b) or 1407 of  
16 this title, a retired pay base equal to \$2,917, which rep-  
17 resents the average monthly salary for high school grad-  
18 uates in the United States, as determined by the Census  
19 Bureau for 2006.

20 “(2) The alternative retired pay base in effect under  
21 paragraph (1) for a calendar year shall be adjusted on  
22 December 1 of that year in the manner provided by section  
23 1401a(b) of this title for use during the next calendar  
24 year.

25 “(3) In this subsection, the term ‘combat-related dis-  
26 ability’ means a disability that is compensable under the

1 laws administered by the Secretary of Veterans Affairs  
2 and that—

3 “(A) is attributable to an injury for which the  
4 member was awarded the Purple Heart; or

5 “(B) was incurred (as determined under criteria  
6 prescribed by the Secretary of Defense for purposes  
7 of section 1413a of this title) as a direct result of  
8 armed conflict.”.

9 (b) ALTERNATIVE RETIRED PAY BASE FOR RETIRED  
10 PAY FOR NON-REGULAR SERVICE.—Section 12739 of  
11 such title is amended by adding at the end the following  
12 new subsection:

13 “(e)(1) In the case of a member of the armed forces  
14 with a combat-related disability who is entitled to monthly  
15 retired pay computed under subsection (a), the Secretary  
16 concerned shall permit the member to elect to have used  
17 in paragraph (1) of such subsection, in lieu of the retired  
18 pay base of the member computed under section 1406(b)  
19 or 1407 of this title, a retired pay base equal to \$2,917,  
20 which represents the average monthly salary for high  
21 school graduates in the United States, as determined by  
22 the Census Bureau for 2006.

23 “(2) The alternative retired pay base in effect under  
24 paragraph (1) for a calendar year shall be adjusted on  
25 December 1 of that year in the manner provided by section

1 1401a(b) of this title for use during the next calendar  
2 year.

3 “(3) In this subsection, the term ‘combat-related dis-  
4 ability’ means a disability that is compensable under the  
5 laws administered by the Secretary of Veterans Affairs  
6 and that—

7 “(A) is attributable to an injury for which the  
8 member was awarded the Purple Heart; or

9 “(B) was incurred (as determined under criteria  
10 prescribed by the Secretary of Defense for purposes  
11 of section 1413a of this title) as a direct result of  
12 armed conflict.”.

13 (c) APPLICATION OF AMENDMENTS.—The amend-  
14 ments made by subsections (a) and (b) shall apply with  
15 respect to members of the Armed Forces who retired or  
16 whose names were placed on the temporary disability re-  
17 tired list after September 11, 2001, except that any re-  
18 computation of the retired pay for a member on account  
19 of such amendments who retired or whose name was  
20 placed on the temporary disability retired list before the  
21 date of the enactment of this Act shall be effective only  
22 for months beginning after the date of the enactment of  
23 this Act.

1 **SEC. 2. ALTERNATIVE WARTIME DISABILITY COMPENSA-**  
2 **TION RATES FOR CERTAIN VETERANS.**

3 (a) ALTERNATIVE COMPENSATION BASE FOR CHAP-  
4 TER 11 WARTIME DISABILITY COMPENSATION.—Section  
5 1114 of title 38, United States Code, is amended by add-  
6 ing at the end the following new subsection:

7 “(t)(1) In the case of a veteran—

8 “(A) having a covered service-connected  
9 disability rated as total, the Secretary shall per-  
10 mit the veteran to elect to receive, in lieu of the  
11 monthly compensation rate in effect under sub-  
12 section (j), a monthly compensation equal to  
13 \$2,917, which represents the average monthly  
14 salary for high school graduates in the United  
15 States, as determined by the Census Bureau for  
16 2006; and

17 “(B) having a covered service-connected  
18 disability rated at a percentage other than total,  
19 the Secretary shall permit the veteran to elect  
20 to receive, in lieu of the monthly compensation  
21 rate in effect under subsections (a) through (i),  
22 as applicable, a monthly compensation equal to  
23 the amount that is the percentage of \$2,917  
24 that corresponds to the percentage of the serv-  
25 ice-connected disability rating of the veteran.

1       “(2) For purposes of this subsection, the term ‘cov-  
2   ered service-connected disability’ means a service-con-  
3   nected disability that—

4               “(A) is attributable to an injury for which the  
5       veteran was awarded the Purple Heart; or

6               “(B) was incurred (as determined under criteria  
7       prescribed by the Secretary of Defense for purposes  
8       of section 1413a of title 10) as a direct result of  
9       armed conflict.”.

10       (b) APPLICATION OF AMENDMENT.—The amendment  
11   made by subsection (a) shall apply with respect to veterans  
12   who became eligible to receive compensation under section  
13   1110 of title 38, United States Code, after September 11,  
14   2001, except that any recomputation of disability com-  
15   pensation for a veteran on account of such an amendment  
16   who so became eligible before the date of the enactment  
17   of this Act shall be effective only for months beginning  
18   after the date of the enactment of this Act.
