A BILL

To grant a right of first refusal to the Town of Jupiter Island, Florida, with respect to Coast Guard property on Jupiter Island, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. RIGHT OF FIRST REFUSAL FOR COAST GUARD
- 4 PROPERTY ON JUPITER ISLAND, FLORIDA.
- 5 (a) Right of First Refusal.—Notwithstanding
- 6 any other law (other than this section), the Town of Jupi-
- 7 ter Island, Florida, shall have the right of first refusal
- 8 to select and take without consideration fee simple title
- 9 to real property within the jurisdiction of the Town com-

- 1 prising Parcel #35–38–42–004–000–02590–6 (Bon Air
- 2 Beach lots 259 and 260 located at 83 North Beach Road)
- 3 and Parcel #35-38-42-004-000-02610-2 (Bon Air
- 4 Beach lots 261 to 267), including any improvements
- 5 thereon that are not authorized or required by another
- 6 provision of law to be conveyed to another person.
- 7 (b) Identification of Property.—The Com-
- 8 mandant of the Coast Guard may identify, describe, and
- 9 determine the property referred to in subsection (a) that
- 10 is subject to the right of the Town under that subsection.
- 11 (c) Limitation.—The property referred to in sub-
- 12 section (a) may not be conveyed under that subsection
- 13 until the Commandant of the Coast Guard determines that
- 14 the property is not needed to carry out Coast Guard oper-
- 15 ations.
- 16 (d) REQUIRED USE.—Any property conveyed under
- 17 this section shall be used by the Town of Jupiter Island,
- 18 Florida, solely for conservation of habitat and as protec-
- 19 tion against damage from wind, tidal, and wave energy.
- 20 (e) Reversion.—Any conveyance of property under
- 21 this section shall be subject to the condition that all right,
- 22 title, and interest in the property, at the option of the
- 23 Commandant of the Coast Guard, shall revert to the
- 24 United States Government if the property is used for pur-
- 25 poses other than conservation.

1	(f) Implementation.—The Commandant of the
2	Coast Guard shall upon request by the Town—
3	(1) promptly take those actions necessary to
4	make property identified under subsection (b) and
5	determined by the Commandant under subsection (c)
6	ready for conveyance to the Town; and
7	(2) convey the property to the Town subject to
8	subsections (d) and (e).
