Mr. ISRAEL (for himself, Mr. CARNEY, Mr. RYAN of Ohio, Mr. HODES, Mr. BISHOP of New York, Mr. MOORE of Kansas, and Mr. PERLMUTTER) introduced the following bill; which was referred to the Committee on Foreign Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

## A BILL

To require a clear accounting of the combat proficiency of the security forces of Iraq.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. FINDINGS AND DECLARATION OF POLICY.**

4       (a) FINDINGS.—Congress finds the following:

5           (1) Congress has appropriated over \$15 billion  
6       to train and equip the security forces of Iraq since  
7       April 2004.

9 (b) DECLARATION OF POLICY.—Congress declares  
10 that it shall be the policy of the United States to ensure  
11 that—

12 (1) the security forces of Iraq are trained to  
13 achieve the highest level of combat efficiency in  
14 order to provide for the security and stability of the  
15 Iraqi people;

16 (2) as each battalion of the Iraqi security forces  
17 achieves a level of combat proficiency such that it  
18 can conduct independent combat operations without  
19 support from Coalition forces in Iraq, a unit of the  
20 United States Armed Forces of comparable size will  
21 be redeployed from Iraq; and

22 (3) regular, accurate accounts of the combat  
23 proficiency of battalions of the Iraqi security forces  
24 are necessary for the American public to gauge the  
25 development of the Iraqi security forces.

1   **SEC. 2. REPORT ON COMBAT PROFICIENCY OF IRAQI SECU-**  
2                   **RITY FORCES.**

3               (a) REPORT.—The President of the United States  
4 shall transmit to the appropriate congressional committees  
5 each month a report that contains an accounting of the  
6 number of battalions of the security forces of Iraq at each  
7 level of combat proficiency described in subsection (b).

8               (b) LEVELS OF COMBAT PROFICIENCY.—The levels  
9 of combat proficiency referred to in subsection (a) are the  
10 following:

11               (1) Level 1 means a battalion that can conduct  
12 independent combat operations without support from  
13 Coalition forces in Iraq.

14               (2) Level 2 means a battalion that can conduct  
15 independent combat operations, but only with  
16 logistical support, or non-combat-related support  
17 from Coalition forces in Iraq. The Coalition forces  
18 will not help with direct combat in support of the  
19 battalion.

20               (3) Level 3 means a battalion that can partici-  
21 pate in combat operations alongside Coalition forces,  
22 but cannot conduct independent combat operations  
23 without direct combat support from Coalition forces  
24 in Iraq.

1 (4) Level 4 means a battalion that cannot par-  
2 ticipate in combat operations, even with support  
3 from Coalition forces in Iraq.

4 (c) COMPARISON OF DATA.—The report shall include  
5 a comparison of data from each previous report with re-  
6 spect to each battalion of the security forces of Iraq.

7 (d) PUBLIC NOTIFICATION.—The President shall en-  
8 sure that each report required by this section is made  
9 available on the main public Internet Web site of the De-  
10 partment of Defense not later than 10 days after the date  
11 on which the report is transmitted to the appropriate con-  
12 gressional committees, and that a link to the accounting  
13 in the report is made available on the homepage of such  
14 Internet Web site.

15 (e) DEFINITION.—As used in this section, the term  
16 “appropriate congressional committees” means—

21 (2) the Committee on Appropriations, the Com-  
22 mittee on Armed Services, and the Select Committee  
23 on Intelligence of the Senate.

24 (f) EFFECTIVE DATE.—The requirement to transmit  
25 and make available reports under this section shall apply

1 with respect to the first month beginning after the date  
2 of the enactment of this Act and to each subsequent  
3 month thereafter until the President determines and cer-  
4 tifies to the appropriate congressional committees that the  
5 security forces of Iraq have achieved combat proficiency  
6 to the extent necessary to combat the insurgency in Iraq.
