Mr. ANDREWS (for himself and Mr. LoBIONDO) introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To amend the Internal Revenue Code of 1986 to allow the deduction for State and local income and property taxes under the alternative minimum tax.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. DEDUCTION FOR STATE AND LOCAL INCOME
4 AND PROPERTY TAXES ALLOWED UNDER THE
5 ALTERNATIVE MINIMUM TAX.

6 (a) IN GENERAL.—Subparagraph (A) of section
7 56(b)(1) of the Internal Revenue Code of 1986 (relating
8 to general limitation on deductions) is amended by strik-

1 ing “or” at the end of clause (i) and by striking clause
2 (ii) and inserting the following new clauses:

3 “(ii) for any foreign real property
4 taxes described in paragraph (1) of section
5 164(a), or
6 “(iii) for so much of paragraph (3) of
7 section 164(a) as relates to foreign income,
8 war profits, and excess profits taxes.”.

9 (b) EFFECTIVE DATE.—The amendment made by
10 subsection (a) shall apply to taxable years beginning after
11 December 31, 2006.
