A BILL

To amend the Internal Revenue Code of 1986 to disallow the credit for renewable diesel in the case of fuel coproduced with petroleum, natural gas, or coal feedstocks.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Responsible Renewable
3 Energy Tax Credit Act of 2007”.

4 **SEC. 2. DISALLOWANCE OF RENEWABLE DIESEL CREDIT**5 **FOR FUEL COPRODUCED WITH CERTAIN
6 FEEDSTOCKS.**

7 (a) **COPRODUCTION WITH PETROLEUM FEED-
8 STOCK.**—Paragraph (3) of section 40A(f) of the Internal
9 Revenue Code of 1986 (defining renewable diesel) is
10 amended by adding at the end the following flush sen-
11 tence:

12 “Such term does not include any fuel derived from
13 coprocessing biomass with a feedstock which is not
14 biomass. For purposes of this paragraph, the term
15 ‘biomass’ has the meaning given such term by sec-
16 tion 45K(c)(3).”.

17 (b) **CONFORMING AMENDMENT.**—Section 40A(f)(3)
18 of such Code is amended by striking “(as defined in sec-
19 tion 45K(c)(3))”.

20 (c) **EFFECTIVE DATE.**—The amendments made by
21 this section shall apply to fuel produced after June 30,
22 2007.
