## A BILL

To extend for 3 months transitional medical assistance (TMA) and the abstinence education program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 3-MONTH EXTENSION OF TRANSITIONAL MED-**  
4 **ICAL ASSISTANCE (TMA) AND THE ABSTI-**  
5 **NENCE EDUCATION PROGRAM.**

6 Activities authorized by sections 510 and 1925 of the  
7 Social Security Act shall continue through September 30,  
8 2007, in the manner authorized for fiscal year 2006, not-  
9 withstanding section 1902(e)(1)(A) of such Act, and out

1 of any money in the Treasury of the United States not  
2 otherwise appropriated, there are hereby appropriated  
3 such sums as may be necessary for such purpose. Grants  
4 and payments may be made pursuant to this authority  
5 through the fourth quarter of fiscal year 2007 at the level  
6 provided for such activities through the fourth quarter of  
7 fiscal year 2006.

8 **SEC. 2. REQUIREMENT FOR USE OF TAMPER-RESISTANT**  
9 **PRESCRIPTION PADS UNDER THE MEDICAID**  
10 **PROGRAM.**

11 (a) IN GENERAL.—Section 1903(i) of the Social Se-  
12 curity Act (42 U.S.C. 1396b(i)) is amended—

13 (1) by striking “or” at the end of paragraph  
14 (21);

15 (2) by striking the period at the end of para-  
16 graph (22) and inserting “; or”; and

17 (3) by inserting after paragraph (22) the fol-  
18 lowing new paragraph:

19 “(23) with respect to amounts expended for  
20 medical assistance for covered outpatient drugs (as  
21 defined in section 1927(k)(2)) for which the pre-  
22 scription was executed in written (and non-elec-  
23 tronic) form unless the prescription was executed on  
24 a tamper-resistant pad.”.

1       (b) **EFFECTIVE DATE.**—The amendments made by  
2 subsection (a) shall apply to prescriptions executed on or  
3 after October 1, 2007.
