A BILL

To direct the Secretary of Health and Human Services to prepare concise written materials for use by school personnel to help to identify students with a high potential to commit aggressive and harmful behavior, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Help Identify Indica-
- 5 tors of Potential Student Aggression Act of 2007".

1	SEC. 2. MATERIALS FOR USE BY SCHOOL PERSONNEL TO
2	IDENTIFY STUDENTS WITH A HIGH POTEN-
3	TIAL TO COMMIT AGGRESSIVE AND HARM-
4	FUL BEHAVIOR.
5	(a) In General.—The Secretary of Health and
6	Human Services, acting through the Administrator of the
7	Substance Abuse and Mental Health Services Administra-
8	tion, shall prepare and, as appropriate, periodically re-
9	vise—
10	(1) concise written materials to be used by fac-
11	ulty, counselors, teachers' aides, school medical per-
12	sonnel, and other school leaders in elementary
13	schools, secondary schools, and institutions of higher
14	education—
15	(A) to help to identify the possible warning
16	signs of a student with a high potential to com-
17	mit aggressive and harmful behavior to prop-
18	erty, themselves, or others; and
19	(B) to refer an accounting of the suspect
20	behavior to designated school personnel; and
21	(2) more detailed written materials to be used
22	by designated school personnel to determine an ap-
23	propriate course of action with respect to a student
24	identified pursuant to paragraph (1), including
25	whether the student should be referred to a mental
26	health expert.

1	(b) Alternative Versions.—The materials pre-
2	pared under subsection (a) may be prepared in alternative
3	versions to specifically address distinct school settings.
4	(c) Considerations.—In preparing the materials
5	required by paragraphs (1) and (2) of subsection (a), the
6	Secretary of Health and Human Services—
7	(1) shall take into consideration the need to dif-
8	ferentiate indicators of a wide range of normal be-
9	havior from indicators of a high potential for aggres-
10	sive and harmful behavior;
11	(2) shall take into consideration the possibility
12	of unintended, adverse consequences resulting from
13	targeting for suspicion or identifying a student as
14	having a high potential to commit aggressive and
15	harmful behavior;
16	(3) shall design the materials in a manner
17	that—
18	(A) protects student confidentiality and
19	privacy throughout the identification and refer-
20	ral processes; and
21	(B) notwithstanding such protections, pre-
22	serves the authority of school officials to inter-
23	vene when immediate action is required to con-
24	trol a given situation; and

- 1 (4) shall design the materials so as to prevent
- 2 stereotyping of students and misuse by school per-
- 3 sonnel on the basis of gender, racial, ethnic, or cul-
- 4 tural differences.
- 5 (d) Rule of Construction.—Nothing in this Act
- 6 shall be construed to require an elementary school, sec-
- 7 ondary school, or institution of higher education—
- 8 (1) to use the materials prepared under sub-
- 9 section (a); or
- 10 (2) to implement any standard or recommenda-
- tion contained in such materials.
- 12 (e) Provision to Secretary of Education.—The
- 13 Secretary of Health and Human Services shall provide the
- 14 materials prepared under subsection (a), including any re-
- 15 vision thereof, to the Secretary of Education for distribu-
- 16 tion. The Secretary of Health and Human Services shall
- 17 provide the first version of such materials, ready for dis-
- 18 tribution, not later than 90 days after the date of the en-
- 19 actment of this Act.
- 20 (f) DISTRIBUTION TO SCHOOLS.—Not later than 90
- 21 days after receipt of materials pursuant to subsection (e),
- 22 including any revision thereof, the Secretary of Education
- 23 shall distribute such materials to each private or public
- 24 elementary school, secondary school, and institution of
- 25 higher education.

(g) DEFINITIONS.—In this Act:

- 2 (1) The terms "elementary school" and "sec-3 ondary school" have the meanings given to such 4 terms in section 9101 of the Elementary and Sec-5 ondary Education Act of 1965 (20 U.S.C. 7801).
 - (2) The term "institution of higher education" has the meaning given to such term in section 102 of the Higher Education Act of 1965 (20 U.S.C. 1002).
