Mr. LAMBORN introduced the following bill; which was referred to the
Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to increase assistance for veterans interred in cemeteries other than national cemeteries, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans’ Dignified
5 Burial Assistance Act of 2007”.

6 **SEC. 2. INCREASE IN ASSISTANCE FOR VETERANS IN-**
7 **TERRED IN CEMETERIES OTHER THAN NA-**
8 **TIONAL CEMETERIES.**

9 (a) INCREASE IN PLOT OR INTERMENT ALLOW-
10 ANCE.—Section 2303(b) of title 38, United States Code,

1 is amended by striking “\$300” each place it appears and
 2 inserting “\$400”.

3 (b) REPEAL OF TIME LIMITATION FOR STATE FIL-
 4 ING FOR REIMBURSEMENT FOR INTERMENT COSTS.—

5 (1) IN GENERAL.—The second sentence of sec-
 6 tion 3.1604(d)(2) of title 38, Code of Federal Regu-
 7 lations, shall have no further force or effect as it
 8 pertains to unclaimed remains of a deceased veteran.

9 (2) RETROACTIVE APPLICATION.—Paragraph
 10 (1) shall apply with respect to a claim for reimburse-
 11 ment filed on or after October 1, 2006.

12 (c) GRANTS FOR OPERATION AND MAINTENANCE OF
 13 STATE VETERANS’ CEMETERIES.—

14 (1) IN GENERAL.—Subsection (a) of section
 15 2408 of such title is amended to read as follows:

16 “(a)(1) Subject to subsection (b), the Secretary may
 17 make grants to any State to assist the State in any of
 18 the following:

19 “(A) Establishing, expanding, or improving a
 20 veterans’ cemetery owned by the State.

21 “(B) Operating and maintaining such a ceme-
 22 tery.

23 “(2) Any such grant may be made only upon submis-
 24 sion of an application to the Secretary in such form and

1 manner, and containing such information, as the Sec-
 2 retary may require.”.

3 (2) LIMITATION ON AMOUNT AWARDED.—Sub-
 4 section (e) of such section is amended—

5 (A) by inserting “(1)” before “Amounts”;
 6 and

7 (B) by adding at the end the following new
 8 paragraph:

9 “(2) In any fiscal year, the aggregate amount of
 10 grants awarded under this section for the purposes speci-
 11 fied in subsection (a)(1)(B) may not exceed \$5,000,000.”.

12 (3) CONFORMING AMENDMENTS.—Such section
 13 is further amended—

14 (A) in subsection (b)—

15 (i) by striking “Grants under this sec-
 16 tion” and inserting “A grant under this
 17 section for the purposes described in sub-
 18 section (a)(1)(A)”;

19 (ii) by striking “a grant under this
 20 section” each place it appears and insert-
 21 ing “such a grant”; and

22 (B) in each of subsections (d)(1) and
 23 (f)(1), by inserting “, or in operating and main-
 24 taining a veterans’ cemetery,” after “veterans’
 25 cemetery”.

1 (4) REGULATIONS.—Not later than 180 days
2 after the date of the enactment of this Act, the Sec-
3 retary of Veterans Affairs shall prescribe regulations
4 to carry out the amendments made by this sub-
5 section.
