Mr. ENGEL introduced the following bill; which was referred to the Committee

A BILL

To repeal the prohibitions on United States assistance to
countries that are parties to the International Criminal
Court.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF PROHIBITION ON UNITED STATES**
4 **MILITARY ASSISTANCE TO PARTIES TO THE**
5 **INTERNATIONAL CRIMINAL COURT.**

6 (a) REPEAL.—Section 2007 of the American
7 Servicemembers' Protection Act of 2002 (title II of Public
8 Law 107–206; 22 U.S.C. 7426) is hereby repealed.

9 (b) EFFECTIVE DATE.—The repeal made by sub-
10 section (a) applies with respect to—

1 (1) funds made available for United States mili-
 2 tary assistance for fiscal year 2007 that are unobli-
 3 gated and unexpended as of the date of the enact-
 4 ment of this Act; and

5 (2) funds made available for United States mili-
 6 tary assistance for each subsequent fiscal year.

7 **SEC. 2. REPEALS OF LIMITATION ON ECONOMIC SUPPORT**
 8 **FUND ASSISTANCE TO PARTIES TO THE**
 9 **INTERNATIONAL CRIMINAL COURT.**

10 (a) FISCAL YEARS 2005 AND 2006.—

11 (1) REPEALS.—The following provisions of law
 12 are hereby repealed:

13 (A) Section 574 of the Foreign Operations,
 14 Export Financing, and Related Programs Ap-
 15 propriations Act, 2005 (division D of Public
 16 Law 108–447).

17 (B) Section 574 of the Foreign Operations,
 18 Export Financing, and Related Programs Ap-
 19 propriations Act, 2006 (Public Law 109–102).

20 (2) EFFECTIVE DATE.—The repeals made by
 21 subparagraphs (A) and (B) of paragraph (1) apply
 22 with respect to funds made available under the head-
 23 ing “Economic Support Fund” in title II of division
 24 D of Public Law 108–447 and in title II of Public
 25 Law 109–102, respectively, that are unobligated and

1 unexpended as of the date of the enactment of this
2 Act.

3 (b) FISCAL YEAR 2007.—Notwithstanding any provi-
4 sion of division B of the Continuing Appropriations Reso-
5 lution, 2007 (division B of Public Law 109–289, as
6 amended by Public Laws 109–369, 109–383, and 110–
7 5), section 574 of the Foreign Operations, Export Financ-
8 ing, and Related Programs Appropriations Act, 2006
9 (Public Law 109–102) shall not apply to funds made
10 available under division B of Public Law 109–289 that
11 are unobligated and unexpended as of the date of the en-
12 actment of this Act.
