A BILL

To amend the Elementary and Secondary Education Act of 1965 to establish an accurate and reliable graduation rate for measuring student academic achievement.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Reliable and Accurate
- 5 Graduation Rate Act".

1	SEC. 2. CREATING A RELIABLE AND ACCURATE GRADUA-
2	TION RATE TO IMPROVE THE ACADEMIC
3	ACHIEVEMENT OF HIGH SCHOOL STUDENTS.
4	Section 1111 of the Elementary and Secondary Edu-
5	cation Act of 1965 (20 U.S.C. 6311) is amended—
6	(1) in subsection $(b)(2)$ —
7	(A) in subparagraph (C)(vi) by striking
8	"as the percentage of students who graduate
9	from secondary school with a regular diploma in
10	the standard number of years" and inserting
11	"in subparagraph (K)";
12	(B) by redesignating subparagraph (K) as
13	subparagraph (M); and
14	(C) by inserting after subparagraph (J)
15	the following:
16	"(K) Graduation rate.—
17	"(i) In general.—For the purpose
18	of this section, a State shall calculate its
19	graduation rate by dividing the number of
20	students in the school or local educational
21	agency who receive a regular diploma by
22	the number of first time ninth-grade stu-
23	dents who enrolled in the school or local
24	educational agency four years earlier, tak-
25	ing into account—

1 "(I) the movement of students
2 transferring into and out of the school
or local educational agency, docu-
4 mented through such evidence as a
5 transcript, over the four-year period;
6 and
7 "(II) the limited one time identi-
8 fication of recently arrived limited
9 English proficient students, students
with documented enrollment in a fully
11 articulated early college high school,
and children with disabilities who re-
quire a fifth year to receive a regular
high school diploma.
15 "(ii) Schools and local edu-
16 CATIONAL AGENCIES.—A State shall re-
17 quire local educational agencies and
schools in the State to calculate its gradua-
tion rate consistent with clause (i).
20 "(L) Additional completion measures
21 FOR HIGH SCHOOL STUDENTS IN ALTERNATIVE
22 SETTINGS.—A State may publish and report
additional completion measures for those stu-
dents who completed high school or some equiv-
alent measure in more than four years. Such

measures could include those students that 2 dropped out of high school and passed a Gen-3 eral Educational Development exam or transferred to an alternative school and successfully completed their education, or those children with disabilities who completed their edu-6 cational program in more than five years.". 7
