## A BILL

To amend title 38, United States Code, to extend the time limitation for the use of entitlement to educational assistance under the Montgomery GI Bill for certain persons actively pursuing a qualifying educational degree or certificate.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Montgomery GI Bill
- 5 Degree Extension Act of 2007".

1	SEC. 2. EXTENSION OF TIME LIMITATION FOR USE OF ENTI-
2	TLEMENT TO EDUCATIONAL ASSISTANCE
3	UNDER MONTGOMERY GI BILL.
4	(a) Extension of Limitation Period.—Section
5	3031 of title 38, United States Code, is amended—
6	(1) by redesignating subsection (h) as sub-
7	section (i);
8	(2) by inserting after subsection (g) the fol-
9	lowing new subsection (h):
10	``(h)(1) In the case of an individual eligible for edu-
11	cational assistance under this chapter who has completed
12	at least 50 percent of the credit or time requirements lead-
13	ing to a degree or certificate before the last day of the
14	10-year period prescribed in subsection (a), the period
15	during which the individual may use the individual's enti-
16	tlement shall terminate on the earlier of the following
17	dates:
18	"(A) The date on which the individual com-
19	pletes all of the credit or time requirements leading
20	to the degree or certificate.
21	"(B) The date that is two years after the last
22	day of the 10-year period prescribed in subsection
23	(a).
24	"(2) An individual described in paragraph (1) who
25	uses the individual's entitlement after the last day of the
26	10-year period prescribed in subsection (a) may only use

- 1 the individual's entitlement for the pursuit of a course that
- 2 leads to the degree or certificate referred to in that para-
- 3 graph.".
- 4 (b) Conforming Amendments.—Subsection (a) of
- 5 such section is amended—
- 6 (1) by striking "subsections (b) through (g)"
- 7 and inserting "subsections (b) through (h)"; and
- 8 (2) by striking "subsection (h)" and inserting
- 9 "subsection (i)".
- 10 (c) Effective Date and Applicability.—The
- 11 amendments made by subsections (a) and (b) shall apply
- 12 with respect to an individual whose entitlement to edu-
- 13 cational assistance under chapter 30 of title 38, United
- 14 States Code, has not expired as of the date of the enact-
- 15 ment of this Act under section 3031 of such title, as in
- 16 effect on the day before that date.
