## A BILL

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. IMPROVED DISTRIBUTION OF CONSTRUCTION
- 4 PAYMENTS.

1	Section 8007(a) of the Elementary and Sec-
2	ondary Education Act of 1965 (20 U.S.C. 7707(a))
3	is amended—
4	(1) in paragraph (1), by striking "40 percent"
5	and inserting "80 percent";
6	(2) in subparagraphs (A) and (B) of paragraph
7	(2), by striking "50 percent" each place it appears
8	and inserting "40 percent";
9	(3) in paragraph (2) by adding at the end the
10	following new subparagraphs:
11	"(C) The agency is eligible under section
12	8003(b)(2) or is receiving a basic support pay-
13	ment under circumstances described in section
14	8003(b)(2)(B)(ii).
15	"(D) The agency is eligible under section
16	8003(a)(2)(C)."; and
17	(4) by striking paragraph (3) and inserting the
18	following:
19	"(3) Amount of Payments.—The amount of
20	a payment to each local educational agency de-
21	scribed in this subsection for a fiscal year shall be—
22	"(A) not less than the greater of the
23	amount appropriated as provided under para-
24	graph (1) for such fiscal year: divided by—

1	"(i) the number of children deter-
2	mined under subparagraphs (B), (C), and
3	(D)(i) of section $8003(a)(1)$ who were in
4	average daily attendance for all local edu-
5	cational agencies described in paragraph
6	(2), including the number of children at-
7	tending a school facility described in sec-
8	tion 8008(a) if the Secretary does not pro-
9	vide assistance for the school facility under
10	that section for the fiscal year; multiplied
11	by
12	"(ii) the number of children deter-
13	mined for such agency;
14	"(B) not less than \$25,000, except that
15	this subparagraph shall not apply if the amount
16	available to carry out paragraph (1) for such
17	fiscal year is less than \$32,000,000; and
18	"(C) not more than \$3,000,000.".
19	SEC. 2. COMPETITIVE EMERGENCY AND MODERNIZATION
20	GRANTS.
21	Section 8007(b) of the Elementary and Secondary
22	Education Act of 1965 (20 U.S.C. 7707(b)) is amended—
23	(1) in paragraph (1) by striking "60 percent"
24	and inserting "20 percent":

1	(2) in paragraph (3)(A) by inserting after "an
2	emergency grant under paragraph (2)(A)" the fol-
3	lowing: "if the agency is covered by paragraph (7),
4	or".
5	(3) in paragraph (3)(C)(i)(I) by striking "the
6	agency meets at least one" and all that follows, and
7	inserting "the number of children determined under
8	section 8003(a)(1)(C) for the agency for the pre-
9	ceding school year constituted at least 40 percent of
10	the total student enrollment in the schools of the
11	agency during the preceding school year.";
12	(4) by striking paragraph (3)(D)(ii)(II) and in-
13	serting the following:
14	"(II) The number of children de-
15	termined under section 8003(a)(1)(C)
16	for the school for the preceding school
17	year constituted at least 40 percent of
18	the total student enrollment in the
19	school during the preceding school
20	year.";
21	(5) in paragraph (4)(C) by striking "(B), (C),
22	and (D)" and inserting "and (C)";
23	(6) by redesignating paragraph (7) as para-
24	graph (8): and

1	(7) by inserting after paragraph (6) the fol-
2	lowing:
3	"(7) Special Rule.—Notwithstanding para-
4	graph $(3)(C)(i)(I)$ and $(3)(D)(ii)(II)$ , a local edu-
5	cational agency is eligible to receive a grant under
6	this subsection not to exceed \$3,000,000 in any one
7	fiscal year if such agency—
8	"(A) was eligible to receive a payment
9	under section 8003 for the fiscal year prior to
10	the year for which the application is made; and
11	"(B) has had an overall increase in enroll-
12	ment—
13	"(i) during the period between the end
14	of the school year preceding the fiscal year
15	for which the application is made and the
16	beginning of the school year immediately
17	preceding that school year;
18	"(ii) of which not less than 250, or
19	not less than 10 percent (whichever is
20	lower), are children described in—
21	"(I) subparagraphs (A), (B), (C),
22	or (D) of section 8003(a)(1); or
23	"(II) subparagraphs (F) or (G)
24	of section 8003(a)(1), but only to the
25	extent such children are civilian de-

1	pendents of employees of the Depart-
2	ment of Defense; and
3	"(iii) that is the direct result of one or
4	more of the following:
5	"(I) Base realignment and clo-
6	sure or global rebasing, as determined
7	by the Secretary of Defense.
8	" $(II)$ Force structure changes or
9	force relocations.
10	"(III) An action initiated by the
11	Secretary of Interior or other federal
12	agency.".
