## A BILL

To redesignate the Dryden Flight Research Center as the Neil A. Armstrong Flight Research Center and the Western Aeronautical Test Range as the Hugh L. Dryden Aeronautical Test Range.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REDESIGNATION OF DRYDEN FLIGHT RE-**2 **SEARCH CENTER.**

3 (a) **REDESIGNATION.**—The National Aeronautics and  
4 Space Administration (NASA) Hugh L. Dryden Flight  
5 Research Center in Edwards, California, is redesignated  
6 as the “NASA Neil A. Armstrong Flight Research Cen-  
7 ter”.

8 (b) **REFERENCES.**—Any reference in a law, map, reg-  
9 ulation, document, paper, or other record of the United  
10 States to the flight research center referred to in sub-  
11 section (a) shall be deemed to be a reference to the  
12 “NASA Neil A. Armstrong Flight Research Center”.

13 **SEC. 2. REDESIGNATION OF WESTERN AERONAUTICAL**  
14 **TEST RANGE.**

15 (a) **REDESIGNATION.**—The National Aeronautics and  
16 Space Administration (NASA) Western Aeronautical Test  
17 Range in California is redesignated as the “NASA Hugh  
18 L. Dryden Aeronautical Test Range”.

19 (b) **REFERENCES.**—Any reference in a law, map, reg-  
20 ulation, document, paper, or other record of the United  
21 States to the test range referred to in subsection (a) shall  
22 be deemed to be a reference to the “NASA Hugh L. Dry-  
23 den Aeronautical Test Range”.
