AN ACT

To reauthorize and amend the Hydrographic Services Improvement Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Hydrographic Services
- 5 Improvement Act Amendments of 2008".
- 6 SEC. 2. DEFINITIONS.
- 7 Section 302 of the Hydrographic Services Improve-
- 8 ment Act of 1998 (33 U.S.C. 892) is amended—

1	(1) by amending paragraph (3) to read as fol-
2	lows:
3	"(3) Hydrographic data.—The term 'hydro-
4	graphic data' means information that—
5	"(A) is acquired through—
6	"(i) hydrographic, bathymetric, photo-
7	grammetric, lidar, radar, remote sensing,
8	or shoreline and other ocean- and coastal-
9	related surveying;
10	"(ii) geodetic, geospatial, or geo-
11	magnetic measurements;
12	"(iii) tide, water level, and current ob-
13	servations; or
14	"(iv) other methods; and
15	"(B) is used in providing hydrographic
16	services.";
17	(2) by amending paragraph (4)(A) to read as
18	follows:
19	"(A) the management, maintenance, inter-
20	pretation, certification, and dissemination of
21	bathymetric, hydrographic, shoreline, geodetic,
22	geospatial, geomagnetic, and tide, water level,
23	and current information, including the produc-
24	tion of nautical charts, nautical information

1	databases, and other products derived from hy-
2	drographic data;"; and
3	(3) by striking paragraph (5).
4	SEC. 3. FUNCTIONS OF THE ADMINISTRATOR.
5	Section 303 of the Hydrographic Services Improve-
6	ment Act of 1998 (33 U.S.C. 892a) is amended—
7	(1) in subsection (a)—
8	(A) by striking "the Act of 1947," and in-
9	serting "the Coast and Geodetic Survey Act (33
10	U.S.C. 883a et seq.)"; and
11	(B) in paragraph (1) by striking "data;"
12	and inserting "data and provide hydrographic
13	services;";
14	(2) in subsection (b)—
15	(A) by striking "the Act of 1947," and in-
16	serting "the Coast and Geodetic Survey Act (33
17	U.S.C. 883a et seq.)";
18	(B) in paragraph (3) by striking "title IX
19	of the Federal Property and Administrative
20	Services Act of 1949; and" and inserting "sub-
21	chapter VI of chapter 10 of title 40, United
22	States Code;";
23	(C) in paragraph (4) by striking the period
24	and inserting "; and"; and
25	(D) by adding at the end the following:

1	"(5) may create, support, and maintain a Joint
2	Hydrographic Institute."; and
3	(3) by striking subsection (c) and inserting the
4	following:
5	"(c) Acquisition of Hydrographic Data and
6	PROVIDE HYDROGRAPHIC SERVICES.—To the extent that
7	it does not detract from the promotion of safe and efficient
8	navigation, the Administrator may acquire hydrographic
9	data and provide hydrographic services to—
10	"(1) support the conservation and management
11	of coastal and ocean resources;
12	"(2) save and protect life and property;
13	"(3) support the resumption of commerce in re-
14	sponse to emergencies, natural disasters, and man-
15	made disasters; and
16	"(4) meet homeland security and maritime do-
17	main awareness needs, including carrying out mis-
18	sion assignments (as that term is defined in section
19	641 of the Post-Katrina Emergency Management
20	Reform Act of 2006 (6 U.S.C. 741).".
21	SEC. 4. HYDROGRAPHIC SERVICES REVIEW PANEL.
22	Section 305 of the Hydrographic Services Improve-
23	ment Act of 1998 (33 U.S.C. 892c) is amended—
24	(1) in subsection $(c)(1)(A)$ by striking "Direc-
25	tor" and inserting "Co-directors";

1	(2) in subsections $(c)(1)(C)$, $(c)(3)$, and (e) by
2	striking "Secretary" each place it appears and in-
3	serting "Administrator"; and
4	(3) by amending subsection (d) to read as fol-
5	lows:
6	"(d) Compensation.—Voting members of the panel
7	shall be reimbursed for actual and reasonable expenses,
8	including travel and per diem, incurred in the performance
9	of duties for the panel.".
10	SEC. 5. AUTHORIZATION OF APPROPRIATIONS.
11	Section 306 of the Hydrographic Services Improve-
12	ment Act of 1998 (33 U.S.C. 892d) is amended to read
13	as follows:
14	"SEC. 306. AUTHORIZATION OF APPROPRIATIONS.
15	"There are authorized to be appropriated to the Ad-
16	ministrator the following:
17	"(1) To carry out nautical mapping and chart-
18	ing functions under sections 303 and 304, except for
19	conducting hydrographic surveys—
20	"(A) \$55,000,000 for fiscal year 2009;
21	"(B) \$56,000,000 for fiscal year 2010;
22	"(C) $57,000,000$ for fiscal year 2011; and
23	"(D) \$58,000,000 for fiscal year 2012.

1	"(2) To contract for hydrographic surveys
2	under section 303(b)(1), including the leasing or
3	time chartering of vessels—
4	"(A) \$32,130,000 for fiscal year 2009;
5	"(B) \$32,760,000 for fiscal year 2010;
6	"(C) $$33,390,000$ for fiscal year 2011; and
7	"(D) $$34,020,000$ for fiscal year 2012.
8	"(3) To operate hydrographic survey vessels
9	owned by the United States and operated by the Ad-
10	ministration—
11	"(A) \$25,900,000 for fiscal year 2009;
12	"(B) $$26,400,000$ for fiscal year 2010;
13	"(C) $$26,900,000$ for fiscal year 2011; and
14	"(D) $$27,400,000$ for fiscal year 2012.
15	"(4) To carry out geodetic functions under this
16	title—
17	"(A) \$32,640,000 for fiscal year 2009;
18	"(B) $$32,280,000$ for fiscal year 2010;
19	"(C) $$33,920,000$ for fiscal year 2011; and
20	"(D) $$34,560,000$ for fiscal year 2012.
21	"(5) To carry out tide and current measure-
22	ment functions under this title—
23	"(A) \$27,000,000 for fiscal year 2009;
24	"(B) $$27,500,000$ for fiscal year 2010;
25	"(C) \$28.000.000 for fiscal year 2011; and

- 1 "(D) \$28,500,000 for fiscal year 2012.
- 2 "(6) To acquire a replacement hydrographic
- 3 survey vessel capable of staying at sea continuously
- 4 for at least 30 days \$75,000,000.".
- 5 SEC. 6. ADDITION OF SHORT TITLE TO EXISTING LAW.
- 6 The Act of August 6, 1947 (chapter 504; 33 U.S.C.
- 7 883a et seq.) is amended by adding at the end the fol-
- 8 lowing:
- 9 "SEC. 11. SHORT TITLE.
- 10 "This Act may be cited as the 'Coast and Geodetic
- 11 Survey Act'.".
