# A BILL

For the relief of Paul Ladd and Jennifer Ladd.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       **SECTION 1. PERMANENT RESIDENT STATUS FOR PAUL**  
4                   **LADD AND JENNIFER LADD.**

5       (a) IN GENERAL.—Notwithstanding subsections (a)  
6 and (b) of section 201 of the Immigration and Nationality  
7 Act, Paul Ladd and Jennifer Ladd shall each be eligible  
8 for issuance of an immigrant visa or for adjustment of  
9 status to that of an alien lawfully admitted for permanent  
10 residence upon filing an application for issuance of an im-  
11 migrant visa under section 204 of such Act or for adjust-  
12 ment of status to lawful permanent resident.

1       (b) ADJUSTMENT OF STATUS.—If Paul Ladd or Jen-  
2 nifer Ladd enters the United States before the filing dead-  
3 line specified in subsection (c), he or she shall be consid-  
4 ered to have entered and remained lawfully and shall, if  
5 otherwise eligible, be eligible for adjustment of status  
6 under section 245 of the Immigration and Nationality Act  
7 as of the date of the enactment of this Act.

8       (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
9 FEES.—Subsections (a) and (b) shall apply only if the ap-  
10 plication for issuance of an immigrant visa or the applica-  
11 tion for adjustment of status is filed with appropriate fees  
12 within 2 years after the date of the enactment of this Act.

13       (d) REDUCTION OF IMMIGRANT VISA NUMBER.—  
14 Upon the granting of an immigrant visa or permanent res-  
15 idence to Paul Ladd and Jennifer Ladd, the Secretary of  
16 State shall instruct the proper officer to reduce by 2, dur-  
17 ing the current or next following fiscal year, the total num-  
18 ber of immigrant visas that are made available to natives  
19 of the country of the aliens' birth under section 203(a)  
20 of the Immigration and Nationality Act or, if applicable,  
21 the total number of immigrant visas that are made avail-  
22 able to natives of the country of the aliens' birth under  
23 section 202(e) of such Act.

24       (e) DENIAL OF PREFERENTIAL IMMIGRATION  
25 TREATMENT FOR CERTAIN RELATIVES.—The natural

- 1 parents, brothers, and sisters of Paul Ladd and Jennifer
- 2 Ladd shall not, by virtue of such relationship, be accorded
- 3 any right, privilege, or status under the Immigration and
- 4 Nationality Act.
