## A BILL

To enhance the management and disposal of spent nuclear fuel and high-level radioactive waste and to ensure the expansion of clean nuclear power in the United States to reduce greenhouse gas emissions and enhance our domestic energy security.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Renewing Our Com-
- 5 mitment to Safe and Clean Power Act".
- 6 SEC. 2. DEFINITIONS.
- 7 For purposes of this Act:

- 1 (1) "Commission";
- 2 (2) "disposal";
- 3 (3) "high-level radioactive waste";
- 4 (4) "repository";
- 5 (5) "Secretary"; and
- 6 (6) "spent nuclear fuel"
- 7 have the meaning given those terms in section 2 of the
- 8 Nuclear Waste Policy Act of 1982 (42 U.S.C. 10101).

#### 9 SEC. 3. NUCLEAR WASTEFUND.

- 10 (a) Crediting Fees.—Beginning on October 1,
- 11 2007, and continuing through the end of the fiscal year
- 12 when construction is complete for surface facilities for the
- 13 fully operational repository as described in the license ap-
- 14 plication and for the Nevada rail line, fees collected by
- 15 the Secretary and deposited in the Nuclear Waste Fund
- 16 under the Nuclear Waste Policy Act of 1982 (42 U.S.C.
- 17 10101 et seq.) shall be credited to the Nuclear Waste
- 18 Fund as discretionary offsetting collections each year in
- 19 amounts not to exceed the amounts appropriated from the
- 20 Nuclear Waste Fund for that year.
- 21 (b) Fund Uses.—Section 302(d)(4) of the Nuclear
- 22 Waste Policy Act of 1982 (42 U.S.C. 10222(d)(4)) is
- 23 amended by inserting "infrastructure activities that the
- 24 Secretary deems are necessary or appropriate to support
- 25 construction or operation of a repository at the Yucca

- 1 Mountain site or transportation to such site of spent nu-
- 2 clear fuel and high-level radioactive waste, and" after
- 3 "with".

### 4 SEC. 4. WASTE CONFIDENCE.

- 5 Notwithstanding any other law, in deciding whether
- 6 to permit the construction or operation of a nuclear reac-
- 7 tor or any related facilities, the Commission shall deem,
- 8 without further consideration, that sufficient capacity will
- 9 be available in a timely manner to dispose of the spent
- 10 nuclear fuel and high-level radioactive waste resulting
- 11 from the operation of the reactor and any related facilities.
