## A BILL

To require the distribution by the National Technical Information Service of monthly updates of the Death Master List prepared by the Social Security Administration to all nationwide consumer reporting agencies, to require such consumer reporting agencies to maintain a permanent fraud alert in each file of a consumer whose name appears on the Death Master List, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Identity Theft Preven-  
3 tion and Timely Reporting Act of 2007”.

4 **SEC. 2. DISTRIBUTION OF DEATH MASTER LIST TO CON-  
5 SUMER REPORTING AGENCIES.**

6 The National Technical Information Service of the  
7 Department of Commerce shall provide monthly updates  
8 of the Death Master List prepared by the Social Security  
9 Administration to each consumer reporting agency de-  
10 scribed in section 603(p) of the Fair Credit Reporting Act.

11 **SEC. 3. FRAUD ALERTS REQUIRED FOR FILES OF CON-  
12 SUMERS WHOSE NAMES APPEAR ON THE  
13 DEATH MASTER LIST.**

14 Section 605A(b) of the Fair Credit Reporting Act (15  
15 U.S.C. 1681c-1(b)) is amended by adding at the end the  
16 following new paragraph:

17 “(3) INCLUSION OF EXTENDED ALERT IN FILES  
18 WHOSE NAMES APPEAR ON THE DEATH MASTER  
19 LIST.—

20 “(A) IN GENERAL.—Each consumer re-  
21 porting agency described in section 603(p) shall  
22 include a fraud alert under this subsection in  
23 the consumer file of each consumer whose name  
24 appears on the Death Master List prepared by  
25 the Social Security Administration for so long  
26 as the agency continues to maintain such file.

1                   “(B) PROMPT ACTION.—Each consumer  
2                   reporting agency described in section 603(p)  
3                   shall take the action required under paragraph  
4                   (1) as soon as possible after receiving a month-  
5                   ly update of the Death Master List from the  
6                   National Technical Information Service in ac-  
7                   cordance with section 2 of the Consumer Fraud  
8                   Prevention Act.”.
