## A BILL

To amend title XVIII of the Social Security Act to provide for Medicare coverage of services of qualified respiratory therapists performed under the general supervision of a physician.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Respiratory
- 5 Therapy Initiative Act of 2007".

1	SEC. 2. MEDICARE COVERAGE OF SERVICES OF QUALIFIED
2	RESPIRATORY THERAPISTS PERFORMED
3	UNDER THE GENERAL SUPERVISION OF A
4	PHYSICIAN.
5	(a) In General.—Section 1861 of the Social Secu-
6	rity Act (42 U.S.C. 1395x) is amended—
7	(1) in subsection $(s)(2)$ —
8	(A) by striking "and" at the end of sub-
9	paragraph (Z);
10	(B) by adding "and" at the end of sub-
11	paragraph (AA); and
12	(C) by adding at the end the following new
13	subparagraph:
14	"(BB) respiratory therapy services which would
15	be physicians' services if furnished by a physician
16	(as defined in subsection $(r)(1)$ ) for the diagnosis
17	and treatment of respiratory illnesses and which are
18	performed by a respiratory therapist (as defined in
19	subsection (ccc)) under the general supervision of a
20	physician and which the respiratory therapist is le-
21	gally authorized to perform by the State in which
22	the services are performed, but only if no facility or
23	other provider charges or is paid any amounts with
24	respect to the furnishing of such services."; and
25	(2) by adding at the end the following new sub-
26	section:

1	"Respiratory Therapist"
2	"(ccc) For purposes of subsection $(s)(2)(BB)$ and
3	section $1833(a)(1)(W)$ only, the term 'respiratory thera-
4	pist' means an individual who—
5	"(1) is credentialed by a national credentialing
6	board recognized by the Secretary;
7	"(2)(A) is licensed to practice respiratory ther-
8	apy in the State in which the respiratory therapy
9	services are performed, or (B) in the case of an indi-
10	vidual in a State which does not provide for such li-
11	censure, is legally authorized to perform respiratory
12	therapy services (in the State in which the individual
13	performed such services) under State law (or the
14	State regulatory mechanism provided by State law);
15	"(3) is a registered respiratory therapist; and
16	"(4) holds a bachelor's degree.".
17	(b) Payment.—Section 1833(a)(1) of such Act (42
18	U.S.C. 1395l(a)(1)) is amended—
19	(1) by striking "and" before "(V)"; and
20	(2) by inserting before the semicolon at the end
21	the following: "(W) with respect to services de-
22	scribed in section $1861(s)(2)(BB)$ (relating to serv-
23	ices furnished by a respiratory therapist) that are
24	furnished by a respiratory therapist (as defined in
25	section 1861(ccc)), the amount paid shall be equal

- 1 to 80 percent of the lesser of the actual charge for
- 2 the services or 85 percent of the fee schedule
- 3 amount provided under section 1848 for the same
- 4 services if furnished by a physician".
- 5 (c) Effective Date.—The amendments made by
- 6 this section shall apply to services furnished on or after

7 January 1, 2008.
