AN ACT

To direct the Attorney General to provide grants for Internet
crime prevention education programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. GRANTS FOR INTERNET CRIME PREVENTION**
2 **EDUCATION PROGRAMS.**

3 (a) GRANT FOR I-SAFE.—

4 (1) GRANT.—Subject to the availability of the
5 funds authorized to be appropriated under para-
6 graph (2), the Attorney General shall provide a
7 grant to i-Safe, Inc., to carry out Internet crime pre-
8 vention education programs.

9 (2) AUTHORIZATION OF APPROPRIATIONS.—

10 There is authorized to be appropriated \$5,000,000
11 for grants under paragraph (1) for each of the fiscal
12 years 2008 through 2012.

13 (b) COMPETITIVE GRANT PROGRAM.—

14 (1) ESTABLISHMENT.—Subject to the avail-
15 ability of the funds authorized to be appropriated
16 under paragraph (2), the Attorney General shall cre-
17 ate and administer a competitive grants program for
18 organizations to carry out Internet crime prevention
19 education programs.

20 (2) AUTHORIZATION OF APPROPRIATIONS.—

21 There is authorized to be appropriated \$5,000,000
22 for grants under paragraph (1) for each of the fiscal
23 years 2008 through 2012.

1 **SEC. 2. INTERNET CRIME PREVENTION EDUCATION PRO-**
2 **GRAMS DEFINED.**

3 (a) IN GENERAL.—The term “Internet crime preven-
4 tion education programs” means programs that serve to
5 educate parents, children, educators, and communities
6 about how to recognize and prevent potentially criminal
7 activity on the Internet.

8 (b) RELATED DEFINITIONS.—

9 (1) POTENTIALLY CRIMINAL ACTIVITY.—The
10 term “potentially criminal activity” includes access
11 through the Internet and other electronic devices to
12 potentially illegal activity including sexual or racial
13 harassment, cyberbullying, sexual exploitation, expo-
14 sure to pornography, and privacy violations.

15 (2) CYBERBULLYING.—The term
16 “cyberbullying” includes verbal, visual, or written
17 psychological bullying or harassment by an indi-
18 vidual or group, using an electronic device or devices
19 including e-mail, instant messaging, text messages,
20 blogs, telephones, pagers, and websites, to support
21 deliberate, repeated, and hostile behavior that is in-
22 tended to harm others.
