## A BILL

To enhance national security by restricting access of illegal aliens to driver’s licenses and State-issued identification documents.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act shall be cited as the “Prevention of Unsafe  
 5       Licensing Act”.

6       **SEC. 2. FINDINGS.**

7       The Congress makes the following findings:

8               (1) The ability of illegal aliens and terrorists to  
 9       acquire driver’s licenses or identification cards poses  
 10      a threat to national security.

11              (2) Issuing driver’s licenses or other forms of  
 12      documentation to individuals who are illegally

1 present in the United States will enable illegal  
2 aliens, and possibly terrorists, to open bank ac-  
3 counts, transfer money out of the country, purchase  
4 weapons, and commit voter fraud.

5 (3) The 9/11 terrorists obtained dozens of driv-  
6 er's licenses from States with weak licensing laws.  
7 The 9/11 hijackers also acquired a total of 28 State-  
8 issued identification cards or driver's licenses.

9 (4) An illegal alien, whose presence in the  
10 United States proves blatant disregard of Federal  
11 law, should not be rewarded by having his or her  
12 presence in the United States supported by receiving  
13 legitimate government-issued identification.

14 (5) Congress passed the REAL ID Act of 2005  
15 (division B of Public Law 109–13) to enhance secu-  
16 rity of State-issued driver's licenses and other identi-  
17 fication documents to prevent potential terrorists  
18 from obtaining identification documents in order to  
19 remain and operate in the United States.

20 (6) Recent actions by some States have dem-  
21 onstrated a willingness to exploit loopholes in the  
22 law to provide driver's licenses to illegal aliens re-  
23 gardless of the security concerns.

24 (7) A driver's license is a desired document; it  
25 enables an individual to travel and live in the United

1 States and may facilitate acquiring other documents  
2 and services.

3 (8) Illegal aliens may use a driver's license to  
4 register and vote in Federal, State, and local elec-  
5 tions.

6 (9) Allowing illegal immigrants to have access  
7 to driver's licenses could hinder an employer's ability  
8 to check identification and verify legal status and  
9 work authorization.

10 (10) Federal Courts have repeatedly found that  
11 the Congress has plenary power to regulate immi-  
12 gration, including conditions on admissibility, pres-  
13 ence, and removal of aliens.

14 **SEC. 3. PROHIBITION ON ISSUING DRIVER'S LICENSES TO**  
15 **ILLEGAL ALIENS.**

16 Section 202 of the REAL ID Act of 2005 (49 U.S.C.  
17 30301 note) is amended—

18 (1) in subsection (d), by striking paragraph  
19 (11) and redesignating paragraphs (12) and (13) as  
20 paragraphs (11) and (12), respectively; and

21 (2) by adding at the end the following:

22 “(e) PROHIBITION.—A State is prohibited from  
23 issuing any driver's license or identification card to any

1 individual unless the State satisfies the requirements of  
2 subsection (c)(2)(B).”.
