AN ACT

To amend the Dayton Aviation Heritage Preservation Act of 1992 to add sites to the Dayton Aviation Heritage National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **TITLE I—ADDITIONAL AREAS IN-**
2 **CLUDED IN DAYTON AVIA-**
3 **TION HERITAGE NATIONAL**
4 **HISTORICAL PARK**

5 **SEC. 101. ADDITIONAL AREAS INCLUDED IN PARK.**

6 Section 101 of the Dayton Aviation Heritage Preser-
7 vation Act of 1992 (16 U.S.C. 410ww, et seq.) is amended
8 by adding at the end the following:

9 “(c) **ADDITIONAL SITES.**—In addition to the sites de-
10 scribed in subsection (b), the park shall consist of the fol-
11 lowing sites, as generally depicted on a map titled ‘Dayton
12 Aviation Heritage National Historical Park’, numbered
13 362/80,013 and dated May 2008:

14 “(1) Hawthorn Hill, Oakwood, Ohio.

15 “(2) The Wright Company factory and associ-
16 ated land and buildings, Dayton, Ohio.”.

17 **SEC. 102. PROTECTION OF HISTORIC PROPERTIES.**

18 Section 102 of the Dayton Aviation Heritage Preser-
19 vation Act of 1992 (16 U.S.C. 410ww-1) is amended—

20 (1) in subsection (a), by inserting “Hawthorn
21 Hill, the Wright Company factory,” after “, ac-
22 quire”;

23 (2) in subsection (b), by striking “Such agree-
24 ments” and inserting:

1 “(d) CONDITIONS.—Cooperative agreements under
2 this section”;

3 (3) by inserting before subsection (d) (as added
4 by paragraph 2) the following:

5 “(c) COOPERATIVE AGREEMENTS.—The Secretary is
6 authorized to enter into a cooperative agreement with a
7 partner or partners, including the Wright Family Founda-
8 tion, to operate and provide programming for Hawthorn
9 Hill and charge reasonable fees notwithstanding any other
10 provision of law, which may be used to defray the costs
11 of park operation and programming.”; and

12 (4) by striking “Commission” and inserting
13 “Aviation Heritage Foundation”.

14 **TITLE II—WRIGHT BROTHERS-**
15 **DUNBAR NATIONAL HISTOR-**
16 **ICAL PARK DESIGNATION**

17 **SEC. 201. REDESIGNATION OF DAYTON AVIATION HERIT-**
18 **AGE NATIONAL HISTORICAL PARK.**

19 (a) REDESIGNATION.—The Dayton Aviation Herit-
20 age Preservation Act of 1992, is amended—

21 (1) by striking “Dayton Aviation Heritage Na-
22 tional Historical Park” each place it appears and in-
23 serting “Wright Brothers-Dunbar National Histor-
24 ical Park”;

1 (2) by redesignating subsection (b) of section
2 108 as subsection (e); and

3 (3) by inserting after subsection (a) of section
4 108 the following new subsection:

5 “(b) GRANT ASSISTANCE.—The Secretary is author-
6 ized to make grants to the parks’ partners, including the
7 Aviation Trail, Inc., the Ohio Historical Society, and Day-
8 ton History, for projects not requiring Federal involve-
9 ment other than providing financial assistance, subject to
10 the availability of appropriations in advance identifying
11 the specific partner grantee and the specific project.
12 Projects funded through these grants shall be limited to
13 construction and development on non-Federal property
14 within the boundaries of the park. Any project funded by
15 such a grant shall support the purposes of the park, shall
16 be consistent with the park’s general management plan,
17 and shall enhance public use and enjoyment of the park.”.

18 (b) REFERENCES.—Any reference in any law (other
19 than this title), map, regulation, document, record, or
20 other official paper of the United States to the “Dayton
21 Aviation Heritage National Historical Park” shall be con-
22 sidered to be a reference to the “Wright Brothers-Dunbar
23 National Historical Park”.

1 **SEC. 202. NATIONAL AVIATION HERITAGE AREA.**

2 Title V of division J of the Consolidated Appropria-
3 tions Act, 2005 (16 U.S.C. 461 note; Public Law 108-
4 447), is amended—

5 (1) in section 503(3), by striking “104” and in-
6 serting “504”;

7 (2) in section 503(4), by striking “106” and in-
8 serting “506”;

9 (3) in section 504, by striking subsection (b)(2)
10 and by redesignating subsection (b)(3) as subsection
11 (b)(2); and

12 (4) in section 505(b)(1), by striking “106” and
13 inserting “506”.
