## A BILL

To amend the Elementary and Secondary Education Act of 1965 to ensure that the Impact Aid program of the Department of Education guarantees that each eligible local educational agency receives at least the same percentage of the maximum payment under current formulas as the percentage of its land owned by the Federal Government.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EACH ELIGIBLE LOCAL EDUCATIONAL AGENCY**  
2 **TO RECEIVE AT LEAST SAME PERCENTAGE**  
3 **OF THE MAXIMUM PAYMENT AS THE PER-**  
4 **CENTAGE OF LAND OWNED BY THE FEDERAL**  
5 **GOVERNMENT.**

6 (a) PAYMENTS FOR FEDERAL ACQUISITION OF REAL  
7 PROPERTY.—Section 8002 of the Elementary and Sec-  
8 ondary Education Act of 1965 (20 U.S.C. 7702) is amend-  
9 ed by adding at the end the following:

10 “(o) ENTITLEMENT TO PERCENTAGE OF MAX-  
11 IMUM.—Notwithstanding any other provision of this title,  
12 the Secretary shall, each fiscal year, for each eligible local  
13 educational agency, do the following:

14 “(1) Identify—

15 “(A) the amount that the local educational  
16 agency is to receive under the other provisions  
17 of this section; and

18 “(B) the amount determined by multi-  
19 plying—

20 “(i) the maximum amount that the  
21 local educational agency is eligible to re-  
22 ceive under the other provisions of this sec-  
23 tion; and

24 “(ii) the percentage of land of the  
25 local educational agency that is Federal  
26 property eligible under this section.

1           “(2) If the amount under paragraph (1)(A) is  
2           less than the amount under paragraph (1)(B), trans-  
3           fer, from amounts available to the Secretary for  
4           other purposes, funds sufficient to make up the dif-  
5           ference, and add those funds to the amount paid to  
6           the local educational agency under this section.”.

7           (b) BASIC PAYMENTS; PAYMENTS FOR HEAVILY IM-  
8           PACTED LOCAL EDUCATIONAL AGENCIES.—Section 8003  
9           of that Act (20 U.S.C.7703) is amended by adding at the  
10          end the following:

11          “(h) ENTITLEMENT TO PERCENTAGE OF MAX-  
12          IMUM.—Notwithstanding any other provision of this title,  
13          the Secretary shall, each fiscal year, for each eligible local  
14          educational agency, do the following:

15               “(1) Identify—

16                   “(A) the amount that the local educational  
17                   agency is to receive under subsection (b); and

18                   “(B) the amount determined by multi-  
19                   plying—

20                       “(i) the maximum amount that the  
21                       local educational agency is eligible to re-  
22                       ceive under subsection (b); and

23                       “(ii) the percentage of land of the  
24                       local educational agency that is Federal  
25                       property eligible under section 8002.

1           “(2) If the amount under paragraph (1)(A) is  
2           less than the amount under paragraph (1)(B), trans-  
3           fer, from amounts available to the Secretary for  
4           other purposes, funds sufficient to make up the dif-  
5           ference, and add those funds to the amount paid to  
6           the local educational agency under subsection (b).”.
