Mr. AL GREEN of Texas introduced the following bill; which was referred to the Committee on Education and Labor

A BILL

To amend the Fair Labor Standards Act to provide for the calculation of the minimum wage based on the Federal poverty threshold for a family of 3, as determined by the Census Bureau.

1 *Be it enacted by the Senate and House of Representa-*

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Living American Wage

5 (LAW) Act of 2007”.

6 **SEC. 2. FINDINGS; SENSE OF CONGRESS.**

7 (a) FINDINGS.—Congress finds the following:

12 (4) Two full-time workers earning the Federal
13 minimum wage earn an income below the national
14 housing wage, the amount a person needs to earn to
15 afford a 2-bedroom apartment at average rent.

16 (b) SENSE OF CONGRESS.—It is the sense of Con-
17 gress that—

24 (2) the minimum wage should be set at a level
25 high enough to allow 2 full-time minimum wage

1 workers to earn an income above the national hous-
2 ing wage; and

3 (3) Congress or any of the several States may
4 establish a higher minimum wage requirement than
5 that established in this Act.

6 **SEC. 3. MINIMUM WAGE.**

7 Section 6 of the Fair Labor Standards Act of 1938
8 is amended—

9 (1) by amending subsection (a)(1) to read as
10 follows:

11 “(1) except as otherwise provided in this sec-
12 tion—

13 “(A) \$5.85 an hour beginning July 24,
14 2007;

15 “(B) not less than \$6.55 an hour begin-
16 ning July 24, 2008;

17 “(C) not less than \$7.25 an hour begin-
18 ning July 24, 2009; and

19 “(D) not less than the amount determined
20 by the Secretary under subsection (b) beginning
21 September 1, 2008;”; and

22 (2) by redesignating subsection (b) as sub-
23 section (c) and inserting after subsection (a) the fol-
24 lowing:

1 “(b)(1) Not later than June 1, 2008, and once every
2 4 years thereafter, the Secretary shall determine the min-
3 imum wage rate applicable under subsection (a)(1) based
4 on the formula described in paragraph (2). The Secretary
5 shall publish such wage rate in the Federal Register not
6 later than October 1 of each year. If such determination
7 results in a lower minimum wage than that then in effect,
8 the Secretary shall not adjust the minimum wage then in
9 effect pursuant to this subsection.

10 “(2) The minimum wage rate determined by the Sec-
11 retary under paragraph (1) shall be the minimum hourly
12 wage sufficient for a person working for such wage 40
13 hours per week, 52 weeks per year, to earn an annual in-
14 come in an amount that is 5 percent higher than the Fed-
15 eral poverty threshold for a 3-person household, with one
16 person a child under age 18, and living in the 48 contig-
17 uous States, as published for each such year by the Census
18 Bureau.”.
