## AN ACT

To amend the Palo Alto Battlefield National Historic Site Act of 1991 to expand the boundaries of the historic site, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Palo Alto Battlefield
- 3 National Historical Park Boundary Expansion and Redes-
- 4 ignation Act of 2008".
- 5 SEC. 2. DESIGNATION OF PALO ALTO BATTLEFIELD NA-
- 6 TIONAL HISTORICAL PARK.
- 7 (a) IN GENERAL.—The Palo Alto Battlefield Na-
- 8 tional Historic Site is hereby designated the "Palo Alto
- 9 Battlefield National Historical Park".
- 10 (b) References.—Any reference in a law, map, reg-
- 11 ulation, document, paper or other record of the United
- 12 States to Palo Alto Battlefield National Historic Site is
- 13 deemed to be a reference to the Palo Alto Battlefield Na-
- 14 tional Historical Park.
- 15 (c) Conforming Amendments.—The Palo Alto
- 16 Battlefield National Historic Site Act of 1991 (Public Law
- 17 102–304; 106 Stat. 256; 16 U.S.C. 461) is amended—
- 18 (1) by striking "National Historic Site" each
- 19 place it appears and inserting "National Historical
- 20 Park";
- 21 (2) in the heading for section 3, by striking
- 22 "NATIONAL HISTORIC SITE" and inserting "NA-
- 23 TIONAL HISTORICAL PARK"; and
- 24 (3) by striking "historic site" each place it ap-
- pears and inserting "historical park".

### 1 SEC. 3. BOUNDARY EXPANSION.

- 2 Section 3(b) of the Palo Alto Battlefield National
- 3 Historic Site Act of 1991 (Public Law 102–304; 106 Stat.
- 4 256; 16 U.S.C. 461) is amended—
- 5 (1) by redesignating paragraph (2) as para-
- 6 graph (3);
- 7 (2) by inserting after paragraph (1) the fol-
- 8 lowing new paragraph:
- 9 "(2) The historical park also shall consist of approxi-
- 10 mately 34 acres as generally depicted on the map entitled
- 11 'Palo Alto Battlefield NHS Proposed Boundary Expan-
- 12 sion', numbered 469/80,012, and dated May 21, 2008.
- 13 The map shall be on file and available for public inspection
- 14 in the appropriate offices of the National Park Service.";
- 15 and
- 16 (3) in paragraph (3), as so redesignated, by
- striking "map referred to in paragraph (1)" and in-
- serting "maps referred to in paragraphs (1) and
- 19 (2)".
