A BILL

To require a study of the feasibility of establishing the John Lewis Civil Rights Trail System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "John Lewis Civil
- 5 Rights Trail System Act".
- 6 SEC. 2. FEASIBILITY STUDY.
- 7 (a) STUDY.—The Archivist of the United States, in
- 8 consultation with the Secretary of the Interior, and with
- 9 the Secretary of Agriculture with respect to lands adminis-
- 10 tered by such Secretary, shall conduct a study of the feasi-

- 1 bility of establishing the John Lewis Civil Rights Trail
- 2 System, as described in subsection (b), in substantially the
- 3 same manner as studies performed by the Secretary of the
- 4 Interior under section 5(b) of the National Trails System
- 5 Act (Public Law 109–418).
- 6 (b) Description of John Lewis Civil Rights
- 7 TRAIL SYSTEM.—For purposes of this section, the John
- 8 Lewis Civil Rights Trail System is a system of trails mark-
- 9 ing the geographic locations in the United States (includ-
- 10 ing its territories) of historically significant events related
- 11 to struggles for civil rights based on racial equality, includ-
- 12 ing signage or printed materials (or both) that provide in-
- 13 formation about the people and events involved in such
- 14 struggles and associated with such location.

15 SEC. 3. PILOT PROGRAM.

- 16 (a) IN GENERAL.—The Secretary of the Interior shall
- 17 establish and maintain individual trails marking the geo-
- 18 graphic locations of historically significant events related
- 19 to struggles for civil rights based on racial equality. The
- 20 Secretary shall provide for each trail signage or printed
- 21 materials (or both) that provide information about the
- 22 people and events involved in such struggles and associ-
- 23 ated with such locations.
- 24 (b) Location.—The Secretary may establish such a
- 25 trail in each State where a significant civil rights event

- 1 occurred. The Secretary shall establish at least 6 such
- 2 trails as soon as practicable after the date of enactment
- 3 of this Act.
- 4 (c) Authorization of Appropriations.—To carry
- 5 out this section there are authorized to be appropriated
- 6 to the Secretary of the Interior such sums as are necessary
- 7 for fiscal years 2009 through 2015.
