Mr. INGLIS of South Carolina introduced the following bill; which was referred
to the Committee on Ways and Means

A BILL

To liquidate or reliquidate certain entries of truck tires.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LIQUIDATION OR RELIQUIDATION OF CERTAIN**
4 **ENTRIES OF TRUCK TIRES.**

5 (a) LIQUIDATION OR RELIQUIDATION REQUIRED.—
6 Notwithstanding sections 514 and 520 of the Tariff Act
7 of 1930 (19 U.S.C. 1514 and 1520), or any other provi-
8 sion of law, U.S. Customs and Border Protection shall,
9 not later than 180 days after the date of the enactment
10 of this Act—

11 (1) liquidate or reliquidate as free of duty each
12 entry described in subsection (b) containing any

1 merchandise which, at the time of original liquida-
 2 tion, was merchandise eligible for duty-free treat-
 3 ment under title V of the Trade Act of 1974 (19
 4 U.S.C. 2461 et seq.); and

5 (2) refund any duties and interest paid on such
 6 entries.
