A BILL

- To direct the Commandant of the Coast Guard to issue regulations requiring pilots of certain vessels to carry and utilize a portable electronic device equipped for navigational purposes, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Vessel Navigation and
 - 5 Safety Improvement Act".

1	SEC. 2. REQUIREMENT FOR PILOTS TO CARRY AND UTILIZE
2	PORTABLE ELECTRONIC NAVIGATIONAL DE-
3	VICE.
4	(a) IN GENERAL.—The Commandant of the Coast
5	Guard shall issue regulations that—
6	(1) require that any pilot licensed under sub-
7	title II of title 46, United States Code, while serving
8	under the authority of that license as a pilot on a
9	covered vessel, shall carry and utilize a portable elec-
10	tronic device that is—
11	(A) equipped for navigational purposes;
12	and
13	(B) capable of being connected to an Auto-
14	matic Identification System, in accordance with
15	the International Convention for the Safety of
16	Life at Sea, Chapter V, Regulation 19.2; and
17	(2) require such pilots to obtain training in the
18	use of such electronic devices, and prescribe require-
19	ments for such training.
20	(b) Deadlines for Compliance.—The regulations
21	shall require such pilots to—
22	(1) carry and utilize electronic devices pursuant
23	to subsection (a)(1) by no later than 18 months
24	after the date of enactment of this Act; and

- 1 (2) begin training pursuant to subsection (a)(2)
- 2 by no later than 12 months after the date of the en-
- actment of this Act.
- 4 (c) Exemptions.—The Commandant may exempt a
- 5 pilot from the requirement under subsection (a)(1) if the
- 6 Commandant certifies that a portable electronic device is
- 7 not necessary for the safe navigation of a covered vessel
- 8 on the waters where the pilot operates.
- 9 (d) COVERED VESSEL DEFINED.—In this section the
- 10 term "covered vessel" means a self-propelled, commercial
- 11 vessel of 300 gross tons or more.
