A BILL

To ensure Pell Grant eligibility for any student whose parent or guardian died as a result of performing military service in Iraq or Afghanistan after September 11, 2001.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Children of Fallen Sol-
5 diers Pell Grant Act of 2007”.

1 **SEC. 2. CALCULATION OF FEDERAL PELL GRANT ELIGI-**
2 **BILITY.**

3 Section 401(f) of the Higher Education Act of 1965
4 (20 U.S.C. 1070a(f)) is amended by adding at the end
5 the following new paragraph:

6 “(4)(A) Notwithstanding paragraph (1) or any
7 other provision of this section, the expected family
8 contribution of each student described in subpara-
9 graph (B) shall be deemed to be zero for the period
10 during which each such student is eligible to receive
11 a Federal Pell Grant under subsection (c).

12 “(B) Subparagraph (A) shall apply to any stu-
13 dent at an institution of higher education—

14 “(i) whose parent or guardian was a mem-
15 ber of the Armed Forces of the United States
16 who died as a result of performing military
17 service in Iraq or Afghanistan after September
18 11, 2001; and

19 “(ii) who was 18 years or less, or was en-
20 rolled as a full-time or part-time student at an
21 institution of higher education, as of the time
22 of the parent or guardian’s death.”.

23 **SEC. 3. EFFECTIVE DATE.**

24 The amendment made by section 2 of this Act shall
25 apply with respect to Federal Pell Grants awarded for aca-

1 demic year 2008–2009, and each succeeding academic
2 year.
