A BILL

To amend title 10, United States Code, to reduce the minimum age for receipt of military retired pay for non-regular service from 60 to 55.

SECTION 1. REDUCTION IN MINIMUM AGE FOR RECEIPT OF

- 2 MILITARY RETIRED PAY FOR NON-REGULAR
- 3 SERVICE.
- 4 (a) REDUCTION IN AGE.—Section 12731(a)(1) of
- 5 title 10, United States Code, is amended by striking "at
- 6 least 60 years of age" and inserting "at least 55 years
- 7 of age".
- 8 (b) Application to Existing Provisions of Law
- 9 OR POLICY.—With respect to any provision of law, or of
- 10 any policy, regulation, or directive of the executive branch,
- 11 that refers to a member or former member of the uni-
- 12 formed services as being eligible for, or entitled to, retired
- 13 pay under chapter 1223 of title 10, United States Code,
- 14 but for the fact that the member or former member is
- 15 under 60 years of age, such provision shall be carried out
- 16 with respect to that member or former member by sub-
- 17 stituting for the reference to being 60 years of age a ref-
- 18 erence to the age in effect for qualification for such retired
- 19 pay under section 12731(a) of title 10, United States
- 20 Code, as amended by subsection (a).
- 21 (c) Effective Date.—The amendment made by
- 22 subsection (a) shall take effect on the first day of the first
- 23 month beginning on or after the date of the enactment
- 24 of this Act and shall apply to retired pay payable for that
- 25 month and subsequent months.
