## RESOLUTION

Condemning in the strongest terms the terrorist attacks that occurred in Casablanca, Morocco, on April 10 and 14, 2007, and in Algiers, Algeria, on April 11, 2007.

Whereas on April 10, 2007, a series of explosions in Casablanca, Morocco, resulted in the tragic death of a Moroccan police officer and numerous injuries to others;

Whereas on April 14, 2007, two suicide attacks in Casablanca, Morocco, one near the United States Consulate, resulted in panic and chaos in the surrounding area;

Whereas on April 11, 2007, multiple explosions in Algiers, Algeria, resulted in the horrific deaths of 33 people, in-

cluding members of the police force, and injuries to more than one hundred people;

Whereas the people and Governments of the Kingdom of Morocco and the People's Democratic Republic of Algeria have been targeted in several terrorist attacks over the past several years;

Whereas Al-Qaeda and Al-Qaeda affiliates claimed responsibility for the attacks in Morocco and Algeria; and

Whereas Morocco and Algeria are both allies of the United States in the fight against global terrorism: Now, therefore, be it

1       *Resolved*, That the House of Representatives—

2               (1) condemns in the strongest terms the horrific terrorist attacks that occurred in Casablanca, 3               Morocco, on April 10 and 14, 2007, and in Algiers, 4               Algeria, on April 11, 2007;

5               (2) expresses its condolences to the families and 6               friends of those individuals who were killed in the 7               attacks and expresses its sympathies to those individuals 8               who have been injured;

9               (3) expresses the solidarity of the people and 10               Government of the United States with the people 11               and Governments of the Kingdom of Morocco and 12               the People's Democratic Republic of Algeria as they 13               recover from these cowardly and inhuman attacks;

14               (4) expresses its readiness to support and assist 15               the Moroccan and Algerian authorities in their ef-

1       forts to bring to justice those individuals responsible  
2       for the recent attacks in Morocco and Algeria and  
3       to detect, pursue, disrupt, and dismantle the net-  
4       works that plan and carry out such attacks; and

5               (5) expresses its support for the people and  
6       Governments of Morocco and Algeria in their contin-  
7       ued struggle against extremism and violence, and  
8       support for their efforts to secure peace for their na-  
9       tions.
