- 17 dered on the motion to its adoption without intervening
- 18 motion.
- 19 Sec. 2. Upon the adoption of this resolution it shall
- 20 be in order to consider in the House the joint resolution
- 21 (H.J. Res. 72) making further continuing appropriations
- 22 for the fiscal year 2008, and for other purposes. All points
- 23 of order against consideration of the joint resolution are
- 24 waived except those arising under clause 9 or 10 of rule
- 25 XXI. The joint resolution shall be considered as read. All

- 1 points of order against provisions of the joint resolution
- 2 are waived. The previous question shall be considered as
- 3 ordered on the joint resolution to final passage without
- 4 intervening motion except: (1) one hour of debate equally
- 5 divided and controlled by the chairman and ranking mi-
- 6 nority member of the Committee on Appropriations; and
- 7 (2) one motion to recommit.
- 8 Sec. 3. During consideration of House Joint Resolu-
- 9 tion 72 or the motion to concur pursuant to this resolu-
- 10 tion, notwithstanding the operation of the previous ques-
- 11 tion, the Chair may postpone further consideration of ei-
- 12 ther measure to such time as may be designated by the
- 13 Speaker.
