A BILL

To amend the Small Business Act to improve programs for veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Military Reservist and
- 5 Veteran Small Business Reauthorization Act of 2007".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act—
- 8 (1) the term "activated" means receiving an
- 9 order placing a Reservist on active duty;

1	(2) the term "active duty" has the meaning
2	given that term in section 101 of title 10, United
3	States Code;
4	(3) the terms "Administration" and "Adminis-
5	trator" mean the Small Business Administration
6	and the Administrator thereof, respectively;
7	(4) the term "Reservist" means a member of a
8	reserve component of the Armed Forces, as de-
9	scribed in section 10101 of title 10, United States
10	Code;
11	(5) the term "Service Corps of Retired Execu-
12	tives" means the Service Corps of Retired Execu-
13	tives authorized by section 8(b)(1) of the Small
14	Business Act (15 U.S.C. 637(b)(1));
15	(6) the terms "service-disabled veteran" and
16	"small business concern" have the meanings given
17	those terms in section 3 of the Small Business Act
18	(15 U.S.C. 632);
19	(7) the term "small business development cen-
20	ter" means a small business development center de-
21	scribed in section 21 of the Small Business Act (15
22	U.S.C. 648); and
23	(8) the term "women's business center" means
24	a women's business center described in section 29 of

the Small Business Act (15 U.S.C. 656).

TITLE I—MILITARY RESERVIST LOANS SEC. 101. GRANT ASSISTANCE FOR MILITARY RESERVISTS' SMALL BUSINESSES.

5	(a) Authorization of Grants.—Section
6	7(b)(3)(B) of the Small Business Act (15 U.S.C.
7	636(b)(3)(B)) is amended by inserting "or grants" after
8	"or a deferred basis".
9	(b) Grant Specifications.—Section 7(b)(3) of the
10	Small Business Act (15 U.S.C. 636(b)(3)) is amended by
11	inserting after subparagraph (F) the following:
12	"(G) Grants made under subparagraph
13	(B)—
14	"(i) may be awarded in addition to
15	any loan made under subparagraph (B);
16	"(ii) shall not exceed \$25,000; and
17	"(iii) shall be made only to a small
18	business concern—
19	"(I) that provides a business plan
20	demonstrating viability for not less
21	than 3 years after the date of the ap-
22	plication for that grant;
23	"(II) with 10 or fewer employees;
24	and

1	"(III) that has not received a
2	grant under subparagraph (B) during
3	the 2-year period ending on the date
4	of the application for that grant.".
5	(c) Authorization of Appropriations.—Section

21	SEC. 102. NONCOLLATERALIZED LOANS.
22	Section 7(b)(3) of the Small Business Act (15 U.S.C.

2	sion of law, the Administrator may make a loan
3	under this paragraph of not more than
4	\$100,000 without collateral.
5	"(ii) The Administrator may defer pay-
6	ment of principal and interest on a loan de-
7	scribed in clause (i) during the longer of—
8	"(I) the 1-year period beginning on
9	the date of the initial disbursement of the
10	loan; and
11	"(II) the period during which the rel-
12	evant essential employee is on active
13	duty.".
14	SEC. 103. APPLICATION PERIOD.
15	Section 7(b)(3)(C) of the Small Business Act (15
16	U.S.C. $636(b)(3)(C)$) is amended by striking "90 days"
17	and inserting "1 year".
18	SEC. 104. PREAPPROVAL PROCESS.
19	(a) Definition.—In this section, the term "eligible
20	Reservist" means a Reservist who—
21	(1) has not been ordered to active duty;
22	(2) expects to be ordered to active duty during
23	a period of military conflict (as that term is defined
24	in section $7(n)(1)$ of the Small Business Act (15
25	U.S.C. $636(n)(1)$; and

1	(3) can reasonably demonstrate that the small
2	business concern for which that Reservist is a key
3	employee will suffer economic injury in the absence
4	of that Reservist.
5	(b) Establishment.—Not later than 6 months after
6	the date of enactment of this Act, the Administrator shall
7	establish a preapproval process, under which—
8	(1) the Administrator may approve a loan or
9	grant to a small business concern under section
10	7(b)(3) of the Small Business Act (15 U.S.C.
11	636(b)(3)), as amended by this Act, before an eligi-
12	ble Reservist employed by that small business con-
13	cern is activated; and
14	(2) the Administrator shall distribute funds for
15	any loan or grant approved under paragraph (1) if
16	that eligible Reservist is activated.
17	SEC. 105. OUTREACH AND TECHNICAL ASSISTANCE PRO-
18	GRAM.
19	(a) In General.—Not later than 6 months after the
20	date of enactment of this Act, the Administrator, in con-
21	sultation with the Secretary of Veterans Affairs and the
22	Secretary of Defense, shall develop a comprehensive out-
23	reach and technical assistance program (in this section re-
24	ferred to as the "program") to—

1	(1) market the loans and grants available under
2	section 7(b)(3) of the Small Business Act (15 U.S.C.
3	636(b)(3)), as amended by this Act, to Reservists,
4	and family members of Reservists, that are on active
5	duty and that are not on active duty; and
6	(2) provide technical assistance to a small busi-
7	ness concern applying for a loan or grant under that
8	section.
9	(b) Components.—The program shall—
10	(1) incorporate appropriate websites maintained
11	by the Administration, the Department of Veterans
12	Affairs, and the Department of Defense; and
13	(2) require that information on the program is
14	made available to small business concerns directly
15	through—
16	(A) the district offices and resource part-
17	ners of the Administration, including small
18	business development centers, women's business
19	centers, and the Service Corps of Retired Ex-
20	ecutives; and
21	(B) other Federal agencies, including the
22	Department of Veterans Affairs and the De-
23	partment of Defense.
24	(c) Report.—

1	(1) In general.—Not later than 6 months
2	after the date of enactment of this Act, and every
3	6 months thereafter until the date that is 30 months
4	after such date of enactment, the Administrator
5	shall submit to Congress a report on the status of
6	the program.
7	(2) Contents.—Each report submitted under
8	paragraph (1) shall include—
9	(A) for the 6-month period before the date
10	of that report—
11	(i) the number of loans and grants
12	approved under section 7(b)(3) of the
13	Small Business Act (15 U.S.C. 636(b)(3)),
14	as amended by this Act;
15	(ii) the number of loans and grants
16	disbursed under that section; and
17	(iii) the total amount disbursed under
18	that section; and
19	(B) recommendations, if any, to make the
20	program more effective in serving small busi-
21	ness concerns that employ Reservists.

2	siring a grant under this section shall submit an ap-
3	plication to the Administrator at such time, in such
4	manner, and accompanied by such information as
5	the Administrator may reasonably require.
6	"(2) Contents.—Each application submitted
7	under paragraph (1) shall describe—
8	"(A) the activities for which the applicant
9	seeks assistance under this section; and
10	"(B) how the applicant plans to allocate
11	funds within its network.
12	"(3) Matching not required.—Subpara-
13	graphs (A) and (B) of section 21(a)(4), requiring
14	matching funds, shall not apply to grants awarded
15	under this section.
16	"(f) Award of Grants.—
17	"(1) Deadline.—The Administrator shall
18	award grants not later than 60 days after the pro-
19	mulgation of final rules and regulations under sub-
20	section (d).
21	"(2) Amount.—Each eligible applicant award-
22	ed a grant under this section shall receive a grant
23	in an amount—
24	"(A) not less than \$150,000 per fiscal
25	vear: and

1	"(B) not greater than \$500,000 per fiscal
2	year.
3	"(g) Report.—
4	"(1) In General.—The Comptroller General of
5	the United States shall—
6	"(A) initiate an evaluation of the program
7	not later than 30 months after the disburse-
8	ment of the first grant under this section; and
9	"(B) submit a report not later than 6
10	months after the initiation of the evaluation
