A BILL

To change the name of the National Institute on Drug Abuse to the National Institute on Diseases of Addiction and to change the name of the National Institute on Alcohol Abuse and Alcoholism to the National Institute on Alcohol Disorders and Health.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Recognizing Addiction
3 as a Disease Act of 2007”.

4 **SEC. 2. FINDINGS.**

5 Congress makes the following findings:

6 (1) Addiction is a chronic, relapsing brain dis-
7 ease that is characterized by compulsive drug seek-
8 ing and use, despite harmful consequences. It is con-
9 sidered a brain disease because drugs change the
10 brain’s structure and manner in which it functions.
11 These brain changes can be long lasting, and can
12 lead to the harmful behaviors seen in people who
13 abuse drugs. The disease of addiction affects both
14 brain and behavior, and scientists have identified
15 many of the biological and environmental factors
16 that contribute to the development and progression
17 of the disease.

18 (2) The pejorative term “abuse” used in con-
19 nection with diseases of addiction has the adverse ef-
20 fect of increasing social stigma and personal shame,
21 both of which are so often barriers to an individual’s
22 decision to seek treatment.

23 **SEC. 3. NAME CHANGE.**

24 (a) PUBLIC HEALTH SERVICE ACT.—The Public

(i) in subsection (a), by striking “National Institute on Alcohol Abuse and Alcoholism” and inserting “National Institute on Alcohol Disorders and Health”; and

(ii) in subsection (b)—

(I) in paragraph (3), by striking “Alcohol Abuse and Alcoholism” and

1 inserting “Alcohol Disorders and
2 Health”;

3 (II) in paragraph (5), by striking
4 “National Institute of Drug Abuse”
5 and inserting “National Institute on
6 Diseases of Addiction”; and

7 (III) in paragraph (10), by strik-
8 ing “Alcohol Abuse and Alcoholism”
9 and inserting “Alcohol Disorders and
10 Health”; and

11 (C) in section 464P (42 U.S.C. 285o–4)—

12 (i) in subsection (a)(7), by striking
13 “National Institute on Alcohol Abuse and
14 Alcoholism” and inserting “National Insti-
15 tute on Alcohol Disorders and Health”;
16 and

17 (ii) in subsection (b)(3), by striking
18 “Council on Drug Abuse” and inserting
19 “Council on Diseases of Addiction”; and

20 (4) in subpart 15 of part C of title IV (42
21 U.S.C. 285o et seq.)—

22 (A) in the subpart heading by striking
23 “Drug Abuse” and inserting “Diseases of Ad-
24 diction”; and

1 (B) in section 464L(a) (42 U.S.C.
2 285o(a)), by striking “National Institute on
3 Drug Abuse” and inserting “National Institute
4 on Diseases of Addiction”;
5 (5) in section 501 (42 U.S.C. 290aa)—

6 (A) by striking “National Institute on Al-
7 cohol Abuse and Alcoholism” each place that
8 such appears and inserting “National Institute
9 on Alcohol Disorders and Health”; and

10 (B) by striking “National Institute on
11 Drug Abuse” each place that such appears and
12 inserting “National Institute on Diseases of Ad-
13 diction”;

14 (6) in section 507 (42 U.S.C. 290bb)—

15 (A) by striking “National Institute on Al-
16 cohol Abuse and Alcoholism” each place that
17 such appears and inserting “National Institute
18 on Alcohol Disorders and Health”; and

19 (B) by striking “National Institute on
20 Drug Abuse” each place that such appears and
21 inserting “National Institute on Diseases of Ad-
22 diction”;

23 (7) in section 513 (42 U.S.C. 290bb–6), by
24 striking “NATIONAL INSTITUTE ON DRUG ABUSE” in

the section heading and inserting “NATIONAL INSTITUTE ON DISEASES OF ADDICTION”;

(8) in section 530 (42 U.S.C. 290cc–30)—

(A) by striking “National Institute of Alcohol Abuse and Alcoholism” and inserting “National Institute on Alcohol Disorders and Health”; and

(B) by striking “National Institute on Drug Abuse” and inserting “National Institute on Diseases of Addiction”; and

(9) in section 1918(a)(8)(B) (42 U.S.C. 300x–7(a)(8)(B)), by striking “National Institute on Drug Abuse” each place that such appears and inserting “National Institute on Diseases of Addiction”.

(b) OTHER ACTS.—

(1) TITLE 5, UNITED STATES CODE.—Section 7361(a) of title 5, United States Code, is amended by striking “National Institute on Drug Abuse” and inserting “National Institute on Diseases of Addiction”.

(2) COMPREHENSIVE SMOKING EDUCATION ACT.—Section 3(b)(1)(A) of the Comprehensive Smoking Education Act (15 U.S.C. 1341(b)(1)(A)) is amended by striking “National Institute on Drug

1 Abuse” and inserting “National Institute on Dis-
 2 eases of Addiction”.

3 (3) ELEMENTARY AND SECONDARY EDUCATION
 4 ACT OF 1965.—Section 4124(a)(2) of the Elementary
 5 and Secondary Education Act of 1965 (20 U.S.C.
 6 7134 (a)(2)) is amended—

7 (A) in subparagraph (C), by striking “Na-
 8 tional Institute on Drug Abuse” and inserting
 9 “National Institute on Diseases of Addiction”;
 10 and

11 (B) in subparagraph (D), by striking “Na-
 12 tional Institute on Alcoholism and Alcohol
 13 Abuse” and inserting “National Institute on Al-
 14 cohol Disorders and Health”.

15 (4) CONTROLLED SUBSTANCES ACT.—Section
 16 303(g)(2)(H) of the Controlled Substances Act (21
 17 U.S.C. 823(g)(2)(H)) is amended by striking “Na-
 18 tional Institute on Drug Abuse” each place that
 19 such appears and inserting “National Institute on
 20 Diseases of Addiction”.

21 (5) DRUG ABUSE, PREVENTION, TREATMENT,
 22 AND REHABILITATION ACT.—The Drug Abuse, Pre-
 23 vention, Treatment, and Rehabilitation Act is
 24 amended—

1 (A) in section 410(1) (21 U.S.C. 1177(a)),
2 by striking “National Institute on Drug Abuse”
3 and inserting “National Institute on Diseases
4 of Addiction”; and

5 (B) in section 412(a) (21 U.S.C. 1179(A)),
6 by striking “National Institute on Drug Abuse”
7 and inserting “National Institute on Diseases
8 of Addiction”.

9 (c) REFERENCE.—Any reference in any law, regula-
10 tion, order, document, paper, or other record of the United
11 States to the “National Institute on Drug Abuse”, the
12 “National Institute on Alcohol Abuse and Alcoholism”, the
13 “National Advisory Council on Alcohol Abuse and Alco-
14 holism”, and the “National Advisory Council on Drug
15 Abuse” shall be deemed to be a reference to the “National
16 Institute on Diseases of Addiction”, the “National Insti-
17 tute on Alcohol Disorders and Health”, the “National Ad-
18 visory Council on Alcohol Disorders and Health”, and the
19 “National Advisory Council on Diseases of Addiction”, re-
20 spectively.

21 (d) RULE OF CONSTRUCTION.—Nothing in this Act
22 shall be construed to alter the mission of the National In-
23 stitute on Alcohol Abuse and Alcoholism (renamed the Na-
24 tional Institute on Alcohol Disorders and Health) or the
25 National Institute on Drug Abuse (as renamed the Na-

1 tional Institute on Diseases of Addiction) or have any sub-
 2 stantive effect on the duties or responsibilities of such In-
 3 stitutes.

4 **SEC. 4. THE EUNICE KENNEDY SHRIVER NATIONAL INSTI-**
 5 **TUTE OF CHILD HEALTH AND HUMAN DEVEL-**
 6 **OPMENT.**

7 (a) *FINDINGS.*—Congress makes the following findings:

8 (1) *Since it was established by Congress in 1962*
 9 *at the request of President John F. Kennedy, the Na-*
 10 *tional Institute of Child Health and Human Develop-*
 11 *ment has achieved an outstanding record of achieve-*
 12 *ment in catalyzing a concentrated attack on the un-*
 13 *solved health problems of children and of mother-in-*
 14 *fant relationships by fulfilling its mission to—*

15 (A) *ensure that every individual is born*
 16 *healthy and wanted, that women suffer no harm-*
 17 *ful effects from reproductive processes, and that*
 18 *all children have the chance to achieve their full*
 19 *potential for healthy and productive lives, free*
 20 *from disease or disability; and*

21 (B) *ensure the health, productivity, inde-*
 22 *pendence, and well-being of all individuals*
 23 *through optimal rehabilitation.*

24 (2) *The National Institute of Child Health and*
 25 *Human Development has made unparalleled con-*

1 *tributions to the advancement of child health and*
 2 *human development, including significant efforts to—*

3 *(A) reduce dramatically the rates of Sudden*
 4 *Infant Death Syndrome, infant mortality, and*
 5 *maternal HIV transmission;*

6 *(B) develop the Haemophilus Influenza B*
 7 *(Hib) vaccine, credited with nearly eliminating*
 8 *the incidence of mental retardation; and*

9 *(C) conduct intramural research, support*
 10 *extramural research, and train thousands of*
 11 *child health and human development researchers*
 12 *who have contributed greatly to dramatic gains*
 13 *in child health throughout the world.*

14 *(3) The vision, drive, and tenacity of one*
 15 *woman, Eunice Kennedy Shriver, was instrumental*
 16 *in proposing, passing, and enacting legislation to es-*
 17 *tablish the National Institute of Child Health and*
 18 *Human Development (Public Law 87–838) on Octo-*
 19 *ber 17, 1962.*

20 *(4) It is befitting and appropriate to recognize*
 21 *the substantial achievements of Eunice Kennedy*
 22 *Shriver, a tireless advocate for children with special*
 23 *needs, whose foresight in creating the National Insti-*
 24 *tute of Child Health and Human Development gave*
 25 *life to the words of President Kennedy, who wished to*

1 *“encourage imaginative research into the complex*
 2 *processes of human development from conception to*
 3 *old age.”.*
