## A BILL

- 2 This Act may be cited as the "Breast Cancer Re-
- 3 search and Screening Act of 2007".
- 4 SEC. 2. NIH BREAST CANCER FUNDING.
- 5 There is authorized to be appropriated to the Na-
- 6 tional Institutes of Health, \$2,148,000,000 for fiscal year
- 7 2008 for carrying out breast cancer research under title
- 8 IV of the Public Health Service Act (42 U.S.C. 481 et
- 9 seq.).
- 10 SEC. 3. EXTENDING THE ELIGIBILITY PERIOD FOR A "WEL-
- 11 COME TO MEDICARE" PHYSICAL EXAMINA-
- 12 TION FROM SIX MONTHS TO ONE YEAR.
- 13 (a) IN GENERAL.—Section 1862(a)(1)(K) of the So-
- 14 cial Security Act (42 U.S.C. 1395y(a)(1)(K)) is amended
- 15 by striking "6 months" and inserting "1 year".
- 16 (b) Effective Date.—The amendment made by
- 17 subsection (a) shall apply to initial preventive physician

- 19 SEC. 4. ELIMINATION OF THE 20 PERCENT COINSURANCE
- FOR SCREENING MAMMOGRAPHY AND
- 21 COLORECTAL CANCER SCREENING TESTS.

- 2 "screening mammography".
- 3 (c) Effective Date.—The amendments made by
- 4 this section shall apply to screening mammography and
- 5 colorectal cancer screening tests performed on or after

6 January 1, 2008.
