To establish the Champlain Quadricentennial Commemoration Commission and the Hudson-Fulton 400th Commemoration Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) **SHORT TITLE.**—This Act may be cited as the

7 **SEC. 2. FINDINGS; PURPOSE.**

8 (a) **FINDINGS.**—Congress finds that—

9 (1) the first European exploration of the Hud-
 10 son River and Lake Champlain and the introduction
 11 of steam navigation to maritime commerce were
 12 events of major historical importance, both in the
 13 United States and internationally;

1 (2) in 1609—

2 (A) Englishman Henry Hudson, acting in
3 service of the Dutch East India Company, was
4 the first European to sail up the river later
5 named for him in the vessel Half Moon; and

6 (B) French explorer Samuel de Champlain
7 was the first European to see—

8 (i) the lake later named for him; and

9 (ii) the shores of the northern regions
10 of the States of New York and Vermont;

11 (3) those voyages—

12 (A) were 2 of the most significant passages
13 in the European exploration and discovery of
14 America; and

15 (B) began 2 of the earliest contacts in the
16 New World between Native Americans and Eu-
17 ropeans;

18 (4) those explorations led to the establishment
19 of—

20 (A) Fort Orange, a Dutch, and later
21 English, settlement of what is now the capital
22 city of the State of New York; and

23 (B) French Quebec settlements as far
24 south as Lake George;

1 (5) the establishment of the settlements de-
 2 scribed in paragraph (4) extended the trade, com-
 3 merce, culture, and religion of the European settlers
 4 deep into the Mohawk Valley and as far west as
 5 Lake Erie;

6 (6) the early settlements of Fort George and
 7 the numerous French Quebec settlements influenced
 8 the history, culture, law, commerce, and traditions of
 9 liberty of the United States that—

10 (A) extend to the present day; and

11 (B) are constantly reflected in the position
 12 of the United States as the leader of the coun-
 13 tries of the free world;

14 (7) in 1807, Robert Fulton navigated the Hud-
 15 son River from the city of New York to Albany in
 16 the steamboat Clermont, successfully inaugurating
 17 steam navigation on a commercial basis;

18 (8) the successful navigation of the Hudson
 19 River was 1 of the most important events in the his-
 20 tory of navigation because that navigation—

21 (A) revolutionized waterborne commerce on
 22 the great rivers of the United States;

23 (B) transformed naval warfare; and

24 (C) fostered international relations through
 25 transoceanic travel and trade; and

1 (9) in 2000, the province of Quebec—

2 (A) established a commission known as the
3 “Quebec 400 Commission”;

4 (B) granted to the Quebec 400 Commis-
5 sion a budget of an amount not less than
6 \$1,000,000; and

7 (C) included in the responsibilities of the
8 Quebec 400 Commission a commemoration of
9 the Champlain voyage of 1609.

10 (b) PURPOSES.—The purposes of this Act are to es-
11 tablish the Champlain Commission and the Hudson-Ful-
12 ton Commission—

13 (1) to ensure a suitable national observance of
14 the anniversaries of Henry Hudson, Robert Fulton,
15 and Samuel de Champlain in 2009 through coopera-
16 tion with, and assistance to, the programs and ac-
17 tivities of the States of New York and Vermont, and
18 the commemorative commissions formed by those
19 States;

20 (2) to assist in ensuring that Hudson-Fulton-
21 Champlain 2009 observances provide an excellent
22 visitor experience and beneficial interaction between
23 visitors and the natural and cultural resources of the
24 sites located in the States;

1 ~~(3)~~ to assist in ensuring that Hudson-Fulton-
 2 Champlain 2009 observances are inclusive and ap-
 3 propriately recognize the diverse Hudson River and
 4 Lake Champlain communities that developed over 4
 5 centuries;

6 ~~(4)~~ to facilitate international involvement (in-
 7 cluding the involvement of the Quebec 400 Commis-
 8 sion) in the Hudson-Fulton-Champlain 2009 observ-
 9 ances;

10 ~~(5)~~ to support and facilitate marketing efforts
 11 for—

12 ~~(A)~~ a commemorative coin;

13 ~~(B)~~ a commemorative stamp; and

14 ~~(C)~~ related activities for the Hudson-Ful-
 15 ton-Champlain 2009 observances;

16 ~~(6)~~ to assist in the appropriate development of
 17 heritage tourism and economic benefits to the
 18 United States; and

19 ~~(7)~~ to support and facilitate the related efforts
 20 of the Lake Champlain Basin Program in the co-
 21 ordination of efforts to commemorate the voyage of
 22 Samuel de Champlain.

23 **SEC. 3. COORDINATION.**

24 Each commission established under this Act shall co-
 25 ordinate with the other respective commission established

1 under this Act to ensure that commemorations of Henry
 2 Hudson, Robert Fulton, and Samuel de Champlain are—

3 ~~(1)~~ consistent with the plans and programs of
 4 the commemorative commissions established by the
 5 States of New York and Vermont; and

6 ~~(2)~~ well-organized and successful.

7 **TITLE I—CHAMPLAIN QUADRI-**
 8 **CENTENNIAL COMMEMORA-**
 9 **TION COMMISSION**

10 **SEC. 101. DEFINITIONS.**

11 In this title:

12 ~~(1)~~ CHAMPLAIN COMMISSION.—The term
 13 “Champlain Commission” means the Champlain
 14 Quadricentennial Commemoration Commission es-
 15 tablished by section 102(a).

16 ~~(2)~~ COMMEMORATION.—The term “commemo-
 17 ration” means the commemoration of the 400th an-
 18 niversary of the voyage of Samuel de Champlain.

19 ~~(3)~~ LAKE CHAMPLAIN BASIN PROGRAM.—The
 20 term “Lake Champlain Basin Program” means the
 21 partnership established by section 120 of the Fed-
 22 eral Water Pollution Control Act (33 U.S.C. 1270)
 23 between the States of New York and Vermont and
 24 Federal agencies to carry out the Lake Champlain
 25 management plan entitled, “Opportunities for Ae-

1 tion: An Evolving Plan for the Lake Champlain
2 Basin”.

3 (4) SECRETARY.—The term “Secretary” means
4 the Secretary of the Interior.

5 (5) STATES.—

6 (A) IN GENERAL.—The term “States”
7 means the States of New York and Vermont.

8 (B) INCLUSIONS.—The term “States” in-
9 cludes political subdivisions of the States.

10 **SEC. 102. ESTABLISHMENT OF CHAMPLAIN COMMISSION.**

11 (a) IN GENERAL.—There is established a commission
12 to be known as the “Champlain Quadricentennial Com-
13 memoration Commission”.

14 (b) MEMBERSHIP.—

15 (1) COMPOSITION.—The Champlain Commis-
16 sion shall be composed of 11 members, of whom—

17 (A) 2 members shall be employees of the
18 National Park Service, of whom—

19 (i) 1 shall be the Director of the Na-
20 tional Park Service (or a designee); and

21 (ii) 1 shall be an employee of the Na-
22 tional Park Service having experience rel-
23 evant to the commemoration, who shall be
24 appointed by the Secretary;

1 ~~(B)~~ 4 members shall be appointed by the
 2 Secretary from among individuals who, on the
 3 date of enactment of this Act, are—

4 (i) serving as members of the Hudson-
 5 Fulton-Champlain Quadricentennial Com-
 6 mission of the State of New York; and

7 (ii) residents of Champlain Valley,
 8 New York;

9 ~~(C)~~ 4 members shall be appointed by the
 10 Secretary from among individuals who, on the
 11 date of enactment of this Act, are—

12 (i) serving as members of the Lake
 13 Champlain Quadricentennial Commission
 14 of the State of Vermont; and

15 (ii) residents of the State of Vermont;
 16 and

17 ~~(D)~~ 1 member shall be appointed by the
 18 Secretary, and shall be an individual who has—

19 (i) an interest in, support for, and ex-
 20 pertise appropriate with respect to, the
 21 commemoration; and

22 (ii) knowledge relating to the history
 23 of the Champlain Valley.

24 ~~(2)~~ TERM; VACANCIES.—

1 (A) TERM.—A member of the Champlain
2 Commission shall be appointed for the life of
3 the Champlain Commission.

4 (B) VACANCIES.—

5 (i) IN GENERAL.—A vacancy on the
6 Champlain Commission shall be filled in
7 the same manner in which the original ap-
8 pointment was made.

9 (ii) PARTIAL TERM.—A member ap-
10 pointed to fill a vacancy on the Champlain
11 Commission shall serve for the remainder
12 of the term for which the predecessor of
13 the member was appointed.

14 (3) INITIAL MEETING.—Not later than 30 days
15 after the date on which all members of the Cham-
16 plain Commission have been appointed, the Cham-
17 plain Commission shall hold the initial meeting of
18 the Champlain Commission.

19 (4) MEETINGS.—The Champlain Commission
20 shall meet—

21 (A) at least twice each year; or

22 (B) at the call of the Chairperson or the
23 majority of the members of the Champlain
24 Commission.

1 ~~(5) QUORUM.—A majority of voting members~~
 2 ~~shall constitute a quorum, but a lesser number may~~
 3 ~~hold meetings.~~

4 ~~(6) CHAIRPERSON AND VICE CHAIRPERSON.—~~

5 ~~(A) ELECTION.—The Champlain Commis-~~
 6 ~~sion shall elect the Chairperson and the Vice~~
 7 ~~Chairperson of the Champlain Commission on~~
 8 ~~an annual basis.~~

9 ~~(B) ABSENCE OF THE CHAIRPERSON.—~~

10 ~~The Vice Chairperson shall serve as the Chair-~~
 11 ~~person in the absence of the Chairperson.~~

12 ~~(7) VOTING.—The Champlain Commission shall~~
 13 ~~act only on an affirmative vote of a majority of the~~
 14 ~~voting members of the Champlain Commission.~~

15 **SEC. 103. DUTIES.**

16 ~~(a) IN GENERAL.—The Champlain Commission~~
 17 ~~shall—~~

18 ~~(1) plan, develop, and execute programs and ac-~~
 19 ~~tivities appropriate to commemorate the 400th anni-~~
 20 ~~versary of the voyage of Samuel de Champlain, the~~
 21 ~~first European to discover and explore Lake Cham-~~
 22 ~~plain;~~

23 ~~(2) facilitate activities relating to the Cham-~~
 24 ~~plain Quadricentennial throughout the United~~
 25 ~~States;~~

- 1 ~~(3)~~ coordinate the activities of the Champlain
2 Commission with—
- 3 ~~(A)~~ State commemoration commissions;
4 ~~(B)~~ appropriate Federal agencies, includ-
5 ing—
- 6 (i) the Department of Agriculture;
7 (ii) the Department of Defense;
8 (iii) the Department of State; and
9 (iv) the Department of Transpor-
10 tation;
- 11 ~~(C)~~ the Lake Champlain Basin Program;
12 ~~(D)~~ the Chairman of the National Endow-
13 ment for the Arts; and
- 14 ~~(E)~~ the Secretary of the Smithsonian Insti-
15 tution;
- 16 ~~(4)~~ encourage civic, patriotic, historical, edu-
17 cational, artistic, religious, economic, and other or-
18 ganizations throughout the United States to orga-
19 nize and participate in anniversary activities to ex-
20 pand the understanding and appreciation of the sig-
21 nificance of the voyage of Samuel de Champlain;
- 22 ~~(5)~~ provide technical assistance to States, local-
23 ities, and nonprofit organizations to further the com-
24 memoration;

1 (6) coordinate and facilitate for the public
2 scholarly research on, publication about, and inter-
3 pretation of, the voyage of Samuel de Champlain;

4 (7) ensure that the Champlain 2009 anniver-
5 sary provides a lasting legacy and a long-term public
6 benefit by assisting in the development of appro-
7 priate programs and facilities;

8 (8) help ensure that the observances of the voy-
9 age of Samuel de Champlain are inclusive and ap-
10 propriately recognize the experiences and heritage of
11 all people present when Samuel de Champlain ar-
12 rived in the Champlain Valley; and

13 (9) consult and coordinate with the Lake
14 Champlain Basin Program and other relevant orga-
15 nizations to plan and develop programs and activi-
16 ties to commemorate the voyage of Samuel de
17 Champlain.

18 (b) STRATEGIC PLAN AND ANNUAL PERFORMANCE

19 PLANS.—The Champlain Commission shall prepare—

20 (1) a strategic plan in accordance with section
21 306 of title 5, United States Code, for each day (in-
22 cluding travel time) during which the member is en-
23 gaged in the performance of the duties of the Cham-
24 plain Commission; and

1 ~~(2)~~ annual performance plans in accordance
 2 with section ~~1115~~ of title ~~31~~, United States Code,
 3 for the activities of the Champlain Commission ear-
 4 ried out under this Act.

5 ~~(c)~~ REPORTS.—

6 ~~(1)~~ ANNUAL REPORTS.—The Champlain Com-
 7 mission shall annually submit to Congress a report
 8 that contains—

9 ~~(A)~~ a list of each gift, bequest, or devise
 10 with a value of more than \$250; and

11 ~~(B)~~ the identity of the donor of each gift,
 12 bequest, or devise provided in subparagraph
 13 ~~(A)~~.

14 ~~(2)~~ FINAL REPORT.—Not later than ~~【Sep-~~
 15 tember ~~30, 2010】~~, the Champlain Commission shall
 16 submit to the Secretary a final report that con-
 17 tains—

18 ~~(A)~~ a summary of the activities of the
 19 Champlain Commission;

20 ~~(B)~~ a final accounting of funds received
 21 and expended by the Champlain Commission;
 22 and

23 ~~(C)~~ the findings and recommendations of
 24 the Champlain Commission.

1 **SEC. 104. POWERS.**

2 (a) GIFTS.—The Champlain Commission may solicit,
3 accept, use, and dispose of gifts, bequests, or devises of
4 money or other real or personal property for aiding or fa-
5 cilitating the work of the Champlain Commission.

6 (b) APPOINTMENT OF ADVISORY COMMITTEES.—The
7 Champlain Commission may appoint such advisory com-
8 mittees as the Champlain Commission determines to be
9 necessary to carry out this Act.

10 (c) AUTHORIZATION OF ACTION.—The Champlain
11 Commission may authorize any member or employee of the
12 Champlain Commission to take any action that the Cham-
13 plain Commission is authorized to take under this Act.

14 (d) PROCUREMENT.—The Champlain Commission
15 may procure supplies, services, and property, and make
16 or enter into contracts, leases, or other legal agreements,
17 to carry out this Act (except that a contract, lease, or
18 other legal agreement made or entered into by the Cham-
19 plain Commission (or with administrative assistance from
20 the Lake Champlain Basin Program) shall not extend be-
21 yond the date of termination of the Champlain Commis-
22 sion).

23 (e) POSTAL SERVICES.—The Champlain Commission
24 may use the United States mails in the same manner and
25 under the same conditions as other agencies of the Federal
26 Government.

1 (f) GRANTS.—Subject to approval by the Champlain
2 Commission, the Champlain Commission may—

3 (1) make grants in amounts not to exceed
4 \$20,000 to communities, nonprofit organizations,
5 and State commemorative commissions to develop
6 programs to assist in the commemoration; and

7 (2) make grants in amounts not to exceed
8 \$20,000 to research and scholarly organizations to
9 research, publish, or distribute information relating
10 to the early history of the voyage of Samuel de
11 Champlain.

12 (g) TECHNICAL ASSISTANCE.—The Champlain Com-
13 mission shall provide technical assistance to States, local-
14 ities, and nonprofit organizations to further the com-
15 memoration.

16 (h) COORDINATION AND CONSULTATION WITH LAKE
17 CHAMPLAIN BASIN PROGRAM.—The Champlain Commis-
18 sion shall coordinate and consult with the Lake Champlain
19 Basin Program to provide grants and technical assistance
20 under subsections (f) and (g) for the development of ac-
21 tivities commemorating the voyage of Samuel de Cham-
22 plain.

23 **SEC. 105. CHAMPLAIN COMMISSION PERSONNEL MATTERS.**

24 (a) COMPENSATION OF MEMBERS.—

1 (1) IN GENERAL.—Except as provided in para-
 2 graph (2), a member of the Champlain Commission
 3 shall serve without compensation.

4 (2) FEDERAL EMPLOYEES.—A member of the
 5 Champlain Commission who is an officer or em-
 6 ployee of the Federal Government shall serve with-
 7 out compensation in addition to the compensation
 8 received for the services of the member as an officer
 9 or employee of the Federal Government.

10 (b) TRAVEL EXPENSES.—A member of the Cham-
 11 plain Commission shall be allowed travel expenses, includ-
 12 ing per diem in lieu of subsistence, at rates authorized
 13 for an employee of an agency under subchapter I of chap-
 14 ter 57 of title 5, United States Code, while away from
 15 the home or regular place of business of the member in
 16 the performance of the duties of the Champlain Commis-
 17 sion.

18 (c) STAFF.—

19 (1) IN GENERAL.—The Chairperson of the
 20 Champlain Commission may, without regard to the
 21 civil service laws (including regulations), appoint and
 22 terminate an Executive Director and such other ad-
 23 ditional personnel as are necessary to enable the
 24 Champlain Commission to perform the duties of the
 25 Champlain Commission.

1 ~~(2) CONFIRMATION OF EXECUTIVE DIREC-~~
 2 ~~TOR.—The employment of an Executive Director~~
 3 ~~shall be subject to confirmation by the Champlain~~
 4 ~~Commission.~~

5 ~~(d) COMPENSATION.—~~

6 ~~(1) IN GENERAL.—Except as provided in para-~~
 7 ~~graph (2), the Chairperson of the Champlain Com-~~
 8 ~~mission may fix the compensation of the Executive~~
 9 ~~Director and other personnel without regard to the~~
 10 ~~provisions of chapter 51 and subchapter III of chap-~~
 11 ~~ter 53 of title 5, United States Code, relating to~~
 12 ~~classification of positions and General Schedule pay~~
 13 ~~rates.~~

14 ~~(2) MAXIMUM RATE OF PAY.—The rate of pay~~
 15 ~~for the Executive Director and other personnel shall~~
 16 ~~not exceed the rate payable for level V of the Execu-~~
 17 ~~tive Schedule under section 5316 of title 5, United~~
 18 ~~States Code.~~

19 ~~(e) DETAIL OF GOVERNMENT EMPLOYEES.—~~

20 ~~(1) FEDERAL EMPLOYEES.—~~

21 ~~(A) IN GENERAL.—At the request of the~~
 22 ~~Champlain Commission, the head of any Fed-~~
 23 ~~eral agency may detail, on a reimbursable or~~
 24 ~~nonreimbursable basis, any of the personnel of~~
 25 ~~the agency to the Champlain Commission to as-~~

1 sist the Champlain Commission in carrying out
 2 the duties of the Champlain Commission under
 3 this Act.

4 ~~(B) CIVIL SERVICE STATUS.~~—The detail of
 5 an employee under subparagraph (A) shall be
 6 without interruption or loss of civil service sta-
 7 tus or privilege.

8 ~~(2) STATE EMPLOYEES.~~—The Champlain Com-
 9 mission may—

10 ~~(A)~~ accept the services of personnel de-
 11 tailed from States (including subdivisions of
 12 States); and

13 ~~(B)~~ reimburse States for services of de-
 14 tailed personnel.

15 ~~(3) LAKE CHAMPLAIN BASIN PROGRAM EM-~~
 16 ~~PLOYEES.~~—The Champlain Commission may—

17 ~~(A)~~ accept the services of personnel de-
 18 tailed from the Lake Champlain Basin Pro-
 19 gram; and

20 ~~(B)~~ reimburse the Lake Champlain Basin
 21 Program for services of detailed personnel.

22 ~~(4) PROCUREMENT OF TEMPORARY AND INTER-~~
 23 ~~MITTENT SERVICES.~~—The Chairperson of the Cham-
 24 plain Commission may procure temporary and inter-
 25 mittent services in accordance with section ~~3109(b)~~

1 of title 5, United States Code, at rates for individ-
 2 uals that do not exceed the daily equivalent of the
 3 annual rate of basic pay prescribed for level V of the
 4 Executive Schedule under section 5316 of that title.

5 (f) VOLUNTEER AND UNCOMPENSATED SERVICES.—

6 Notwithstanding section 1342 of title 31, United States
 7 Code, the Champlain Commission may accept and use vol-
 8 untary and uncompensated services as the Champlain
 9 Commission determines necessary.

10 (g) SUPPORT SERVICES.—The Director of the Na-
 11 tional Park Service shall provide to the Champlain Com-
 12 mission, on a reimbursable basis, such administrative sup-
 13 port services as the Champlain Commission may request.

14 (h) FACA NONAPPLICABILITY.—Section 14(b) of the
 15 Federal Advisory Committee Act (5 U.S.C. App.) shall not
 16 apply to the Champlain Commission.

17 (i) NO EFFECT ON AUTHORITY.—Nothing in this
 18 section supersedes the authority of the States or the Na-
 19 tional Park Service concerning the commemoration.

20 **SEC. 106. AUDIT OF CHAMPLAIN COMMISSION.**

21 The Inspector General of the Department of the Inte-
 22 rior shall—

23 (1) annually conduct an audit of the Champlain
 24 Commission;

1 (2) make available to the public the results of
2 the annual audit; and

3 (3) submit the results of the annual audit to
4 the Committee on Government Reform of the House
5 of Representatives.

6 **SEC. 107. AUTHORIZATION OF APPROPRIATIONS.**

7 (a) IN GENERAL.—There is authorized to be appro-
8 priated to carry out this Act \$500,000 for each of fiscal
9 years **[2008 through 2011]**; to remain available until ex-
10 pended.

11 (b) ALLOCATION.—Of amounts made available under
12 subsection (a) for fiscal year **[2008]** and each fiscal year
13 thereafter—

14 (1) 45 percent shall be provided for activities in
15 the State of New York relating to the commemora-
16 tion of Samuel de Champlain;

17 (2) 45 percent shall be provided for activities in
18 the State of Vermont relating to the commemoration
19 of Samuel de Champlain; and

20 (3) 10 percent shall be distributed by the
21 Champlain Commission for activities relating to the
22 commemoration of Samuel de Champlain, in accord-
23 ance with this Act.

1 **SEC. 108. TERMINATION OF CHAMPLAIN COMMISSION.**

2 (a) DATE OF TERMINATION.—The Champlain Com-
3 mission shall terminate on ~~December 31, 2010~~.

4 (b) TRANSFER OF DOCUMENTS AND MATERIALS.—
5 Before the date of termination specified in subsection (a),
6 the Champlain Commission shall transfer all documents
7 and materials of the Champlain Commission to the Na-
8 tional Archives or another appropriate Federal entity.

9 **TITLE H—HUDSON-FULTON**

8 **SEC. 202. ESTABLISHMENT OF HUDSON-FULTON COMMIS-**
9 **SION.**

10 (a) ESTABLISHMENT.—There is established a com-
11 mission to be known as the “Hudson-Fulton 400th Com-
12 memoration Commission”.

13 (b) MEMBERSHIP.—

14 (1) COMPOSITION.—The Hudson-Fulton Com-
15 mission shall be composed of 16 members, of
16 whom—

17 (A) 1 member shall be appointed by the
18 Secretary, after taking into consideration the

12 appointed by the Secretary;

13 (E) 2 members shall be appointed by the
14 Secretary, and shall be individuals that have an
15 interest in, support for, and expertise appro-
16 priate with respect to, the commemoration, of
17 whom—

18 (i) 1 member shall be an individual
19 with expertise in the Hudson River Valley
20 National Heritage Area; and

21 (ii) 1 member shall be an individual
22 with expertise in the State of New York, as
23 it relates to the commemoration;

24 (F) 1 member shall be the Chairperson of
25 a commemorative commission formed by the

1 State of New York (or the designee of the
2 Chairperson); and

3 ~~(G) 2 members shall be appointed by the~~
4 ~~Secretary, after—~~

6 ommendation of the Mayor of the city of
7 New York; and

8 (ii) consulting the Members of the

12 ~~(A) TERM.—A member of the Hudson-Ful-~~
13 ~~ton Commission shall be appointed for the life~~

 14 experiences and heritage of all people present when
 15 Henry Hudson sailed the Hudson River.

15 make or enter into contracts, leases, or other legal agree-

18 son-Fulton Commission shall not extend beyond the date

20 (e) POSTAL SERVICES.—The Hudson-Fulton Com-

 9 the home or regular place of business of the member in
 10 the performance of the duties of the Hudson-Fulton Com-

13 (1) IN GENERAL.—The Chairperson of the

3 (I) 1 member shall be an indi-
 4 vidual with expertise in the Hudson
 5 River Valley National Heritage Area;
 6 and

7 (II) 1 member shall be an indi-
 8 vidual with expertise in the State of
 9 New York, as it relates to the Hudson-
 10 Fulton commemoration;

11 (F) 1 member shall be the Chairperson of a
 12 commemorative commission formed by the State
 13 of New York (or the designee of the Chairperson);
 14 and

15 (G) 2 members shall be appointed by the
 16 Secretary, after—

17 (i) considering the recommendation of
 18 the Mayor of the city of New York; and

19 (ii) consulting the Members of the
 20 House of Representatives whose districts en-
 21 compass the city of New York.

22 (2) *TERM; VACANCIES.—*

23 (A) *TERM.*—A member of the Hudson-Ful-
 24 ton Commission shall be appointed for the life of
 25 the Hudson-Fulton Commission.

1 (B) *VACANCIES.*—*A vacancy on the Hud-*
 2 *son-Fulton Commission shall be filled in the*
 3 *same manner in which the original appointment*

 23 *Area;*

1 (D) *the American Heritage Rivers Initia-*
 2 *tive Interagency Committee established by Exec-*
 3 *utive Order 13061, dated September 11, 1997;*

4 (E) *the National Endowment for the Hu-*
 5 *manities;*

6 (F) *the National Endowment for the Arts;*
 7 *and*

8 (G) *the Smithsonian Institution;*

9 (4) *encourage civic, patriotic, historical, edu-*
 10 *cational, artistic, religious, economic, and other orga-*
 11 *nizations throughout the United States to organize*
 12 *and participate in anniversary activities to expand*
 13 *the understanding and appreciation of the signifi-*
 14 *cance of the voyages of Henry Hudson and Robert*
 15 *Fulton;*

16 (5) *provide technical assistance to States, local-*
 17 *ities, and nonprofit organizations to further the Hud-*
 18 *son-Fulton commemoration;*

19 (6) *coordinate and facilitate for the public schol-*
 20 *arly research on, publication about, and interpreta-*
 21 *tion of, the voyages of Henry Hudson and Robert*
 22 *Fulton;*

23 (7) *ensure that the Hudson-Fulton 2009 com-*
 24 *memorations provide a lasting legacy and long-term*

1 *public benefit by assisting in the development of ap-*
 2 *propriate programs and facilities; and*

3 (8) *help ensure that the observances of Henry*
 4 *Hudson are inclusive and appropriately recognize the*
 5 *experiences and heritage of all people present when*
 6 *Henry Hudson sailed the Hudson River.*

7 **SEC. 6. COMMISSION MEETINGS.**

8 (a) *INITIAL MEETING.*—*Not later than 30 days after*
 9 *the date on which all members of a commission established*
 10 *under this Act have been appointed, the applicable Commis-*
 11 *sion shall hold an initial meeting.*

12 (b) *MEETINGS.*—*A commission established under this*
 13 *Act shall meet—*

14 (1) *at least twice each year; or*

15 (2) *at the call of the Chairperson or the majority*
 16 *of the members of the Commission.*

17 (c) *QUORUM.*—*A majority of voting members shall*
 18 *constitute a quorum, but a lesser number may hold meet-*

8 (a) *GIFTS.*—*The Commission may solicit, accept, use,*

12 (b) *APPOINTMENT OF ADVISORY COMMITTEES.*—*The*

 17 *may authorize any member or employee of the Commission*

20 (d) *PROCUREMENT.*—

21 (1) *IN GENERAL.*—*The Commission may procure*
 22 *supplies, services, and property, and make or enter*
 23 *into contracts, leases, or other legal agreements, to*
 24 *carry out this Act (except that a contract, lease, or*
 25 *other legal agreement made or entered into by the*

1 *Commission shall not extend beyond the date of ter-*
 2 *mination of the Commission).*

3 (2) *LIMITATION.*—*The Commission may not pur-*
 4 *chase real property.*

5 (e) *POSTAL SERVICES.*—*The Commission may use the*
 6 *United States mails in the same manner and under the*
 7 *same conditions as other agencies of the Federal Govern-*
 8 *ment.*

9 (f) *GRANTS.*—

10 (1) *CHAMPLAIN COMMISSION.*—*The Champlain*
 11 *Commission may make grants in amounts not to ex-*
 12 *ceed \$20,000—*

13 (A) *to communities, nonprofit organiza-*
 14 *tions, and State commemorative commissions to*
 15 *develop programs to assist in the Champlain*
 16 *commemoration; and*

17 (B) *to research and scholarly organizations*
 18 *to research, publish, or distribute information re-*
 19 *lating to the early history of the voyage of Sam-*
 20 *uel de Champlain.*

21 (2) *HUDSON-FULTON COMMISSION.*—*The Hud-*
 22 *son-Fulton Commission may make grants in amounts*
 23 *not to exceed \$20,000—*

24 (A) *to communities, nonprofit organiza-*
 25 *tions, and State commemorative commissions to*

1 *develop programs to assist in the Hudson-Fulton*
 2 *commemoration; and*

3 *(B) to research and scholarly organizations*
 4 *to research, publish, or distribute information re-*
 5 *lating to the early history of the voyages of*
 6 *Henry Hudson and Robert Fulton.*

7 *(g) TECHNICAL ASSISTANCE.—The Commission shall*
 8 *provide technical assistance to States, localities, and non-*

11 *(h) COORDINATION AND CONSULTATION WITH LAKE*

 14 *Basin Program to provide grants and technical assistance*

18 **SEC. 8. COMMISSION PERSONNEL MATTERS.**

19 *(a) COMPENSATION OF MEMBERS.—*

20 *(1) IN GENERAL.—Except as provided in para-*
 21 *graph (2), a member of the Commission shall serve*
 22 *without compensation.*

23 *(2) FEDERAL EMPLOYEES.—A member of the*
 24 *Commission who is an officer or employee of the Fed-*
 25 *eral Government shall serve without compensation in*

1 *addition to the compensation received for the services*
2 *of the member as an officer or employee of the Federal*
3 *Government.*

4 **(b) TRAVEL EXPENSES.**—*A member of the Commission*
5 *shall be allowed travel expenses, including per diem in lieu*
6 *of subsistence, at rates authorized for an employee of an*
7 *agency under subchapter I of chapter 57 of title 5, United*
8 *States Code, while away from the home or regular place*
9 *of business of the member in the performance of the duties*
10 *of the Commission.*

11 **(c) STAFF.**—*The Commission may, without regard to*
12 *the civil service laws (including regulations), appoint and*
13 *terminate an Executive Director and such other additional*
14 *personnel as are necessary to enable the Commission to per-*
15 *form the duties of the Commission.*

16 **(d) COMPENSATION.**—

17 **(1) IN GENERAL.**—*Except as provided in para-*
18 *graph (2), the Commission may fix the compensation*
19 *of the Executive Director and other personnel without*
20 *regard to the provisions of chapter 51 and subchapter*
21 *III of chapter 53 of title 5, United States Code, relat-*
22 *ing to classification of positions and General Schedule*
23 *pay rates.*

24 **(2) MAXIMUM RATE OF PAY.**—*The rate of pay for*
25 *the Executive Director and other personnel shall not*

1 *exceed the rate payable for level V of the Executive*
 2 *Schedule under section 5316 of title 5, United States*
 3 *Code.*

4 *(e) DETAIL OF GOVERNMENT EMPLOYEES.—*

5 *(1) FEDERAL EMPLOYEES.—*

6 *(A) IN GENERAL.—At the request of the*
 7 *Commission, the head of any Federal agency*
 8 *may detail, on a reimbursable or nonreimburs-*
 9 *able basis, any of the personnel of the agency to*
 10 *the Commission to assist the Commission in car-*
 11 *rying out the duties of the Commission under*
 12 *this Act.*

13 *(B) CIVIL SERVICE STATUS.—The detail of*
 14 *an employee under subparagraph (A) shall be*
 15 *without interruption or loss of civil service sta-*
 16 *tus or privilege.*

17 *(2) STATE EMPLOYEES.—The Commission*
 18 *may—*

19 *(A) accept the services of personnel detailed*
 20 *from the State of New York or the State of*
 21 *Vermont, as appropriate (including subdivisions*
 22 *of the States); and*

23 *(B) reimburse the State of New York or the*
 24 *State of Vermont for services of detailed per-*
 25 *sonnel.*

1 (3) *LAKE CHAMPLAIN BASIN PROGRAM EMPLOY-*
 2 *EES.—The Champlain Commission may—*

3 (A) *accept the services of personnel detailed*
 4 *from the Lake Champlain Basin Program; and*
 5 (B) *reimburse the Lake Champlain Basin*
 6 *Program for services of detailed personnel.*

7 (4) *PROCUREMENT OF TEMPORARY AND INTER-*
 8 *MITTENT SERVICES.—The Commission may procure*
 9 *temporary and intermittent services in accordance*
 10 *with section 3109(b) of title 5, United States Code, at*
 11 *rates for individuals that do not exceed the daily*
 12 *equivalent of the annual rate of basic pay prescribed*
 13 *for level V of the Executive Schedule under section*
 14 *5316 of that title.*

15 (f) *VOLUNTEER AND UNCOMPENSATED SERVICES.—*
 16 *Notwithstanding section 1342 of title 31, United States*
 17 *Code, the Commission may accept and use voluntary and*
 18 *uncompensated services as the Commission determines nec-*
 19 *essary.*

20 (g) *SUPPORT SERVICES.—The Secretary shall provide*
 21 *to the Commission, on a reimbursable basis, such adminis-*
 22 *trative support services as the Commission may request.*

23 (h) *FACA NONAPPLICABILITY.—Section 14(b) of the*
 24 *Federal Advisory Committee Act (5 U.S.C. App.) shall not*
 25 *apply to the Commission.*

1 **SEC. 9. REPORTS.**

2 *Not later than September 30, 2010, the Commission*
 3 *shall submit to the Secretary a report that contains—*

4 *(1) a summary of the activities of the Commis-*
 5 *sion;*

6 *(2) a final accounting of funds received and ex-*
 7 *pende by the Commission; and*

8 *(3) the findings and recommendations of the*
 9 *Commission.*

10 **SEC. 10. TERMINATION OF COMMISSIONS.**

11 *(a) DATE OF TERMINATION.—The Commission shall*
 12 *terminate on December 31, 2010.*

13 *(b) TRANSFER OF DOCUMENTS AND MATERIALS.—Be-*
 14 *fore the date of termination specified in subsection (a), the*
 15 *Commission shall transfer all of its documents and mate-*
 16 *rials of the Commission to the National Archives or another*
 17 *appropriate Federal entity.*

18 **SEC. 11. AUTHORIZATION OF APPROPRIATIONS.**

19 *(a) IN GENERAL.—There are authorized to be appro-*
 20 *priated to carry out this Act for each of fiscal years 2008*
 21 *through 2011—*

22 *(1) \$500,000 to the Champlain Commission; and*

23 *(2) \$500,000 to the Hudson-Fulton Commission.*

24 *(b) AVAILABILITY.—Amounts made available under*
 25 *subsection (a) shall remain available until expended.*
