Mr. LUGAR (for himself, Mr. DURBIN, Mr. BAYH, Ms. STABENOW, and Mr. LEVIN) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To amend the Farm Security and Rural Investment Act of 2002 to enhance the ability to produce fruits and vegetables on covered commodity base acres.

1 *Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Farming Flexibility
5 Act of 2007”.

1 **SEC. 2. PRODUCTION OF FRUITS AND VEGETABLES FOR**
2 **PROCESSING ON COVERED COMMODITY BASE**
3 **ACRES.**

4 Section 1101 of the Farm Security and Rural Invest-
5 ment Act of 2002 (7 U.S.C. 7911) is amended by adding
6 at the end the following:

7 “(i) **PRODUCTION OF FRUITS OR VEGETABLES FOR**
8 **PROCESSING.**—

9 “(1) **IN GENERAL.**—Subject to paragraphs (2)
10 and (3), the producers on a farm, with the consent
11 of the owner of and any other producers on the
12 farm, may reduce the base acres for a covered com-
13 modity for the farm if the reduced acres are used for
14 the planting and production of fruits or vegetables
15 for processing.

16 “(2) **REVERSION TO BASE ACRES FOR COVERED**
17 **COMMODITY.**—Any reduced acres of a farm devoted
18 to the planting and production of fruits or vegeta-
19 bles during a crop year under paragraph (1) shall be
20 included in base acres for the covered commodity for
21 the subsequent crop year, unless the producers on
22 the farm make the election described in paragraph
23 (1) for the subsequent crop year.

24 “(3) **RECALCULATION OF BASE ACRES.**—

25 “(A) **IN GENERAL.**—Subject to subpara-
26 graph (B), if the Secretary recalculates base

1 acres for a farm, the planting and production of
2 fruits or vegetables for processing under para-
3 graph (1) shall be considered to be the same as
4 the planting, prevented planting, or production
5 of the covered commodity.

6 “(B) AUTHORITY.—Nothing in this sub-
7 section provides authority for the Secretary to
8 recalculate base acres for a farm.”.
