A BILL

To prohibit profiteering and fraud relating to military action, relief, and reconstruction efforts, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “War Profiteering Pre-
3 vention Act of 2007”.

4 **SEC. 2. PROHIBITION OF PROFITEERING.**

5 (a) PROHIBITION.—

6 (1) IN GENERAL.—Chapter 47 of title 18,
7 United States Code, is amended by adding at the
8 end the following:

9 **“§ 1039. War profiteering and fraud relating to mili-
10 tary action, relief, and reconstruction ef-
11 forts**

12 **“(a) PROHIBITION.—**

13 **“(1) IN GENERAL.—**Whoever, in any matter in-
14 volving a contract or the provision of goods or serv-
15 ices, directly or indirectly, in connection with a war,
16 military action, or relief or reconstruction activities
17 within the jurisdiction of the United States Govern-
18 ment, knowingly and willfully—

19 **“(A)(i) executes or attempts to execute a**
20 **scheme or artifice to defraud the United States;**
21 **or**

22 **“(ii) materially overvalues any good or**
23 **service with the specific intent to defraud and**
24 **excessively profit from the war, military action,**
25 **or relief or reconstruction activities; ;**

1 shall be fined under paragraph (2), imprisoned
 2 not more than 20 years, or both; or

3 “(B)(i) falsifies, conceals, or covers up by
 4 any trick, scheme, or device a material fact;

5 “(ii) makes any materially false, fictitious,
 6 or fraudulent statements or representations; or

7 “(iii) makes or uses any materially false
 8 writing or document knowing the same to con-
 9 tain any materially false, fictitious or fraudu-
 10 lent statement or entry;

11 shall be fined under paragraph (2) imprisoned
 12 not more than 10 years, or both.

13 “(2) FINE.—A person convicted of an offense
 14 under paragraph (1) may be fined the greater of—

15 “(A) \$1,000,000; or

16 “(B) if such person derives profits or other
 17 proceeds from the offense, not more than twice
 18 the gross profits or other proceeds.

19 “(b) EXTRATERRITORIAL JURISDICTION.—There is
 20 extraterritorial Federal jurisdiction over an offense under
 21 this section.

22 “(c) VENUE.—A prosecution for an offense under
 23 this section may be brought—

24 “(1) as authorized by chapter 211 of this title;

1 “(2) in any district where any act in further-
 2 ance of the offense took place; or

3 “(3) in any district where any party to the con-
 4 tract or provider of goods or services is located.”.

5 (2) TABLE OF SECTIONS.—The table of sections
 6 for chapter 47 of title 18, United States Code, is
 7 amended by adding at the end the following:

“1039. War profiteering and fraud relating to military action, relief, and recon-
 struction efforts.”.

8 (b) CIVIL FORFEITURE.—Section 981(a)(1)(C) of
 9 title 18, United States Code, is amended by inserting
 10 “1039,” after “1032,”.

11 (c) CRIMINAL FORFEITURE.—Section 982(a)(2)(B)
 12 of title 18, United States Code, is amended by striking
 13 “or 1030” and inserting “1030, or 1039”.

14 ~~(d) RICO.—Section 1956(c)(7)(D) of title 18, United~~
 15 ~~States Code, is amended by inserting the following: “, see-~~
 16 ~~tion 1039 (relating to war profiteering and fraud relating~~
 17 ~~to military action, relief, and reconstruction efforts)” after~~
 18 ~~“liquidating agent of financial institution),”.~~

19 (d) MONEY LAUNDERING.—Section 1956(c)(7)(D) of
 20 title 18, United States Code, is amended by inserting after
 21 “liquidating agent of financial institution),” the following:
 22 “section 1039 (relating to war profiteering and fraud relat-
 23 ing to military action, relief, and reconstruction efforts),”.

1 *(e) RICO.—Section 1961(1) of title 18, United States*
2 *Code, is amended by inserting after “in connection with*
3 *access devices),” the following: “section 1039 (relating to*
4 *war profiteering and fraud relating to military action, re-*
5 *lief, and reconstruction efforts),”.*
