Mr. ALLARD introduced the following bill; which was read twice and referred
to the Committee on the Judiciary

A BILL

To end the trafficking of methamphetamines and precursor
chemicals across the United States and its borders.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Methamphetamine
5 Trafficking Enforcement Act of 2007”.

6 **SEC. 2. FINDINGS AND PURPOSE.**

7 Congress finds—

8 (1) legislation has been enacted to fight the do-
9 mestic production of methamphetamine;

1 (2) according to the Drug Enforcement Admin-
2 istration, between October 1, 2004 and January 11,
3 2005, there were 1,136 Federal offenders sentenced
4 for methamphetamine-related charges in United
5 States Courts and approximately 96 percent of these
6 methamphetamine cases involved a trafficking of-
7 fense;

8 (3) according to the Drug Enforcement Admin-
9 istration, as much as 80 percent of the methamphet-
10 amine used in the United States comes from abroad;
11 and

12 (4) the goal of the United States should be to
13 bolster efforts to stop the trafficking, manufac-
14 turing, and distributing of methamphetamine.

15 **SEC. 3. CONTROLLED SUBSTANCES ACT AMENDMENT.**

16 (a) IN GENERAL.—Section 408 of the Controlled
17 Substances Act (21 U.S.C. 848) is amended by inserting
18 after subsection (e) the following:

19 “(f) SPECIAL PROVISION FOR METHAMPHET-
20 AMINE.—For the purposes of subsection (b), in the case
21 of a continuing criminal enterprise involving methamphet-
22 amine or its salts, isomers, or salts of isomers, paragraph
23 (2)(A) shall be applied by substituting ‘100’ for ‘300’, and
24 paragraph (2)(B) shall be applied by substituting
25 ‘\$1,000,000’ for ‘\$10 million dollars.’.”.

1 (b) TECHNICAL AND CONFORMING AMENDMENTS.—
2 Section 408 of the Controlled Substances Act (21 U.S.C.
3 848) is amended by striking subsections (q) and (s).

4 **SEC. 4. COORDINATION OF ANTI-METHAMPHETAMINE AC-**
5 **TIVITIES WITH OTHER COUNTRIES.**

6 (a) MULTILATERAL AND BILATERAL NEGOTIA-
7 TIONS.—It is the sense of Congress that the United States
8 Trade Representative, the Secretary of State, the Attorney
9 General of the United States, and the Secretary of Home-
10 land Security should include ways to curb illicit use and
11 shipment of pseudoephedrine, ephedrine, and similar
12 chemicals in any multilateral or bilateral negotiations.

13 (b) EXCHANGES BETWEEN THE DRUG ENFORCE-
14 MENT ADMINISTRATION AND FOREIGN LAW ENFORCE-
15 MENT.—It is the sense of Congress that the Administrator
16 of the Drug Enforcement Administration should collabo-
17 rate with foreign law enforcement officials from countries
18 that are known traffickers of methamphetamine or its pre-
19 cursor chemicals into the United States and establish a
20 special investigative program to maximize education,
21 training, and information sharing with respect to inter-
22 national trafficking and use of methamphetamine.

1 **SEC. 5. REPORT TO CONGRESS ON METHAMPHETAMINE EF-**
2 **FORTS ON INDIAN RESERVATIONS.**

3 Not later than 180 days after the date of enactment
4 of this Act, the Attorney General shall submit a report
5 to Congress regarding problems faced by Indian reserva-
6 tions with respect to methamphetamine trafficking and
7 abuse, and recommendations regarding methods to ad-
8 dress any such problems.
