## A BILL

To revise and extend provisions under the Garrett Lee Smith Memorial Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Garrett Lee Smith Me-  
5 morial Act Reauthorization of 2007”.

6 **SEC. 2. AMENDMENTS TO THE PUBLIC HEALTH SERVICE**  
7 **ACT.**

8 (a) INTERAGENCY RESEARCH, TRAINING, AND TECH-  
9 NICAL ASSISTANCE CENTERS.—Section 520C of the Pub-

1 lic Health Service Act (42 U.S.C. 290bb–34) is amend-  
2 ed—

3 (1) in subsection (d)—

4 (A) in paragraph (1), by striking “youth  
5 suicide early intervention and prevention strate-  
6 gies” and inserting “suicide early intervention  
7 and prevention strategies for all ages, particu-  
8 larly for youth”;

9 (B) in paragraph (2), by striking “youth  
10 suicide early intervention and prevention strate-  
11 gies” and inserting “suicide early intervention  
12 and prevention strategies for all ages, particu-  
13 larly for youth”;

14 (C) in paragraph (3)—

15 (i) by striking “youth”; and

16 (ii) by inserting before the semicolon  
17 the following: “for all ages, particularly for  
18 youth”;

19 (D) in paragraph (4), by striking “youth  
20 suicide” and inserting “suicide for all ages, par-  
21 ticularly among youth”;

22 (E) in paragraph (5), by striking “youth  
23 suicide early intervention techniques and tech-  
24 nology” and inserting “suicide early interven-

1           tion techniques and technology for all ages, par-  
2           ticularly for youth”;

3           (F) in paragraph (7)—

4                 (i) by striking “youth”; and

5                 (ii) by inserting “for all ages, particu-  
6           larly for youth,” after “strategies”; and

7           (G) in paragraph (8)—

8                 (i) by striking “youth suicide” each  
9           place that such appears and inserting “sui-  
10          cide”; and

11                (ii) by striking “in youth” and insert-  
12          ing “among all ages, particularly among  
13          youth”; and

14          (2) in subsection (e)—

15                (A) in paragraph (1), by striking  
16          “\$4,000,000” and all that follows through the  
17          period and inserting “\$4,000,000 for fiscal year  
18          2008, and such sums as may be necessary for  
19          each of fiscal years 2009 through 2012.”; and

20                (B) in paragraph (2), by striking  
21          “\$3,000,000” and all that follows through the  
22          period and inserting “\$5,000,000 for each of  
23          fiscal years 2008 through 2012.”.

1 (b) YOUTH SUICIDE EARLY INTERVENTION AND  
2 PREVENTION STRATEGIES.—Section 520E of the Public  
3 Health Service Act (42 U.S.C. 290bb–36) is amended—

4 (1) in subsection (b), by striking paragraph (2)  
5 and inserting the following:

6 “(2) LIMITATION.—In carrying out this section,  
7 the Secretary shall ensure that a State does not re-  
8 ceive more than one grant or cooperative agreement  
9 under this section at any one time. For purposes of  
10 the preceding sentences, a State shall be considered  
11 to have received a grant or cooperative agreement if  
12 the eligible entity involved is the State or an entity  
13 designated by the State under paragraph (1)(B).  
14 Nothing in this paragraph shall be construed to  
15 apply to entities described in paragraph (1)(C).”;  
16 and

17 (2) by striking subsection (m) and inserting the  
18 following:

19 “(m) AUTHORIZATION OF APPROPRIATIONS.—For  
20 the purpose of carrying out this section, there are author-  
21 ized to be appropriated \$34,000,000 for fiscal year 2008,  
22 \$38,000,000 for fiscal year 2009, \$42,000,000 for fiscal  
23 year 2010, \$46,000,000 for fiscal year 2011, and  
24 \$50,000,000 for fiscal year 2012.”.

1           (c) MENTAL AND BEHAVIORAL HEALTH SERVICES  
2 ON CAMPUS.—Section 520E–2(h) of the Public Health  
3 Service Act (42 U.S.C. 290bb–36b(h)) is amended by  
4 striking “\$5,000,000 for fiscal year 2005” and all that  
5 follows through the period and inserting “\$5,400,000 for  
6 fiscal year 2008, \$5,800,000 for fiscal year 2009,  
7 \$6,200,000 for fiscal year 2010, \$6,600,000 for fiscal year  
8 2011, and \$7,000,000 for fiscal year 2012.”.
