## A BILL

To make technical corrections to SAFETEA–LU and other related laws relating to transit.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRANSIT TECHNICAL CORRECTIONS.**

4 (a) SECTION 5302.—Section 5302(a)(10) of title 49,  
5 United States Code, is amended by striking “charter,”  
6 and inserting “charter, sightseeing,”.

1 (b) SECTION 5303.—Section 5303 of title 49, United  
2 States Code, is amended—

3 (1) in subsection (j)(3)(D), by—

4 (A) inserting “or the identified phase” be-  
5 fore “within the time”; and

6 (B) inserting “or the identified phase” be-  
7 fore the period; and

8 (2) in subsection (k)(2), by striking “a metro-  
9 politan planning area serving”.

10 (c) SECTION 5307.—Section 5307(b) of title 49,  
11 United States Code, is amended—

12 (1) in paragraph (2)(A) by striking “mass  
13 transportation” and inserting “public transpor-  
14 tation”; and

15 (2) in paragraph (3) by striking “section  
16 5305(a)” and inserting “section 5303(k)”.

17 (d) SECTION 5309.—Section 5309(m) of title 49,  
18 United States Code, is amended—

19 (1) in the heading for paragraph (2)(A) by  
20 striking “MAJOR CAPITAL” and inserting “CAP-  
21 ITAL”; and

22 (2) in paragraph (7)(B) by striking “section  
23 3039” and inserting “section 3045”.

24 (e) SECTION 5311.—Section 5311 of title 49, United  
25 States Code, is amended—

1           (1) in subsection (g)(1)(A) by striking “for any  
2           purpose other than operating assistance” and insert-  
3           ing “for a capital project or project administrative  
4           expenses”;

5           (2) in subsections (g)(1)(A) and (g)(1)(B) by  
6           striking “capital” after “net”; and

7           (3) in subsection (i)(1) by striking “Sections  
8           5323(a)(1)(D) and 5333(b) of this title apply” and  
9           inserting “Section 5333(b) applies”.

10          (f) SECTION 5312.—The heading for section 5312(c)  
11          of title 49, United States Code, is amended by striking  
12          “MASS TRANSPORTATION” and inserting “PUBLIC  
13          TRANSPORTATION”.

14          (g) SECTION 5314.—Section 5314(a)(3) of title 49,  
15          United States Code, is amended by striking “section  
16          5323(a)(1)(D)” and inserting “section 5333(b)”.

17          (h) SECTION 5319.—Section 5319 of title 49, United  
18          States Code, is amended by striking “section 5307(k)”  
19          and inserting “section 5307(d)(1)(K)”.

20          (i) SECTION 5320.—Section 5320 of title 49, United  
21          States Code, is amended—

22                 (1) in subsection (a)—

23                         (A) by redesignating paragraphs (1)  
24                         through (3) as paragraphs (2) through (4), re-  
25                         spectively;

1 (B) by inserting after “(a) IN  
2 GENERAL.—” the following:

3 “(1) PROGRAM NAME.—The program author-  
4 ized by this section shall be known as the Paul S.  
5 Sarbanes Transit in Parks Program.”; and

6 (C) in paragraph (2)(A), as redesignated,  
7 by striking “intra-agency” and inserting  
8 “intraagency”;

9 (2) in subsection (b)(5)(A), by striking  
10 “5302(a)(1)(A)” and inserting “5302(a)(1)”;

11 (3) in subsection (d)(1), by inserting “to ad-  
12 minister this section and” after “5338(b)(2)(J)”;  
13 and

14 (4) in subsection (d), by adding at the end the  
15 following:

16 “(4) TRANSFERS TO LAND MANAGEMENT AGEN-  
17 CIES.—The Secretary may transfer amounts avail-  
18 able under paragraph (1) to the appropriate Federal  
19 land management agency to pay necessary costs of  
20 the agency for such activities described in paragraph  
21 (1) in connection with activities being carried out  
22 under this section.”.

23 (j) SECTION 5323.—Section 5323(n) of title 49,  
24 United States Code, is amended by striking “section  
25 5336(e)(2)” and inserting “section 5336(d)(2)”.

1 (k) SECTION 5325.—Section 5325(b) of title 49,  
2 United States Code, is amended—

3 (1) in paragraph (1), by inserting before the pe-  
4 riod at the end “adopted before August 10, 2005”;

5 (2) by striking paragraph (2); and

6 (3) by redesignating paragraph (3) as para-  
7 graph (2).

8 (l) SECTION 5336.—

9 (1) APPORTIONMENTS OF FORMULA GRANTS.—  
10 Section 5336 of title 49, United States Code, is  
11 amended—

12 (A) in subsection (a) by striking “Of the  
13 amount” and all that follows before paragraph  
14 (1) and inserting “Of the amount apportioned  
15 under subsection (i)(2) to carry out section  
16 5307—”;

17 (B) in subsection (d)(1) by striking “sub-  
18 sections (a) and (h)(2) of section 5338” and in-  
19 serting “subsections (a)(1)(C)(vi) and (b)(2)(B)  
20 of section 5338”; and

21 (C) by redesignating subsection (c), as  
22 added by section 3034(c) of Public Law 109–  
23 59 (119 Stat. 1628), as subsection (k).

24 (2) TECHNICAL AMENDMENTS.—Section  
25 3034(d)(2) of the Safe, Accountable, Flexible, Effi-

1       cient Transportation Equity Act: A Legacy for  
2       Users (119 Stat. 1629), is amended by striking  
3       “paragraph (2)” and inserting “subsection (a)(2)”.

4       (m) SECTION 5337.—Section 5337(a) of title 49,  
5       United States Code, is amended by striking “for each of  
6       fiscal years 1998 through 2003” and inserting “for each  
7       of fiscal years 2005 through 2009”.

8       (n) SECTION 5338.—Section 5338(d)(1)(B) of title  
9       49, United States Code, is amended by striking “section  
10      5315(a)(16)” and inserting “section 5315(b)(2)(P)”.

11      (o) SAFETEA-LU.—

12           (1) SECTION 3037.—Section 3037(c)(10) of the  
13      Safe, Accountable, Flexible, Efficient Transportation  
14      Equity Act: A Legacy for Users (119 Stat. 1636) is  
15      amended by striking “Middle Rio Grande Coalition  
16      of governments, Albuquerque to Santa Fe corridor  
17      study” and inserting “Mid-Region Council of Gov-  
18      ernments, New Mexico, public transportation buses,  
19      bus-related equipment and facilities, and intermodal  
20      terminals in Albuquerque and Santa Fe under the  
21      terms and conditions of section 5309 of title 49,  
22      United States Code.”.

23           (2) SECTION 3040.—Section 3040(4) of such  
24      Act (119 Stat. 1639) is amended by striking  
25      “\$7,871,895,000” and inserting “\$7,872,893,000”.

1 (3) SECTION 3043.—

2 (A) SAN DIEGO.—Section 3043(c)(105) of  
3 such Act (119 Stat. 1645) is amended by strik-  
4 ing “LOSSAN Del Mar-San Diego Rail—Cor-  
5 ridor Improvements” and inserting “LOSSAN  
6 Rail Corridor Improvements”.

7 (B) SAN DIEGO.—Section 3043(c)(217) of  
8 such Act (119 Stat. 1648) is amended by strik-  
9 ing “San Diego” and inserting “San Diego  
10 Transit”.

11 (C) LOS ANGELES.—

12 (i) PHASE 1.—Section 3043(b)(13) of  
13 such Act (119 Stat. 1642) is amended to  
14 read as follows:

15 “(13) Los Angeles—Exposition LRT (Phase  
16 1).”.

17 (ii) PHASE 2.—Section 3043(c) of  
18 such Act (119 Stat. 1645) is amended by  
19 inserting after paragraph (104) the fol-  
20 lowing:

21 “(104A) Los Angeles—Exposition LRT (Phase  
22 2).”.

23 (D) BOSTON.—Section 3043(d)(6) of such  
24 Act (119 Stat. 1649) is amended to read as fol-  
25 lows:

1           “(6) Boston-Silver Line Phase III,  
2           \$20,000,000.”.

3           (E) PROJECT CONSTRUCTION GRANTS.—

4           Section 3043(e) of such Act (119 Stat. 1651)  
5           is amended by adding at the end the following:

6           “(4) PROJECT CONSTRUCTION GRANTS.—

7           Projects recommended by the Secretary for a project  
8           construction grant agreement under section 5309(e)  
9           of title 49, United States Code, or for funding under  
10          section 5309(m)(2)(A)(i) of such title during fiscal  
11          year 2008 and fiscal year 2009 are authorized for  
12          preliminary engineering, final design, and construc-  
13          tion for fiscal years 2007 through 2009.”.

14          (4) SECTION 3044.—The table contained in sec-  
15          tion 3044(a) of such Act (119 Stat. 1652) is amend-  
16          ed—

17                 (A) in item number 487 by striking “Cen-  
18                 tral Arkansas Transit Authority Facility Up-  
19                 grades” and inserting “Central Arkansas Tran-  
20                 sit Authority Bus Acquisition”;

21                 (B) in item number 491 by amending the  
22                 item to read as follows: “PACE, IL, Cermak  
23                 Road, Bus Rapid Transit, and related bus  
24                 projects, and alternatives analysis”;

1 (C) in item number 512 by striking “Cor-  
2 ning, NY, Phase II Corning Preserve Transpor-  
3 tation Enhancement Project” and inserting  
4 “Transportation Center Enhancements, Cor-  
5 ning, NY”;

6 (D) in item number 534 by striking “Com-  
7 munity Buses” and inserting “Bus and Bus  
8 Facilities”;

9 (E) in item number 541 by striking  
10 “Intermodal Ferry Dock” and inserting  
11 “Gartina Highway Bus Stops”; and

12 (F) in item number 570 by striking  
13 “Maine Department of Transportation-Acadia  
14 Intermodal Facility” and inserting “MaineDOT  
15 Acadia Intermodal Passenger and Maintenance  
16 Facility”.

17 (5) SECTION 3046.—Section 3046(a)(7) of such  
18 Act (119 Stat. 1708) is amended—

19 (A) by striking “hydrogen fuel cell vehi-  
20 cles” and inserting “hydrogen fueled vehicles”;

21 (B) by striking “hydrogen fuel cell em-  
22 ployee shuttle vans” and inserting “hydrogen  
23 fueled employee shuttle vans”; and

1           (C) by striking “in Allentown, Pennsyl-  
2           vania” and inserting “to the DaVinci Center in  
3           Allentown, Pennsylvania”.

4           (6) SECTION 3050.—Section 3050(b) of such  
5           Act (119 Stat. 1713) is amended by inserting “by  
6           negotiating the extension of the existing agreement  
7           between mile post 191.13 and mile post 185.1 to  
8           mile post 165.9 in Rhode Island” before the period  
9           at the end.

10          (7) EXTENSIONS.—

11           (A) LOS ANGELES.—In evaluating the local  
12           share of the project authorized by section  
13           3043(c)(104A) of such Act, as added by this  
14           Act, in the rating process under section 5309 of  
15           title 49, United States Code, the Secretary of  
16           Transportation shall give consideration to  
17           project elements of the project authorized by  
18           section 3043(b)(13) of such Act advanced with  
19           100 percent non-Federal funds.

20           (B) SAN GABRIEL VALLEY.—In evaluating  
21           the local share of Phase II of the project au-  
22           thorized by section 3043(b)(33) of such Act  
23           (119 Stat. 1642) in the rating process under  
24           section 5309 of title 49, United States Code,  
25           the Secretary of Transportation shall give con-

1           sideration to project elements of Phase I of  
2           such project advanced with 100 percent non-  
3           Federal funds.

4           (p) TEA-21.—Section 3012(c)(1) of the Transpor-  
5   tation Equity Act for the 21st Century (112 Stat. 358)  
6   is amended by striking “to be used only for the completion  
7   of the program to develop and deploy a new Advanced Pro-  
8   pulsion Control System begun under the Request for  
9   Technical Proposals for Project S-2814-2” and inserting  
10 “to develop and deploy new technology for the Silverliner  
11 IV Regional Rail Cars, including a Propulsion Control  
12 System, Trainline Door Control Relay Panel, HVAC Con-  
13 trol Upgrade, Blending Valve, and related improvements”.
