 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as "The VA Vision Scholars
 - 5 Act of 2007".

4	(a) Establishment of Program.—Part V of title
5	38, United States Code, is amended by adding at the end
6	the following new chapter:
7	"CHAPTER 80—VISUAL IMPAIRMENT AND
8	ORIENTATION AND MOBILITY PROFES-
9	SIONALS EDUCATION ASSISTANCE

	"Sec. "8001. Establishment of scholarship program; purpose. "8002. Application and acceptance. "8003. Amount of assistance; duration. "8004. Agreement. "8005. Repayment for failure to satisfy requirements of agreement.
11	"§ 8001. Establishment of scholarship program; pur-
12	pose
13	"(a) Establishment.—Subject to the availability of
14	appropriations, the Secretary shall establish and carry out
15	a scholarship program to provide financial assistance in
16	accordance with this chapter to an individual—
17	"(1) who is accepted for enrollment or currently
18	enrolled in a program of study leading to a degree
19	or certificate in visual impairment or orientation and
20	mobility, or a dual degree or certification in both
21	such areas, at an accredited (as determined by the

- 1 Secretary) educational institution that is in a State;
- 2 and
- 3 "(2) who enters into an agreement with the
- 4 Secretary as described in section 8004 of this title.
- 5 "(b) Purpose.—The purpose of the scholarship pro-
- 6 gram established under this chapter is to increase the sup-
- 7 ply of qualified blind rehabilitation specialists for the De-
- 8 partment and the Nation.
- 9 "(c) Outreach.—The Secretary shall publicize the
- 10 scholarship program established under this chapter to edu-
- 11 cational institutions throughout the United States, with
- 12 an emphasis on disseminating information to such institu-
- 13 tions with high numbers of Hispanic students and to His-
- 14 torically Black Colleges and Universities.

15 "§ 8002. Application and acceptance

- 16 "(a) APPLICATION.—(1) To apply and participate in
- 17 the scholarship program under this chapter, an individual
- 18 shall submit to the Secretary an application for such par-
- 19 ticipation together with an agreement described in section
- 20 8004 of this title under which the participant agrees to
- 21 serve a period of obligated service in the Department as
- 22 provided in the agreement in return for payment of edu-
- 23 cational assistance as provided in the agreement.
- 24 "(2) In distributing application forms and agreement
- 25 forms to individuals desiring to participate in the scholar-

- 1 ship program, the Secretary shall include with such forms
- 2 the following:
- 3 "(A) A fair summary of the rights and liabil-
- 4 ities of an individual whose application is approved
- 5 (and whose agreement is accepted) by the Secretary.
- 6 "(B) A full description of the terms and condi-
- 7 tions that apply to participation in the scholarship
- 8 program and service in the Department.
- 9 "(b) APPROVAL.—(1) Upon the Secretary's approval
- 10 of an individual's participation in the scholarship program,
- 11 the Secretary shall, in writing, promptly notify the indi-
- 12 vidual of that acceptance.
- 13 "(2) An individual becomes a participant in the schol-
- 14 arship program upon such approval by the Secretary.

15 "§ 8003. Amount of assistance; duration

- 16 "(a) Amount of Assistance.—The amount of the
- 17 financial assistance provided for an individual under this
- 18 chapter shall be the amount determined by the Secretary
- 19 as being necessary to pay the tuition and fees of the indi-
- 20 vidual. In the case of an individual enrolled in a program
- 21 of study leading to a dual degree or certification in both
- 22 the areas of study described in section 8001(a)(1) of this
- 23 title, the tuition and fees shall not exceed the amounts
- 24 necessary for the minimum number of credit hours to
- 25 achieve such dual certification or degree.

- 1 "(b) Relationship to Other Assistance.—Fi-
- 2 nancial assistance may be provided to an individual under
- 3 this chapter to supplement other educational assistance to
- 4 the extent that the total amount of educational assistance
- 5 received by the individual during an academic year does
- 6 not exceed the total tuition and fees for such academic
- 7 year.
- 8 "(c) Maximum Amount of Assistance.—(1) In no
- 9 case may the total amount of assistance provided under
- 10 this chapter for an academic year to an individual who
- 11 is a full-time student exceed \$15,000.
- 12 "(2) In the case of an individual who is a part-time
- 13 student, the total amount of assistance provided under
- 14 this chapter shall bear the same ratio to the amount that
- 15 would be paid under paragraph (1) if the participant were
- 16 a full-time student in the program of study being pursued
- 17 by the individual as the coursework carried by the indi-
- 18 vidual to full-time coursework in that program of study.
- 19 "(3) In no case may the total amount of assistance
- 20 provided to an individual under this chapter exceed
- 21 \$45,000.
- 22 "(d) Maximum Duration of Assistance.—The
- 23 Secretary may provide financial assistance to an individual
- 24 under this chapter for not more than six years.

"§ 8004. Agreement

2	"An agreement between the Secretary and a partici-
3	pant in the scholarship program under this chapter shall
4	be in writing, shall be signed by the participant, and shall
5	include the following:
6	"(1) The Secretary's agreement to provide the
7	participant with financial assistance as authorized
8	under this chapter.
9	"(2) The participant's agreement—
10	"(A) to accept such financial assistance;
11	"(B) to maintain enrollment and attend-
12	ance in the program of study described in sec-
13	tion 8001(a)(1) of this chapter;
14	"(C) while enrolled in such program, to
15	maintain an acceptable level of academic stand-
16	ing (as determined by the educational institu-
17	tion offering such program under regulations
18	prescribed by the Secretary); and
19	"(D) after completion of the program, to
20	serve as a full-time employee in the Department
21	for a period of three years, to be served within
22	the first six years after the participant has com-
23	pleted such program and received a degree or
24	certificate described in section 8001(a)(1) of
25	this chapter.

- 1 "(3) Such other terms and conditions that the
- 2 Secretary determines appropriate for carrying out
- 3 this chapter.
- 4 "§ 8005. Repayment for failure to satisfy require-
- 5 ments of agreement
- 6 "(a) IN GENERAL.—An individual who receives edu-
- 7 cational assistance under this chapter shall repay to the
- 8 Secretary an amount equal to the unearned portion of
- 9 such assistance if the individual fails to satisfy the require-
- 10 ments of the agreement entered into under section 8004
- 11 of this title, except in circumstances authorized by the
- 12 Secretary.
- 13 "(b) Amount of Repayment.—The Secretary shall
- 14 establish, by regulations, procedures for determining the
- 15 amount of the repayment required under this section and
- 16 the circumstances under which an exception to the re-
- 17 quired repayment may be granted.
- 18 "(c) Waiver or Suspension of Compliance.—
- 19 The Secretary shall prescribe regulations providing for the
- 20 waiver or suspension of any obligation of an individual for
- 21 service or payment under this chapter (or an agreement
- 22 under this chapter) whenever noncompliance by the indi-
- 23 vidual is due to circumstances beyond the control of the
- 24 individual or whenever the Secretary determines that the

- 1 waiver or suspension of compliance is in the best interest
- 2 of the United States.
- 3 "(d) Obligation as Debt to United States.—
- 4 An obligation to repay the Secretary under this section
- 5 is, for all purposes, a debt owed the United States. A dis-
- 6 charge in bankruptcy under title 11 does not discharge
- 7 a person from such debt if the discharge order is entered
- 8 less than five years after the date of the termination of
- 9 the agreement or contract on which the debt is based.".
- 10 (b) CLERICAL AMENDMENTS.—The tables of chap-
- 11 ters at the beginning of title 38, and of part V of title
- 12 38, are each amended by inserting after the item relating
- 13 to chapter 79 the following new item:
- 14 (c) Effective Date.—The Secretary of Veterans
- 15 Affairs shall implement chapter 80 of title 38, United
- 16 States Code, as added by subsection (a), not later than
- 17 six months after the date of the enactment of this Act.
