Mrs. BOXER (for herself, Mr. LAUTENBERG, and Mr. KERRY) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To provide for prostate cancer imaging research and education.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Prostate Research, Im-
5 aging, and Men’s Education Act” or the “PRIME Act”.

6 SEC. 2. FINDINGS.

7 Congress makes the following findings:

8 (1) Prostate cancer has reached epidemic pro-
9 portions, particularly among African-American men,
10 and strikes and kills men in numbers comparable to

1 the number of women who lose their lives from
2 breast cancer.

3 (2) Life-saving breakthroughs in screening, di-
4 agnosis, and treatment of breast cancer resulted
5 from the development of advanced imaging tech-
6 nologies led by the Federal Government.

7 (3) Men should have accurate and affordable
8 prostate cancer screening exams and minimally-
9 invasive treatment tools, similar to what women have
10 for breast cancer.

11 (4) While it is important for men to take ad-
12 vantage of current prostate cancer screening tech-
13 niques, a recent NCI-funded study demonstrated
14 that the most common available methods of detect-
15 ing prostate cancer (PSA blood test and physical
16 exams) are not foolproof, causing numerous false
17 alarms and false reassurances.

18 (5) The absence of advanced imaging tech-
19 nologies for prostate cancer causes the lack of accu-
20 rate information critical for clinical decisions, result-
21 ing in missed cancers and lost lives, as well as un-
22 necessary and costly medical procedures, with re-
23 lated complications.

24 (6) With prostate imaging tools, men and their
25 families would face less physical, psychological, fi-

1 nancial and emotional trauma and billions of dollars
2 could be saved in private and public health care sys-
3 tems.

4 **SEC. 3. RESEARCH AND DEVELOPMENT OF PROSTATE CAN-
5 CER IMAGING TECHNOLOGIES.**

6 (a) EXPANSION OF RESEARCH.—The Secretary of
7 Health and Human Services (referred to in this Act as
8 the “Secretary”), acting through the Director of the Na-
9 tional Institutes of Health and in consultation with the
10 Secretary of Defense, shall carry out a program to expand
11 and intensify research to develop innovative advanced im-
12 aging technologies for prostate cancer detection, diagnosis,
13 and treatment comparable to state-of-the-art mammog-
14 raphy technologies.

15 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
16 authorized to be appropriated to carry out this section,
17 \$100,000,000 for each of fiscal years 2008 through 2012.

18 **SEC. 4. PUBLIC AWARENESS AND EDUCATION CAMPAIGN.**

19 (a) NATIONAL CAMPAIGN.—The Secretary shall carry
20 out a national campaign to increase the awareness and
21 knowledge of Americans with respect to the need for pros-
22 tate cancer screening and for improved detection tech-
23 nologies.

24 (b) REQUIREMENTS.—The national campaign con-
25 ducted under subsection (a) shall include—

1 (1) roles for the Health Resources Services Ad-
2 ministration, the Office on Minority Health of the
3 Department of Health and Human Services, the
4 Centers for Disease Control and Prevention, and the
5 Office of Minority Health of the Centers for Disease
6 Control and Prevention; and

14 (c) RACIAL DISPARITIES.—In developing the national
15 campaign under subsection (a), the Secretary shall recog-
16 nize and address the racial disparities in the incidences
17 of prostate cancer and mortality rates with respect to such
18 disease.

19 (d) GRANTS.—The Secretary shall establish a pro-
20 gram to award grants to nonprofit private entities to en-
21 able such entities to test alternative outreach and edu-
22 cation strategies to increase the awareness and knowledge
23 of Americans with respect to the need for prostate cancer
24 screening and improved imaging technologies.

1 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
2 authorized to be appropriated to carry out this section,
3 \$10,000,000 for each of fiscal years 2008 through 2012.

4 **SEC. 5. IMPROVING PROSTATE CANCER SCREENING BLOOD**
5 **TESTS.**

6 (a) IN GENERAL.—The Secretary, in coordination
7 with the Secretary of Defense, shall carry out research to
8 develop an improved prostate cancer screening blood test
9 using in-vitro detection.

10 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
11 authorized to be appropriated to carry out this section,
12 \$20,000,000 for each of fiscal years 2008 through 2012.

13 **SEC. 6. REPORTING AND COMPLIANCE.**

14 (a) REPORT AND STRATEGY.—Not later than 6
15 months after the date of enactment of this Act, the Sec-
16 retary shall submit to Congress a report that details the
17 strategy of the Secretary for implementing the require-
18 ments of this Act and the status of such efforts.

19 (b) FULL COMPLIANCE.—Not later than 1 year after
20 the date of enactment of this Act, and annually thereafter,
21 the Secretary shall submit to Congress a report that—
22 (1) contains assurances that the provisions of
23 this Act are fully implemented; and
